**SUMMARY:** Florida Speaks is a political committee (PC) registered with the State of Florida. The PC's chair is Randall Myers and its treasurer is Jamie C. Jodoin.

The PC is appealing the fine due to unusual circumstances related to the abrupt and unexpected resignation of the campaign treasurer. According to Jamie Jodoin, on October 23, 2018, Mr. Thomas M. Kiernan, treasurer for Florida Speaks, resigned effective immediately. Upon his untimely resignation, two weeks before elections, the committee was forced to fill the vacant position immediately. She states that once she received the records from the prior treasurer on October 30<sup>th</sup>, it was evident that a considerable amount of reports prior to October 23<sup>rd</sup> would have to be amended.

Ms. Jodoin notes that the P1A report was initially filed by the original treasurer as a waiver on 07/02/18, however, after review of records and bank statements, there was one contribution and one expenditure that should have been reported. She amended the report to reflect that activity.

- The 2018 P1A Original Report covers the period from 06/23/18-06/29/18; it was due on 07/06/18.
- The 2018 P1A Queued Transaction Report shows that it was created and filed on 07/06/18.<sup>1</sup>
- Florida Speaks reported receiving 1 contribution, while making 1 expenditure.
- FEC staff was advised, "The committee filed a notice of no activity (waiver) on 07/06/18. A waiver is not a report. On 10/30/18, the committee filed a report showing \$10,000.00 of activity. The fine is based on 25% of the activity.
- The Division of Elections has one note that pertains to Florida Speaks' 2018 P1A report. Credentials were released to Ms. Jodoin on 10/25/18.

The Florida Elections Commission received a letter from Jamie C. Jodoin, Treasurer, appealing the fine assessed against your committee for failing to timely file a required report. However, Section 106.07(8)(c), Florida Statutes, provide that only a candidate or the chairman of a political committee, may appeal a fine assessed by a filing officer for the late filing of a campaign treasurer's report.

Therefore, to preserve your right to appeal the fine, the Commission must receive a written statement signed by you indicating that the person signing the letter was representing you when the appeal was filed.

If we do not hear from you within 14 days from the date of this letter, we will assume that the person signing the letter is neither your attorney nor your personal representative and that you have waived your right to appeal. The Commission will then enter a Default Final Order, ordering you to pay the fine assessed by your filing officer for failing to timely file your campaign treasurer's report.

We received a notice assessing a late filing fee on the treasurer's report that was due on July 6, 2018 for the above referenced political committee. As such, we are filing this letter of appeal requesting an abatement of this late filing fee due to unusual circumstances related to the abrupt and unexpected resignation of the campaign treasurer.

On October 23, 2018, Thomas M. Kiernan, Treasurer for Florida Speaks, resigned effective immediately. Upon his untimely resignation, two weeks before the election, the committee was forced to fill this vacant position immediately. They contacted my office and we promptly filed all necessary forms with the Florida Division of Elections, including a letter from the prior treasurer disclosing his resignation. A copy of this letter has been included for your review. Once I received the records from the prior treasurer on October 30<sup>th</sup>, it was evident that a considerable number of reports filed prior to October 23, 2018 would need to be amended. As such, I began amending those incorrectly filed reports to properly reflect the activity that occurred during those periods.

In the case of the P1A report that was due on July 6, 2018, the prior treasurer had initially filed a waiver. However, after a thorough review of the records and bank statements, there was a single contribution and a single expenditure that had occurred during the coverage period. Therefore, an amended report was filed to disclose this information accurately. A copy of the amended P1A report has been included for your review.

Due to the extenuating circumstances mentioned above, as well as the integrity of the information filed with the Division of Elections, I am requesting an abatement of the late filing fee on the P1A campaign finance report that was due on July 6, 2018.





### Pin Numbers

Pin numbers are confidential secure credentials that allow you to submit reports and update information. The enclosed sealed envelope provides a confidential pin number for the chairperson. By copy of this letter, a confidential pin number to access the EFS was sent to the treasurer.

Each political committee chairperson is required to provide the Division of Elections with confidential personal information that may be used to allow access in the event that the password is forgotten or lost. When you enter the campaign account screen, there will be a drop down box where you pick a question (such as *What is your mother's maiden name?*) and supply an answer. All passwords and answers to questions are stored as encrypted data and cannot be viewed by Division staff and given out over the phone. Please notify the Division if your credentials have been compromised.

## **Timely Filing**

All reports must be completed and filed through the EFS no later than midnight, Eastern Standard Time, of the due date. Reports not filed by midnight of the due date are late filed and subject to the penalties in Section 106.07(8), Florida Statutes. In the event that the EFS is inoperable on the due date, the report will be accepted as timely filed if filed no later than midnight, Eastern Standard Time, of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any political committee failing to file a report on the designated due date is subject to a fine of \$50 per day for the first 3 days and, thereafter, \$500 per day for each day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding each primary and general election, the fine shall be \$500 per day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

### **Electronic Receipts**

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the chairperson and campaign treasurer and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.
