NOTICE OF HEARING (AUTOMATIC FINE)

A hearing will be held in this case before the Florida Elections Commission on, **May 14, 2019 at 8:30 am**, *or as soon thereafter as the parties can be heard*, at the following location: **Senate Office Building, 404 South Monroe Street, Room 110-S, Tallahassee, Florida 32399**. Due to heightened security access requirements, please bring only essential items into the building and plan to arrive early to allow for delays coming through security.

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

If you are the Respondent, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

SUMMARY: Largo/Mid-Pinellas Progressive PC is a political committee (PC) registered with the State of Florida. The PC's chair is Mary Louise Ambrose and its treasurer is Charles William Tucker.

The PC is appealing the fine claiming that they made every effort while their treasurer was hospitalized to meet all the reporting dates. According to Wanda Schwerer, the Deputy Treasurer, they filed reports on or before the due dates. She states that it was due to his absence that they had to amend the reports, as access to the bank statements and Post Office Box was impacted. Regarding the 2018 D1 report, Ms. Schwerer states that the report was filed one day late and amended on 10/31/18.

- The 2018 D1 Original Report covers the period from 10/20/18-10/26/18; it was due on 10/27/18.
- The 2018 D1 Queued Transaction Report shows that it was created and filed on 10/28/18.¹
- Largo/Mid-Pinellas Progressive PC reported receiving 1 contribution, while making zero expenditures.
- FEC staff was advised, "The candidate filed a notice of no activity (waiver) on 10/28/18. A waiver is not a report. On 10/31/18, the candidate filed a report showing \$35.00 of activity. The fine is based on 25% of the activity.
- The Division of Elections does not have any notes that pertain to Largo/Mid-Pinellas Progressive PC's 2018 D1 report.

PRIOR CASES: None.


The President of our Political Committee referred three letters, from Ms. Kristi Reid Willis, of December 10 to me, since I file all of the reports.

I have reviewed the filing records on-line, and want to point out that of the three reports you showed as having been filed late, two were, in fact, filed early or on the due date; those being the reports due on 9/21/2018 and 10/5/2018. All three of the LATE FILING dates you reference are AMENDED dates, and I was not aware that amending a report counted it as being LATE. Please see the screen captures below.

Please let me know if this is incorrect. We made every effort while our Treasurer was hospitalized in Washington, D. C., this past fall to meet all of the reporting dates. It was due to his absence that we had to amend the reports, as access to the bank statements and Post Office box was impacted.

The report due on 10/27/2018 was filed on 10/28/2018, just one day late, not on 10/31 (which is the amended date) as your letter stated. Unless you are fining us for filing amended reports, I believe we have only the one fine due – and that is a single date.
