**SUMMARY:** Orange County Fund for Children and Public Education is a political committee (PC) registered with the State of Florida. The PC's chair is Deborah Carswell and its treasurer is Joshua A. Katz.

The PC is appealing the fine claiming that the treasurer had issues using a mobile device to file the report. According to Deborah Carswell, the treasurer was out of town for the funeral of his wife's grandmother and was unable to file because the interface from his mobile device would not accept zip codes in the report field for Expenditures. She states that he had to wait until he returned home to file the report from his laptop.

- The 2018 G7 Original Report covers the period from 10/20/18-11/01/18; it was due on 11/02/18.
- The 2018 G7 Queued Transaction Report shows that it was created and filed on 11/03/18.
- Orange County Fund for Children and Public Education reported receiving zero contributions, while making 2 expenditures.
- The Division of Elections does not have any notes that pertain to Orange County Fund for Children and Public Education's 2018 G7 report.

The Orange County Fund for Children and Public Education would like to appeal the late fine for the G7 report due on 11/02/2018.

The grounds for the appeal is the reporting interface on mobile devices. The FCPE Treasurer, Joshua Katz, made an attempt to file the G7 report by the due date, but found the interface from his mobile device does not accept the zip code in the reporting field for Expenditures. All other fields required for filing Expenditures accepted data except for the zip code field. The Treasurer was forced to attempt filing on his mobile device as he was out of town for the funeral of his wife's grandmother. When he discovered he could not file from his device, he had to wait until returning home to file from a laptop computer, where the field for zip code could accept the data.

As you review our past filing records it is evident that the FCPE has been extremely diligent with timely and accurate filing. I hope this appeal will be satisfactory. Please let me know if we can provide any further information to assist in your decision.

Dear Ms. Carswell:

Our records indicate that you have not filed either your campaign treasurer's report or notification that no reportable activity occurred, whichever is applicable. The filing date was November 2, 2018.

The law (s. 106.07(8)(b), Fla. Stat.) requires the filing officer to immediately notify you about the missed filing date and the automatic fines that will be assessed for late filing of a report, if a report was due.

- If reportable activity occurred and you have not filed a report, statutory fines are automatically assessed as follows until you file your report:
  - \$50 per day for the first 3 days late
  - \$500 per day for each day after the 3rd day late
  - If the required report immediately precedes a primary and general election, the automatic fine is \$500 for each late day.

The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period. Even if you end up filing your report late, we cannot waive the statutory fines. We will notify you of the specific amount of fines owed once you file your report. You have 20 days from the day you receive the notice to pay the fine or to appeal the fine to the Florida Elections Commission.

• If no reportable activity occurred for the report date(s), you are still required to notify us in writing, via the Division's Electronic Filing System, that no reportable activity occurred. No automatic fines are statutorily assessed.

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.

#### Pin Numbers

Pin numbers are confidential secure credentials that allow you to submit reports and update information. The enclosed sealed envelope provides a confidential pin number for the chairperson. By copy of this letter, a confidential pin number to access the EFS was sent to the treasurer.

Each political committee chairperson is required to provide the Division of Elections with confidential personal information that may be used to allow access in the event that the password is forgotten or lost. When you enter the campaign account screen, there will be a drop down box where you pick a question (such as *What is your mother's maiden name?*) and supply an answer. All passwords and answers to questions are stored as encrypted data and cannot be viewed by Division staff and given out over the phone. Please notify the Division if your credentials have been compromised.

#### **Timely Filing**

All reports must be completed and filed through the EFS no later than midnight, Eastern Standard Time, of the due date. Reports not filed by midnight of the due date are late filed and subject to the penalties in Section 106.07(8), Florida Statutes. In the event that the EFS is inoperable on the due date, the report will be accepted as timely filed if filed no later than midnight, Eastern Standard Time, of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any political committee failing to file a report on the designated due date is subject to a fine of \$50 per day for the first 3 days and, thereafter, \$500 per day for each day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding each primary and general election, the fine shall be \$500 per day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

#### Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the chairperson and campaign treasurer and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.
