A hearing will be held in this case before the Florida Elections Commission on, May 14, 2019 at 8:30 am, *or as soon thereafter as the parties can be heard*, at the following location: Senate Office Building, 404 South Monroe Street, Room 110-S, Tallahassee, Florida 32399. Due to heightened security access requirements, please bring only essential items into the building and plan to arrive early to allow for delays coming through security.

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

If you are the Respondent, you may attend the hearing, and you or your attorney will have 5 minutes to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have 5 *minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing*. The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

SUMMARY: Alachua County Democratic Executive Committee is a political executive committee registered with the Alachua County Supervisor of Elections. The PC's chair is Cynthia Moore Chestnut and its treasurer was Chanae Baker.

The Committee is appealing the fine, claiming several circumstances. According to Cynthia Moore Chestnut, the treasurer was hospitalized from 10/9/18-10/11/18 and placed on bed rest from 10/11/18-1/4/19 for a serious medical condition. Ms. Moore Chestnut also states that she did not receive notice regarding the late report from the treasurer or the filing officer. She notes that the Treasurer was not in contact with the Chair due to the Treasurer's illness, and the Chair did not have access to passwords or filing information, preventing the filing of the report by a person other than the Treasurer.

Ms. Moore Chestnut also states that the report was due the Friday before the General Election and that they were deeply involved in candidate campaigns and later involved in the recount. They request a waiver of the fine due to these circumstances. Medical documentation for the treasurer's illness has been provided.

- The 2018 G7 Original Report covers the period from 08/24/18-11/01/18; it was due on 11/02/18.
- The 2018 G7 Original Report shows that it was filed on 12/05/18.
- Alachua County Democratic Executive Committee reported receiving 6 contributions, while making 8 expenditures.
- The Alachua County Supervisor of Elections office sent emails and a note to FEC staff regarding Alachua County Democratic Executive Committee's 2018 G7 report. A resignation letter from the treasurer was included in the documents from the SOE's office.

Dear Ms. Wims,

On behalf of the Alachua County Democratic Party Executive Committee I am submitting for your consideration an appeal to the fine issued on January 14th 2019. Based on your January 23, letter we are forced with no other decision but to accept your decision and appeal based on unusual circumstances. I am appealing on the grounds of unusual circumstances as outlined in 2B-1.0055 referenced in the original letter and the Supervisor of Elections failure to notify the Chair of the late report per the Florida Elections Commission Statutes Fla.Stat.106.29.3B. For your convenience in traversing the dates and circumstances mentioned throughout this letter, I have also included a brief timeline of events following the details of our appeal.

<u>2B-1.005, Referenced in the Florida Election Commission Letter</u> <u>dated Jan. 23, 2019</u>

2B-1.0055 (c):

We believe that the Treasurer's hospitalization from 10/9/18 to 10/11/18 and bed rest from 10/11/18 to 1/4/19 constitutes a "serious illness, disability or nonelective surgery of the candidate or campaign treasurer" that prevented the timely filing of the report as outlined in 2B-1.0055(c). Please see the attached letter from Dr. Kwo Wei David Ho and UF Health Physicians for the mentioned necessary evidence of the nature of the medical intervention and the associated dates.

2B-1.0055 (g)

The Chair was not notified by the Treasurer that the report was late within the first 7-day period of the report being late as outlined in 2B-1.0055(g) which prevented the Chair from being able to file the report within a timely enough manner to avoid further financial penalties.

We also think it is worth noting that the Florida Elections Commission Statutes and Rules specifies that "Upon determining that a report is late, the filing officer shall immediately notify the chair of the executive committee or the leader of the affiliated party committee as defined in FLa.Stat. 103.092 as to the failure to file a report by the designated due date and that a fine is being assessed for each late day". Unfortunately, the Supervisor of Elections did not notify the Chair that the report had not been filed. Had the Chair been notified in a timely manner, the report would have been filed closer to the deadline in order to avoid further financial penalties.

<u> Timeline of Events:</u>

- 11/2/2018: Report originally due
- 12/20/2018: Report submitted online
- 1/9/2019: Chair of ACDEC contacted the Supervisor of Elections which was the first time the SOE Office had contact with the Chair regarding the late filing of the report

1/14/2019: First notification regarding the late filing of report from the SOE Office

In closing, we think it is worth noting that the Treasurer was not in contact with the Chair due to the Treasurer's illness and that the Chair did not have access to the passwords or filing information, preventing the filing of the report by a person other than the Treasurer. Further, we also find it important to note that in the 100 years of the Alachua County Democratic Party's existence, records have always been filed in a timely manner. Finally, given the highly unusual nature of the 2018 election with the recount, we ask for your utmost consideration regarding this appeal. Based on the foregoing reasons we respectfully request a waiver of the fine.

This letter is to certify that Chanae Baker has been hospitalized from 10/9/18-10/11/18. She was diagnosed with idiopathic intracranial hypertension (or pseudotumor cerebri) and is undergoing continuous medical treatment. With this condition, she has severe headaches, blurry vision and blindness caused by excessive swelling of the optic nerve discs, significant fatigue that can be worsened with a cognitive load. Ms. Baker was on strict bed rest and driving restrictions and recommended to focus on medical interventions to improve symptoms and medical prognosis. We appreciate allowing her time to heal and a slow return to regular activities based on her symptom improvement. On 1/4/19, Ms. Baker was cleared to return to work with a reduced work schedule until she completely recovers.

Per F.S. 106.29(1), "The state executive committee and each county executive committee of each political party and affiliated party committee regulated by chapter 103 shall file regular reports of all contributions received and all expenditures made by such committee. However, the reports shall not include contributions and expenditures that are reported to the Federal Election Commission. In addition, when a special election is called to fill a vacancy in office, each state executive committee, and each county executive committee making contributions or expenditures to influence the results of the special election or the preceding special primary election must file campaign treasurers' reports on the dates set by the Department of State pursuant to s. 100.111 Such reports shall contain the same information as do reports required of candidates by s. 106.07 and shall be filed on the 10th day following the end of each calendar quarter, except that, during the period from the last day for candidate qualifying until the general election. In addition to the reports filed under this section, the state executive committee, each county executive committee, and each affiliated party committee shall file a copy of each prior written acceptance of an in-kind contribution given by the committee during the preceding calendar quarter as required under s. 106.08(6). Each state executive committee and affiliated party committee shall file its reports with the Division of Elections. Each county executive committee shall file its reports with the supervisor of elections in the county in which such committee exists. Any state or county executive committee or affiliated party committee failing to file a report on the designated due date shall be subject to a fine as provided in subsection (3). No separate fine shall be assessed for failure to file a copy of any report required by this section".

Political Party Executive Committee Reporting

Per F.S. 106.0702(1), "An individual seeking a publicly elected position on a political party executive committee who receives a contribution or makes an expenditure shall file a report of all contributions received and all expenditures made. The report shall be filed on the 4th day immediately preceding the primary election".

ALACHUA COUNTY DEMOCRATIC EXECUTIVE COMMITTEE January, 2018 General Membership Meeting

Chair Cynthia Moore Chestnut convened the meeting at 7:00 PM, Wednesday, 10 January 2018 in the Hall of Heroes, GPD, Gainesville, Florida.

Chair Chestnut led members in the Pledge to the Flag followed by a moment of silence.

State Committeeman Robert Mounts asked about presenting a report calling for sanctions on a member. He suggested that any action was out of order since no committee procedures had been approved. No action was taken. Discussion followed on the procedure for considering the Grievance Committee report and possible sanctions. There followed a <u>motion</u> that the vote on sanctions be taken by paper ballot rather than by roll call, seconded, and after discussion and passage of the previous question, carried.

Agenda: A motion was made to adopt the agenda, seconded, and carried.

<u>Minutes</u>: A <u>motion</u> was made to approve the minutes of the November, 2017 meeting, seconded and carried. (There was no December meeting.)

Chair Chestnut appointed Linda Bassham and Terry Fleming to be sergeants-at-arms.

Chair's Report: Chair Chestnut reported that "Erry Rizzo, Palm Beach County DEC Chair was elected Chair of the FDP. The State Committee is gearing up for a special election ion Sarasota County.

Introduction of Guests: Chair Chestnut introduced the following guests: Scott Austin, Oakleigh Barber, Rachel Bhattachartta, Sanita Brown, Doug Bernal, Catherine Goggan, Jonathan Coran, Rick Eddie, Kayser Enneking, Kristina Fields, Claudia Frese, Don Glendenin, Joey Grossman, Armondo Grundy, Bob Hallman, Rayjohn Odum, Alex Pizzaro, Liz Quenby, Tamara Robbins, Carmen Sanchez, Gigi Simmons, Mark Soroke, and Ray Washington, Esq.

<u>Membership Committee</u>: Co-chair Doris Harvey presented the following persons for DEC membership: Marilyn Eisenberg (Pct 45), Francesca Kayser Enneking (Pct 50), Charlotte Hill (Pct 56), Amol Jethwani (Pct 5), Carmen Sanchez (Pct 31), and Kristen Thompson (Pct 42). The Chair has agreed to appoint Tina Fields (Pct 61AL) and Gwendolyn Thompson (Pct 62AL) There followed a <u>motion</u> to accept these applicants as DEC members with all rights and privileges thereunto appertaining, seconded, and carried.

ELECTION OF OFFICERS: Chair Chestnut explained the procedure for the election of officers. The election produced the following results:

State Committeewoman: Marcie Stefan de Alvarado (Pct 57) was elected by acclimation. <u>Vice-Chair</u>: Seth Smith (Pct 30) withdrew from the race for Vice-Chair, and in the election, James Thompson (Pct 48) received 57 votes and Casey Willits (Pct 7) received 40 votes. <u>Treasurer</u>: Chanæ Baker (Pct 48) was elected by acclimation.

Chair Chestnut presented a recommendation from the SC for annual dues of \$25 with \$10 designated as "dues," and \$15 designated as "a donation," with all money going to the program budget. After spirited discussion, a <u>motion</u> to accept the recommendation was made and seconded. There followed an <u>amendment to</u> add "voluntary" before "annual" which was seconded. Then, there was an <u>amendment to</u> to add "suggested" before the word "voluntary" in the amendment to the original motion which was seconded. The vote on the secondary amendment was 84-1, the vote on the primary amendment was 82-3, and the vote on the original motion, which now reads, "Suggested, voluntary annual dues for DEC members will be \$25, with \$10 designated as 'dues' and \$15 designated as 'a donation,' with all money going to the program budget," carried 74-11.

<u>Grievance Committee</u>: Interim Chair Melvin Flournoy presented the recommendations of the Committee regarding the complaint Susan Bottcher brought against Debbie Martinez. The recommendations are:

- 1. Mrs. Martinez shall be prohibited from participating in any and all ACDEC sponsored events for a period of one (1) year from the date that this sanctim is approved by the ACDEC General Body.
- 2. Mrs. Martinez shall have until 31 January 2018 to properly execute and submit a new, un-altered Florida Democratic Party Loyalty Oath to the Membership Committee.
- 3. Furthermore, any future ruling that finds Mrs. Martinez in violation of the loyalty oath or any sanctions imposed by the ACDEC General Membership as a result of this matter shall result in her immediate removal from her ACDEC office.

A motion was made to accept these recommendations. There followed an <u>amendment</u> to strike No. 3 (above) which was seconded. After some discussion and pasage of the previous question, the amendment carried 67-1. At this point, Ray Washington, Esq., representing Debbie Martinez, spok on her behalf. There followed a <u>motion</u> to postpone a vote on sanctions indefinitely, seconded, and failed 25-48. Lively debate on the main motion ensued. Speakers supporting the motion included Susan Bottcher (Pct 24), Scott Schmidt (Pct 54), Helen Strain (Pct 33), Linda Basham (Pct 33AL), Richard Powell (Pct 22), Julia Reiskind (Pct 32), and Kristen Young Pct 18). They spoke alternatively with those opposed to the motion – Sam Collins (Pct 16), Paula Stahmer (Pct 32), Maurice Levy (Pct 50), Kristen Thompson (Pct 42), Don Fields (Pct 61), Robert Mounts (Pct 5), and Mark Goldstein (Pct 17). After time expired for debate, a vote was taken on the amended motion. While tellers counted the vote, members made the following announcements.

The Pleasant Street neighborhood is sponsoring a candidate forum for Gainesville City Commission candidates.

Faye Williams expressed concern and disappointment about what happened bright. She asked for forgiveness for all members and suggested we move forward from this dreadful event.

Casey Willits reported that ten Florida congressional districts, including CD 3, have met their quota for the Second Chances Amendment.

Annie Orlando, a former candidate for Gainesville City Commission, reviewed her race and severely criticized the koyalty oath.

Joe Addition announced that he had withdrawn as a candidate for Florida HD 3. The <u>amended motion</u> (above) from the Grievance Committee carried 58-28.

There being no further business, the meeting was adjourned at 10:28PM.




