If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing*. The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. ORDER OF PROBABLE CAUSE

THIS MATTER was heard by the Florida Elections Commission ("Commission") at its regularly scheduled meeting on December 1, 2020, in Tallahassee, Florida.

On March 18, 2020, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff's Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation(s):

Count 1:

On or about May 17, 2019, Ryan Ramsey violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2018 Termination Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 2:

On or about June 29, 2018, Ryan Ramsey violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2018 P1 Report was true, correct, and complete when it was not.

The Commission finds that there is no probable cause to charge Respondent with violating

Section 106.09(1)(b), Florida Statutes.

NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by <u>consent order</u> where you and Commission staff agree to resolve the violation(s) and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an <u>informal hearing</u> held before the Commission, if you <u>do not</u> dispute any material fact in the Staff Recommendation. You have thirty (30) days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to make written or oral arguments to the Commission concerning the legal issues related to the violation(s) and the potential fine. At the request of Respondent, the Commission will consider and determine willfulness at an informal hearing. Otherwise, live witness testimony is unnecessary.

Third, you may request a <u>formal hearing</u> held before an administrative law judge in the Division of Administrative Hearings ("DOAH"), if you dispute any material fact in the Staff Recommendation. You have thirty (30) days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to present evidence relevant to the violation(s) listed in this order, to cross-examine opposing witnesses, to impeach any witness, and to rebut the evidence presented against you.

If you do not elect to resolve the case by consent order or request a formal hearing at the DOAH or an informal hearing before the Commission within thirty (30) days of the date this Order of Probable Cause is filed with the Commission, the case will be sent to the Commission for a formal or informal hearing, depending on whether the facts are in dispute. STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating Sections 106.07(2)(b)1., and 106.07(5), Florida Statutes, and no probable cause to charge Respondent with violating Section 106.09(1)(b), Florida Statutes.¹ Based upon a thorough review of the Report of Investigation submitted on December 17, 2019, the following facts and law support this staff recommendation:

1. On June 3, 2019, the Florida Elections Commission ("Commission") received a referral from the Department of State, Division of Elections ("Division" or "Complainant"), alleging that Ryan Ramsey ("Respondent") violated Chapter 106, Florida Statutes.

2. Respondent was a 2018 candidate for State Representative, District 19. Respondent's Statement of Candidate form ("DS-DE 84") was filed on August 3, 2017. (ROI Exhibit 3)²

3. By letter dated July 10, 2019, the Executive Director notified Respondent that Commission staff would investigate the following statutory provisions:

Section 106.07(2)(b)1., Florida Statutes: Respondent, a 2018 candidate for State Representative, District 19, acting as his own treasurer, failed to timely make necessary amendments to the campaign's 2018 TR report, as alleged in the complaint.

Section 106.07(5), Florida Statutes: Respondent, a 2018 candidate for State Representative, District 19, may have certified one or more campaign treasurer reports were true, correct, and complete when they were not, as alleged in the complaint.

Section 106.09(1)(b), Florida Statutes: Respondent, a 2018 candidate for State Representative, District 19, may have accepted one or more cash contributions in excess of the \$50 per campaign limit, as alleged in the complaint.

¹ With regard to all other allegations set forth by Complainant, said allegations are more appropriately charged under other sections of law, were previously addressed in a prior case or are barred from further investigation, and therefore, a recommendation of probable cause or no probable cause need not be issued.

² The Report of Investigation is referred to herein as "ROI."

Section 106.141(1), Florida Statutes: Respondent, a 2018 candidate for State Representative, District 19, filed a 2018 Termination Report that may have failed to accurately reflect the disposition of all remaining campaign funds, as alleged in the complaint.

Section 106.19(1)(c), Florida Statutes: Respondent, a 2018 candidate for State Representative, District 19, may have falsely reported or deliberately failed to include information in one or more campaign treasurer reports, as required by Chapter 106, as alleged in the complaint.

4. On August 3, 2017, Respondent filed his Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates form ("DS-DE 9") appointing Brandi Hicks as treasurer for his campaign. (ROI Exhibit 1, page 1) On May 14, 2018, Respondent appointed himself as treasurer for his campaign. (ROI Exhibit 1, page 2)

5. By letter dated August 4, 2017, Kristi Reid Willis, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that the Division had received his DS-DE 9 and that his name was placed on the 2018 active candidate list. (ROI Exhibit 2, page 1)

6. The acknowledgment letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system ("EFS"), and provided Respondent with a user identification number and initial password to grant access to the EFS. (ROI Exhibit 2, page 1) The letter further advised Respondent that all of the Division's publications and reporting forms were available on its website and directed Respondent to print out Chapter 106, Florida Statutes, and the *Calendar of Reporting Dates*, as well as other relevant documents. (ROI Exhibit 2, page 2)

Alleged Violation: Section 106.07(2)(b)1., Florida Statutes

. (·

7. The campaign's 2018 Termination Report was filed on February 4, 2019. (ROI Exhibit 13, page 1) The report was incomplete when filed. (ROI Exhibits 4 & 5)

8. The Division sent three letters notifying Respondent that the campaign's report was incomplete and that Respondent was required to amend the report within 7 days of receipt of the notification. An Error Report showing why the report was incomplete was attached to each notification. (ROI Exhibits 4 & 5) The final notification was confirmed delivered. (ROI Exhibit 5, page 2)

9. Respondent stated that his wife helped him with the campaign reporting but acknowledged that he was ultimately responsible for it. (ROI Exhibit 15, page 1)

10. As of October 14, 2019, Respondent had not filed the required amendment to his report. (ROI Exhibit 6)

11. Respondent failed to timely file the required amendment to the campaign's 2018 Termination Report within 7 days of receiving notification from the Division that the report was incomplete and required amendment.

Alleged Violation: Section 106.07(5), Florida Statutes

12. Complainant alleged that Respondent violated Florida's election laws by certifying that the campaign's reports were true, correct, and complete when they were not. The reporting periods at issue are the 2018 P1 and 2018 TR reporting periods.

13. Under Section 106.07, Florida Statutes, a campaign treasurer's report is required to contain all contributions received and all expenditures made during the reporting period.

14. The campaign's 2018 P1 Report was incorrect as Respondent failed to disclose a \$50 check contribution from self and disclosed a \$45 cash contribution from self which was not supported by bank records. (ROI Exhibit 9, pages 2-10) (See ROI, Table 1, page 3)

15. The campaign's 2018 Termination Report was incorrect as shown in Table 1 of the Report of Investigation, however, this report was previously addressed in a prior case (FEC 18-477) wherein staff recommended charging a violation of Section 106.19(1)(c), Florida Statutes, for a deliberate failure to include information on the campaign's 2018 Termination Report. (ROI Exhibit 10, pages 2-13) (See ROI, Table 1, pages 3 & 4)

16. Respondent certified that the campaign's 2018 P1 Report was true, correct, and complete when it was not. With regard to the campaign's 2018 Termination Report, all reporting inaccuracies were previously addressed in case no: FEC 18-477.

Alleged Violation: Section 106.09(1)(b), Florida Statutes

17. Complainant alleged that Respondent violated Florida's election laws by accepting a cash contribution in excess of \$50. More specifically, Complainant alleged that Respondent accepted a \$100 cash contribution from Gregory Peele. (ROI Exhibit 4, page 3)

18. Respondent's 2018 P1 Report shows a \$100 cash contribution from Gregory Peele. The report was later amended to change the contribution from cash to check. (ROI Exhibit 11, page 1) The report also shows an additional \$100 check contribution from Gregory Peele. (ROI Exhibit 11, page 2)

19. Gregory Peele stated that he made two \$100 contributions to Respondent's campaign, but that both contributions were online transactions that resulted in direct debits from his checking accounting. He stated that he did not make any cash contributions to Respondent's campaign. (ROI Exhibit 12)

20. It does not appear that Respondent accepted a cash contribution in excess of \$50.

Alleged Violation: Section 106.141(1), Florida Statutes

21. With regard to the Complainant's allegation that Respondent failed to timely file the campaign's 2018 Termination Report, said allegation was investigated by Commission staff in case number FEC 18-477. Therefore, Commission staff is barred from further investigating the allegation in this matter. See § 106.25(2), Fla. Stat.

Alleged Violation: Section 106.19(1)(c), Florida Statutes

22. With regard to the Complainant's allegation that Respondent falsely reported or deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2018 P1 Report, Respondent's actions and omissions as set forth in the analysis above are more appropriately charged as a Section 106.07(5), Florida Statutes, violation.

23. With regard to the Complainant's allegation that Respondent falsely reported or deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2018 Termination Report, said allegation was investigated by Commission staff in case number FEC 18-477. Therefore, Commission staff is barred from further investigating the allegation in this matter. See § 106.25(2), Fla. Stat.

24. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).

25. The facts set forth above show that Respondent was a 2018 candidate for State Representative, District 19. Respondent failed to timely file the required amendment to the campaign's 2018 Termination Report within 7 days of receiving notification from the Division that the report was incomplete and required amendment. Respondent certified that the campaign's 2018 P1 Report was true, correct, and complete when it was not. It does not appear that Respondent accepted a cash contribution in excess of \$50. With regard to all other allegations set forth by Complainant, said allegations are more appropriately charged under other sections of law, were previously addressed in a prior case or are barred from further investigation.

Based upon these facts and circumstances, I recommend that the Commission find no probable cause to charge Respondent with violating Section 106.09(1)(b), Florida Statutes, and find probable cause to charge Respondent with violating the following:

Count 1:

On or about May 17, 2019, Ryan Ramsey violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an

addendum to the campaign's 2018 Termination Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 2:

r

On or about June 29, 2018, Ryan Ramsey violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2018 P1 Report was true, correct, and complete when it was not.

Pursuant to Section 106.25(2), Florida Statutes, on June 3, 2019, the Florida Elections Commission (Commission) received information from the Division of Elections (Division) that Respondent violated Chapter 106, Florida Statutes. Commission staff, therefore, investigated whether Respondent violated the following statutes:

Section 106.07(2)(b)1, Florida Statutes, failure of the treasurer of a candidate to timely file an addendum to an incomplete report after receiving notification from the filing officer;

Section 106.07(5), Florida Statutes, prohibiting a candidate from certifying to the correctness of a campaign treasurer's report that is incorrect, false, or incomplete;

Section 106.09(1)(b), Florida Statutes, prohibiting a person from accepting a contribution in the aggregate in cash in excess of \$50;

Section 106.141(1), Florida Statutes, failure of a candidate to dispose of funds remaining in his campaign account within 90 days after he withdrew, became unopposed, was eliminated, or elected and to file a report reflecting the disposition of all remaining funds; and

Section 106.19(1)(c), Florida Statutes, prohibiting a person or organization from falsely reporting or deliberately failing to report information required by Chapter 106, Florida Statutes.

I. Preliminary Information:

1. Respondent, Ryan Ramsey, was a 2018 candidate for State Representative, District 19; he did not qualify.

2. Complainant is the Division.

- 3. Respondent's filing officer is Kristi Reid Willis, Chief, Bureau of Election Records.
- 4. On August 3, 2017, Respondent's Appointment of Campaign Treasurer and

Designation of Campaign Depository form (DS-DE 9) was filed with the Division. Respondent appointed Brandi A. Hicks as his campaign treasurer. On May 14, 2018, Respondent replaced Brandi Hicks as campaign treasurer, and on June 4, 2018, Respondent designated TD Bank as his campaign depository. To review the DS-DE 9 forms, refer to Exhibit 1.

5. On August 4, 2017, Ms. Bronson sent Respondent a letter acknowledging his name had been placed on the active candidate list. The letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system (EFS). Respondent was provided with a user identification number and initial password allowing him access to the EFS.

6. The letter also advised Respondent that all of the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Candidate and Campaign Treasurer Handbook*, and the Calendar of Reporting Dates. The letter further advised Respondent that it was his responsibility to read, understand, and follow the requirements of Florida's election laws. To review a copy of the acknowledgment letter, refer to Exhibit 2.

7. Respondent executed a Statement of Candidate form indicating that he had been provided access to read and understand the requirements of Chapter 106, Florida Statutes; the form is dated as having been signed July 27, 2017. To review the Statement of Candidate form, refer to Exhibit 3.

II. Alleged Violation of Section 106.07(2)(b)1, Florida Statutes:

8. I investigated whether Respondent violated this section of the election laws by not timely filing an amendment to his 2018 Termination-Report (TR) after receiving notification that the report was incomplete.

9. On April 2 and April 16, 2019, the Division sent Respondent letters informing him that one or more of his campaign reports were incomplete. The letter included an error report referencing the 2018 TR. To review copies of the letters and the error report, refer to Exhibit 4.

10. On May 9, 2019, the Division sent Respondent a "Final Notice" letter informing him that one or more of his campaign reports were incomplete. The letter included an error report referencing the 2018 TR; it was confirmed delivered on May 10, 2019. To review the Final Notice letter and the delivery confirmation, refer to Exhibit 5.

11. Respondent did not offer a response to the referral nor did he return a questionnaireaffidavit.

12. According to Ms. Willis, in an e-mail dated October 14, 2019, Respondent's 2018 TR had not been amended and corrected. To review an e-mail from Ms. Willis, refer to Exhibit 6.

13. No record was found to indicate that Respondent has previously violated this section of the election laws.

III. Alleged Violation of Section 106.07(5), Florida Statutes:

14. I investigated whether Respondent violated this section of the election laws by certifying to the correctness of campaign reports as true, correct, and complete, when they were not.

15. Based on the Sum of Contributions vs Expenditures printout, submitted with the referral, it appeared that one or more campaign reports may have been incorrect because there was an apparent surplus of \$80.00 after the 2018 TR was filed. To review the Sum of Contributions vs Expenditures printout, refer to Exhibit 7.

16. I subpoenaed Respondent's campaign account records from his designated campaign depository, TD Bank¹, and compared the campaign account records to his campaign reports. Discrepancies were found in Respondent's 2018 M5, 2018 P1 and 2018 TR, which will be addressed in Table 1 below. Respondent certified the campaign reports as true, correct, and complete.

17. No record was found to indicate that Respondent has previously violated this section of the election laws.

IV. Alleged Violation of Section 106.09(1)(b), Florida Statutes:

18. I investigated whether Respondent violated this section of the election law when he accepted cash contributions in excess of the \$50 per election limit.

19. Complainant included with the referral a copy of an error report referencing Respondent's 2018 P1 campaign report. A notation on the error report read, "Cash contributions may not exceed \$50 – Written explanation required" and identified the contributor as "Gregory" Peele." To review the error report, refer to Exhibit 4, page 3.

20. Table 2 below is reflective of how the contributions were reported. To review the itemized-contributions pages from the 2018 P1 campaign report, refer to Exhibit 11.

21. In an e-mail, the contributor, Gregory Peele, stated that he made two contributions, in the amount of \$100 each, to Respondent's campaign through an online transaction that was a direct debit from his checking account. Mr. Peele added that he did not make any cash contributions to Respondent's campaign. To review the e-mail from the contributor, refer to Exhibit 12.

22. No record was found to indicate that Respondent has previously violated this section of the election laws.

V. Alleged Violation of Section 106.141(1), Florida Statutes

23. I investigated whether Respondent violated this section of the election laws by failing to dispose of funds within 90 days of not qualifying and file a TR reflecting the disposition of the funds.

24. Based on the Sum of Contributions vs Expenditures printout, submitted with the referral, Respondent's campaign had \$80.00 in funds remaining in the account after the filing of the TR. To review the Sum of Contributions vs Expenditures printout, refer to Exhibit 7.

25. As per paragraph one, Respondent did not qualify; Respondent was required to dispose of funds remaining in his campaign account and file a report reflecting the disposition of funds by September 20, 2018.

26. According to his filing history, Respondent's TR was filed with the Division on February 4, 2019, 137 days late. To review Respondent's filing history, refer to Exhibit 13.

27. According to the monthly bank statements, on September 20, 2018, the campaign account had a balance of \$1,796.92. Further, bank records disclose that the account was closed with a zero balance on January 22, 2019. To review the September 2018 bank statement, as well as the January 2019 bank statement, refer to Exhibit 14.

28. No record was found to indicate that Respondent has previously violated this section of the election laws.

VI. Alleged Violation of Section 106.19(1)(c), Florida Statutes:

29. I investigated whether Respondent violated this section of the election laws by falsely reporting or failing to report information.

30. As to the information that was falsely reported or not reported, refer to Table 1 following paragraph 16.

31. No record was found to indicate that Respondent has previously violated this section of the election laws.

VII. FEC History:

32. Respondent has no prior history with the Florida Elections Commission.

Conclusion:

33. On December 16 and 17, 2019, I attempted to contact Respondent for the purpose of reviewing the case with him and to afford him an opportunity for questions or comments. However, each attempt was unsuccessful. To review the phone log, refer to Exhibit 15.

On June 3, 2019, the Florida Elections Commission received a complaint alleging that you violated Florida's election laws. I have reviewed the complaint and find that it contains one or more legally sufficient allegations. The Commission staff will investigate the following alleged violations:

Section 106.07(2)(b)1., Florida Statutes: Respondent, a 2018 candidate for State Representative, District 19, acting as his own treasurer, failed to timely make necessary amendments to the campaign's 2018 TR report, as alleged in the complaint.

Section 106.07(5), Florida Statutes: Respondent, a 2018 candidate for State Representative, District 19, may have certified one or more campaign treasurer reports were true, correct, and complete when they were not, as alleged in the complaint.

Section 106.09(1)(b), Florida Statutes: Respondent, a 2018 candidate for State Representative, District 19, may have accepted one or more cash contributions in excess of the \$50 per campaign limit, as alleged in the complaint.

Section 106.141(1), Florida Statutes: Respondent, a 2018 candidate for State Representative, District 19, filed a 2018 Termination Report that may have failed to accurately reflect the disposition of all remaining campaign funds, as alleged in the complaint.

Section 106.19(1)(c), Florida Statutes: Respondent, a 2018 candidate for State Representative, District 19, may have falsely reported or deliberately failed to include information in one or more campaign treasurer reports, as required by Chapter 106, as alleged in the complaint.

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. Based on the results of the investigation, a staff attorney will make a written recommendation (Staff Recommendation or SR) to the Commission as to whether there is probable cause to charge respondent with violating Chapters 104 or 106, Florida Statutes. You will have an opportunity to respond to both the ROI and the SR. The Commission will then hold one or more hearings to determine whether the alleged violations occurred and, if so, the amount of the fine to be imposed. You and the complainant will receive notice at least 14 days before any hearing at which your case is to be considered.
