If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. #### ORDER OF PROBABLE CAUSE

THIS MATTER was heard by the Florida Elections Commission ("Commission") at its regularly scheduled meeting on December 1, 2020, in Tallahassee, Florida.

On March 6, 2020, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff's Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation(s):

#### Count 1:

On or about September 20, 2018, Ryan Ramsey violated Section 106.141(1), Florida Statutes, when he failed to file the campaign's 2018 Termination Report reflecting the disposition of all remaining campaign funds within 90 days after being eliminated as a candidate.

#### Count 2:

On or around September 20, 2018, Ryan Ramsey violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2018 Termination Report.

The Commission finds that there is **no probable cause** to charge Respondent with violating Section 106.07(7), Florida Statutes.

#### NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by <u>consent order</u> where you and Commission staff agree to resolve the violation(s) and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an <u>informal hearing</u> held before the Commission, if you <u>do not</u> dispute any material fact in the Staff Recommendation. You have thirty (30) days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to make written or oral arguments to the Commission concerning the legal issues related to the violation(s) and the potential fine. At the request of Respondent, the Commission will consider and determine willfulness at an informal hearing. Otherwise, live witness testimony is unnecessary.

#### STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating **Sections 106.141(1)**, and **106.19(1)(c)**, **Florida Statutes**, and **no probable cause** to charge Respondent with violating **Section 106.07(7)**, **Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on December 17, 2019, the following facts and law support this staff recommendation:

- 1. On December 14, 2018, the Florida Elections Commission ("Commission") received a referral from the Department of State, Division of Elections ("Division" or "Complainant"), alleging that Ryan Ramsey ("Respondent") violated Chapter 106, Florida Statutes.
- 2. Respondent was a 2018 candidate for State Representative, District 19. Respondent's Statement of Candidate form ("DS-DE 84") was filed on August 3, 2017. (ROI Exhibit 3)<sup>1</sup>
- 3. By letter dated January 18, 2019, the Executive Director notified Respondent that Commission staff would investigate the following statutory provisions:

Section 106.07(7), Florida Statutes: As alleged in the complaint, Respondent, a 2018 candidate for State Representative, may have failed to notify the filing officer on the prescribed reporting date that no report would be filed on that date because he had not received funds, made contributions, or expended reportable funds during the 2018 termination reporting period.

Section 106.141(1), Florida Statutes: As alleged in the complaint, Respondent, a 2018 candidate for State Representative, failed to timely file his 2018 Termination Report reflecting the disposition of all remaining campaign funds.

Section 106.19(1)(c), Florida Statutes: As alleged in the complaint, Respondent, a 2018 candidate for State Representative, may have falsely reported or deliberately failed to include

information in his 2018 Termination Report, as required by Chapter 106.

- 4. On August 3, 2017, Respondent filed his Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates form ("DS-DE 9") appointing Brandi Hicks as treasurer for his campaign. (ROI Exhibit 1, page 1) On May 14, 2018, Respondent appointed himself as treasurer for his campaign. (ROI Exhibit 1, page 2)
- 5. By letter dated August 4, 2017, Kristi Reid Willis, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that the Division had received his DS-DE 9 and that his name was placed on the 2018 active candidate list. (ROI Exhibit 2, page 1)
- 6. The acknowledgment letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system ("EFS"), and provided Respondent with a user identification number and initial password to grant access to the EFS. (ROI Exhibit 2, page 1) The letter further advised Respondent that all of the Division's publications and reporting forms were available on its website and directed Respondent to print out Chapter 106, Florida Statutes, and the *Calendar of Reporting Dates*, as well as other relevant documents. (ROI Exhibit 2, page 2)

#### Alleged Violation: Section 106.141(1), Florida Statutes

- 7. Complainant alleged that Respondent violated Florida's election laws by failing to timely file the campaign's 2018 Termination Report.
- 8. Respondent did not qualify and was eliminated as a candidate. Respondent was required to dispose of the funds on deposit in his campaign account and file the campaign's 2018 Termination Report within 90 days after being eliminated as a candidate.
- 9. On September 21, 2018, November 7, 2018, and November 20, 2018, the Division sent letters notifying Respondent that his report had not been received. (ROI Exhibits 4 & 5)
- 10. A subpoena was issued to Respondent's designated campaign depository to ascertain whether any financial activity occurred during the relevant reporting period, i.e., June 23, 2018 September 20, 2018. Respondent's bank records show six or more contributions totaling \$1,602.12 (including transfers from PayPal), eight expenditures totaling \$608.03, and six bank fees totaling \$36. (ROI Exhibit 6) (See ROI, page 3, Table)
- 11. Respondent stated that his wife helped him with the campaign reporting but acknowledged that he was ultimately responsible for it. He stated that a termination report was eventually filed. (ROI Exhibit 8, page 1) On February 4, 2019, the report was filed. It was 137 days late. (ROI Exhibit 7)

12. As it appears that Respondent had reportable financial activity during the relevant reporting period, Respondent was required to file the campaign's 2018 Termination Report within 90 days after being eliminated as a candidate, but failed to do so.

#### Alleged Violation: Section 106.19(1)(c), Florida Statutes

- 13. Complainant alleged that Respondent violated Florida's election laws by falsely reporting or deliberately failing to include information required by Chapter 106, Florida Statutes, on the campaign's 2018 Termination Report.
- 14. Based on the above analysis, Respondent had reportable financial activity during the relevant reporting period. Therefore, Respondent was required to disclose the financial activity on the campaign's 2018 Termination Report.
- 15. To date, Respondent has not disclosed the \$2,246.15 in financial activity but rather disclosed six expenditures which are not supported by Respondent's bank records. (ROI Exhibit 6; Attachment A) With regard to Respondent's deliberate failure to include information on the campaign's report, he may have failed to disclose the campaign's financial activity as the funds were not disposed of properly pursuant to sections 106.141(4)(a), and 106.11(5), Florida Statutes, but were spent at gas stations, grocery stores, a restaurant, and a tow company or were withdrawn as cash at an ATM. (ROI Exhibit 6)
- 16. Respondent deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2018 Termination Report.

#### Alleged Violation: Section 106.07(7), Florida Statutes

- 17. Complainant alleged that Respondent violated Florida's election laws by failing to notify the filing officer on the prescribed reporting date that no report would be filed for the 2018 Termination reporting period.
- 18. Based on the above analysis, the campaign was not required to submit a notice of no activity for the 2018 Termination reporting period as there was reportable financial activity that Respondent was required to disclose on his 2018 Termination Report.
- 19. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).
- 20. The facts set forth above show that Respondent was a 2018 candidate for State Representative, District 19. Respondent failed to file the campaign's 2018 Termination Report within 90 days after being eliminated as a candidate. Respondent deliberately failed to include

information required by Chapter 106, Florida Statutes, on the campaign's 2018 Termination Report. Respondent was not required to notify the filing officer that he would not be filing his 2018 Termination Report because the campaign had reportable financial activity.

Based upon these facts and circumstances, I recommend that the Commission find no probable cause to charge Respondent with violating Section 106.07(7), Florida Statutes, and find probable cause to charge Respondent with violating the following:

#### Count 1:

On or about September 20, 2018, Ryan Ramsey violated Section 106.141(1), Florida Statutes, when he failed to file the campaign's 2018 Termination Report reflecting the disposition of all remaining campaign funds within 90 days after being eliminated as a candidate.

#### Count 2:

On or around September 20, 2018, Ryan Ramsey violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2018 Termination Report.

# FLORIDA ELECTIONS COMMISSION REPORT OF INVESTIGATION

**Case No.: FEC 18-477** 

Respondent: Ryan Ramsey

Complainant: Division of Elections

Pursuant to Section 106.25(2), Florida Statutes, on December 14, 2018, the Florida Elections Commission (Commission) received information from the Division of Elections (Division) that Respondent violated Chapter 106, Florida Statutes. Commission staff, therefore, investigated whether Respondent violated the following statutes:

Section 106.07(7), Florida Statutes, failure of a candidate who did not receive any contributions or make any expenditures during a reporting period to notify timely the filing officer, in writing, that no report is being filed;

Section 106.141(1), Florida Statutes, failure of a candidate to dispose of funds remaining in his campaign account within 90 days after he withdrew, became unopposed, was eliminated, or elected and to file a report reflecting the disposition of all remaining funds; and

Section 106.19(1)(c), Florida Statutes, prohibiting a person or organization from falsely reporting or deliberately failing to report information required by Chapter 106, Florida Statutes.

### I. Preliminary Information:

- 1. Respondent, Ryan Ramsey, was a 2018 candidate for State Representative, District 19; he did not qualify.
  - 2. Complainant is the Division.
  - 3. Respondent's filing officer is Kristi Reid Willis, Chief, Bureau of Election Records.
- 4. On August 3, 2017, Respondent's Appointment of Campaign Treasurer and Designation of Campaign Depository form (DS-DE 9) was filed with the Division. Respondent appointed Brandi A. Hicks as his campaign treasurer<sup>1</sup>. To review the DS-DE 9 forms, refer to Exhibit 1.

<sup>&</sup>lt;sup>1</sup> On May 14, 2018, Respondent replaced Brandi A. Hicks as campaign treasurer. On June 4, 2018, Respondent designated TD Bank as his campaign depository.

- 5. On August 4, 2017, Ms. Bronson sent Respondent a letter acknowledging his name had been placed on the active candidate list. The letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system (EFS). Respondent was provided with a user identification number and initial password allowing him access to the EFS.
- 6. The letter also advised Respondent that all of the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Candidate and Campaign Treasurer Handbook*, and the Calendar of Reporting Dates. The letter further advised Respondent that it was his responsibility to read, understand, and follow the requirements of Florida's election laws. To review a copy of the acknowledgment letter, refer to Exhibit 2.
- 7. Respondent executed a Statement of Candidate form indicating that he had been provided access to read Chapter 106, Florida Statutes; the form is dated as having been signed July 27, 2017. To review the Statement of Candidate, refer to Exhibit 3.
- 8. On September 21 and November 7, 2018, the Division sent Respondent letters stating that he had not filed either a termination-report or notification that no reportable activity occurred and reminded him that the filing date was September 20, 2018. The letters were mailed to Respondent at the address provided on his DS-DE 9 form. To review the letters relative to the termination-report, refer to Exhibit 4.
- 9. On November 20, 2018, the Division sent Respondent a letter marked "Final Notice" stating that his 2018 Termination-Report or the required notification that no reportable activity occurred, had not been filed. The letter was mailed to Respondent at the address provided on his DS-DE 9 form and delivered on November 21, 2018. To review the letter marked Final Notice as well as the delivery confirmation, refer to Exhibit 5.
- 10. On December 14, 2018, the Commission staff received a referral from the Division alleging that Respondent failed to report campaign activity during the 2018 Termination-reporting period, or in the alternative, failed to notify the filing officer that no report would be filed. The allegations will be discussed in the paragraphs that follow.

### II. Alleged Violation of Section 106.07(7), Florida Statutes:

- 11. I investigated whether Respondent violated this section of the election laws by not notifying the filing officer, in writing, that no report would be filed due to not receiving any contributions or making any expenditures during the termination-reporting period.
- 12. I subpoenaed Respondent's campaign account records from his designated campaign depository, TD Bank. Based on information from the campaign depository, it appears that Respondent was not required to notify the filing officer, in writing, with a notification-of-no-activity that no report would be filed. Rather, Respondent was required to file his 2018 Termination-Report to disclose financial activity.
  - 13. A review of the campaign account records reveals the following activity during the

termination-reporting period<sup>2</sup>. To review the monthly bank statements, refer to Exhibit 6.

affidavit.

15. No record was found to indicate that Respondent has previously violated this section of the election laws.

#### III. Alleged Violation of Section 106.141(1), Florida Statutes:

- 16. I investigated whether Respondent violated this section of the election laws by not timely filing his 2018 Termination-Report reflecting the disposition of all remaining campaign funds.
- 17. Respondent was a candidate in the 2018 election cycle; he did not qualify. Therefore, it appears that Respondent was required to dispose of his surplus funds by September 20, 2018.
- 18. As previously addressed, Respondent did not file his 2018 Termination-Report covering the reporting period of June 23 September 20, 2018<sup>3</sup>. According to his monthly bank statements, on September 20, 2018, Respondent's campaign account had a balance of \$1,796.92<sup>4</sup>. To review the September 2018 bank statement, refer to Exhibit 6, page 4.
- 19. As per paragraph 14, Respondent did not offer a response to the referral nor did he return a questionnaire-affidavit.
- 20. No record was found to indicate that Respondent has previously violated this section of the election laws.

#### IV. Alleged Violation of Section 106.19(1)(c), Florida Statutes:

- 21. I investigated whether Respondent violated this section of the election laws by not reporting campaign activity during the 2018 Termination-reporting period.
- 22. To review the circumstances relative to Respondent's campaign activity during the termination-reporting period, refer to paragraph 13.
- 23. According to Respondent's filing history, a notification-of-no-activity or a campaign report has been filed for each of the reporting periods prior to the reporting period covering the termination-report. To review Respondent's filing history, refer to Exhibit 7.
- 24. No record was found to indicate that Respondent has previously violated this section of the election laws.

#### V. FEC History:

25. Respondent has no prior history with the Florida Elections Commission.



In the event that the EFS is inoperable on the due date, the report will be accepted as timely filed if filed no later than midnight of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any candidate failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first 3 days late and, thereafter, \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for reports immediately preceding each primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

#### **Electronic Receipts**

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the candidate and campaign treasurer and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.

An online instruction guide is available to you on the EFS to assist with navigation, data entry, and submission of reports. The Division of Elections will also provide assistance to all users by contacting the EFS Help Desk at (850) 245-6280.

Our records indicate that you have not filed either your termination report or notification that no reportable activity occurred, whichever is applicable. The filing date was September 20, 2018.

The law (s. 106.07(8)(b), Fla. Stat.) requires the filing officer to immediately notify you about the missed filing date and the automatic fines that will be assessed for late filing of a report, if a report was due.

- If reportable activity occurred and you have not filed a report, statutory fines are automatically assessed as \$50 per day until you file your report. The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period. Even if you end up filing your report late, we cannot waive the statutory fines. We will notify you of the specific amount of fines owed once you file your report. You have 20 days from the day you receive the notice to pay the fine or to appeal the fine to the Florida Elections Commission.
- If no reportable activity occurred for the report date(s), you are still required to notify us in writing, via the Division's Electronic Filing System, that no reportable activity occurred. No automatic fines are statutorily assessed.

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.



On December 14, 2018, the Florida Elections Commission received a complaint alleging that you violated Florida's election laws. I have reviewed the complaint and find that it contains one or more legally sufficient allegations. The Commission staff will investigate the following alleged violations:

Section 106.07(7), Florida Statutes: As alleged in the complaint, Respondent, a 2018 candidate for State Representative, may have failed to notify the filing officer on the prescribed reporting date that no report would be filed on that date because he had not received funds, made contributions, or expended reportable funds during the 2018 termination reporting period.

Section 106.141(1), Florida Statutes: As alleged in the complaint, Respondent, a 2018 candidate for State Representative, failed to timely file his 2018 Termination Report reflecting the disposition of all remaining campaign funds.

Section 106.19(1)(c), Florida Statutes: As alleged in the complaint, Respondent, a 2018 candidate for State Representative, may have falsely reported or deliberately failed to include information in his 2018 Termination Report, as required by Chapter 106.

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. If the report or notification is not filed within 7 days of receipt of this letter, the Division will refer this matter to the Florida Elections Commission, which may impose civil penalties of up to \$1000 per violation, apart from that automatic fine provisions of s. 106.07(8)(b), Fla. Stat.) that are applicable only to campaign finance reports.

As we stated in the prior notices, even if you now file the report or notification, the untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.
