If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

#### **ORDER OF PROBABLE CAUSE**

THIS MATTER was heard by the Florida Elections Commission (Commission) at its regularly scheduled meeting on February 23, 2021, in Tallahassee, Florida.

On January 5, 2021, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff's Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation(s):

#### Count 1:

On or about May 1, 2019, Javier Estevez violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2018 P5 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

#### Count 2:

On or about November 30, 2018, Javier Estevez violated Section

106.19(1)(d), Florida Statutes, when he made or authorized an expenditure prohibited by Chapter 106, Florida Statutes.

#### Count 3:

On or about November 2, 2018, Javier Estevez violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2018 G7 Report was true, correct, and complete when it was not.

#### Count 4:

On or about November 21, 2018, Javier Estevez violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2019 Termination Report was true, correct, and complete when it was not.

#### Count 5:

On or around November 2, 2018, Javier Estevez violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2018 G7 Report.

#### Count 6:

On or around November 21, 2018, Javier Estevez violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2019 Termination Report.

The Commission finds that there is **no probable cause** to charge Respondent with violating Section 106.19(1)(b), Florida Statutes.

#### NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by <u>consent order</u> where you and Commission staff agree to resolve the violation(s) and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an <u>informal hearing</u> held before the Commission, if you <u>do not</u> dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to make written or oral arguments to the Commission concerning the legal issues related to the violation(s) and the potential fine. At the request of Respondent, the Commission will consider and determine willfulness at an informal hearing. Otherwise, live witness testimony is unnecessary.

Third, you may request a <u>formal hearing</u> held before an administrative law judge in the Division of Administrative Hearings (DOAH), if you dispute any material fact in the Staff Recommendation. #### STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating **Sections 106.07(2)(b)1., 106.07(5), 106.19(1)(c), and 106.19(1)(d), Florida Statutes,** and **no probable cause** to charge Respondent with violating **Section 106.19(1)(b), Florida Statutes.** Based upon a thorough review of the Report of Investigation submitted on September 21, 2020, the following facts and law support this staff recommendation:

- 1. On May 20, 2019, the Florida Elections Commission ("Commission") received a referral from the Department of State, Division of Elections ("Division" or "Complainant"), alleging that Javier Estevez ("Respondent") violated Chapter 106, Florida Statutes.
- 2. Respondent was a 2018 candidate for State Representative, District 105. (ROI Exhibit 1, page 2)<sup>1</sup>
- 3. By letter dated June 18, 2019, the Executive Director notified Respondent that Commission staff would investigate the following statutory provisions:

Section 106.07(2)(b)1., Florida Statutes: Respondent, a 2018 candidate for State Representative, District 105, acting as his own treasurer, failed to timely make necessary amendments to the following campaign treasurer reports, as alleged in the complaint:<sup>2</sup>

- 2018 P5
- 2018 G5
- 2018 G7

Section 106.07(5), Florida Statutes: Respondent, a 2018 candidate for State Representative, District 105, may have certified one or more campaign treasurer reports were true, correct, and complete when they were not, as alleged in the complaint.

<sup>&</sup>lt;sup>1</sup> The Report of Investigation is referred to herein as "ROI."

<sup>&</sup>lt;sup>2</sup> With regard to the Division's allegations that Respondent failed to timely file the required amendments to his 2018 G5 and 2018 G7 reports within 7 days of receiving notification from the Division that the reports were incomplete and required amendment, these allegations were investigated by Commission staff in case number FEC 19-071. Therefore, Commission staff is barred from further investigating said allegations in this matter. See § 106.25(2), Fla. Stat.

Section 106.19(1)(b), Florida Statutes: Respondent, a 2018 candidate for State Representative, District 105, may have failed to report one or more contributions required to be reported by Chapter 106, Florida Statutes, as alleged in the complaint.

Section 106.19(1)(c), Florida Statutes: Respondent, a 2018 candidate for State Representative, District 105, may have falsely reported or deliberately failed to include information in one or more campaign treasurer reports, as required by Chapter 106, Florida Statutes, as alleged in the complaint.

Section 106.19(1)(d), Florida Statutes: Respondent, a 2018 candidate for State Representative, District 105, may have made or authorized one or more expenditures prohibited by Chapter 106, Florida Statutes, as alleged in the complaint.

- 4. On September 6, 2017, Respondent filed his Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates form ("DS-DE 9") appointing himself as treasurer for his campaign. (ROI Exhibit 1, page 1)
- 5. By letter dated September 7, 2017, Kristi Reid Willis, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that the Division had received his DS-DE 9 and that his name was placed on the 2018 active candidate list. (ROI Exhibit 2, page 1)
- 6. The acknowledgment letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system ("EFS"), and provided Respondent with a user identification number and initial password to grant access to the EFS. (ROI Exhibit 2, page 1) The letter further advised Respondent that all of the Division's publications and reporting forms were available on its website and directed Respondent to print out Chapter 106, Florida Statutes, and the *Calendar of Reporting Dates*, as well as other relevant documents. (ROI Exhibit 2, page 2)

#### Alleged Violation: Section 106.07(2)(b)1., Florida Statutes

- 7. The campaign's 2018 P5 Report was incomplete when filed. See Compl.
- 8. The Division sent three letters notifying Respondent that the campaign's report was incomplete and that Respondent was required to amend the report within 7 days of receipt of the notification. A Compliance Report showing why the report was incomplete was attached to each notification. (ROI Exhibits 3 & 4) The final notification was confirmed delivered. (ROI Exhibit 4, page 5) As of March 27, 2020, Respondent had not filed the required amendment to his report. (ROI Exhibit 5)

#### Alleged Violation: Section 106.19(1)(d), Florida Statutes

- 9. Complainant alleged that Respondent violated Florida's election laws by making or authorizing expenditures prohibited by Chapter 106, Florida Statutes. The reporting periods at issue are the 2018 G4, 2018 G5, 2018 G6, 2018 G7, and 2019 TR reporting periods.
- 10. A subpoena was issued to Respondent's designated campaign depository to ascertain whether Respondent authorized expenditures or signed checks drawn on the campaign depository without sufficient funds on deposit to pay the full amount of the authorized expenditures.
- 11. Respondent's bank records show four expenditures totaling \$290.90 which were made or authorized without sufficient funds on deposit to pay the full amount of the authorized expenditures. The four expenditures at issue were for two monthly bank fees (totaling \$28), an overdraft fee (\$35), and an expenditure to Facebook (\$227.90). (ROI Exhibit 7, pages 5 & 8)
- 12. Respondent made or authorized an expenditure prohibited by Chapter 106, Florida Statutes, when he made an expenditure to Facebook without sufficient funds on deposit to pay the full amount of the authorized expenditure. Commission staff declines to recommend probable cause as to the expenditures for bank fees and overdraft fees as they appear to be de minimus.

#### Alleged Violation: Section 106.07(5), Florida Statutes

- 13. Complainant alleged that Respondent violated Florida's election laws by certifying that the campaign's reports were true, correct, and complete when they were not. The reporting periods at issue are the 2018 G4, 2018 G5, 2018 G6, 2018 G7, and 2019 TR reporting periods.
- 14. Under Section 106.07, Florida Statutes, a campaign treasurer's report is required to contain all contributions received and all expenditures made during the reporting period.
- 15. The campaign's 2018 G4, 2018 G5, and 2018 G6 reports reflected all contributions received and all expenditures made during the applicable reporting periods, however, Commission staff was unable to obtain records regarding the online contribution platforms in order to confirm the itemization of certain contributions. (See ROI, p. 3, ¶16, n. 2) (ROI Exhibit 7, pages 1-4; ROI Exhibit 8, pages 1-15)
- 16. The campaign's 2018 G7 Report was incorrect as Respondent failed to disclose one monetary contribution totaling \$33.72, two expenditures totaling \$233.46, and one credit totaling \$10, and reported one expenditure totaling \$2,176.85 that was previously reported in a prior reporting period. (ROI Exhibit 7, pages 4-6, & 20; ROI Exhibit 8, pages 16-20) (See ROI, Table 1, page 4)
- 17. The campaign's 2019 Termination Report was incorrect as Respondent failed to disclose 11 expenditures totaling \$927.48, one overdraft fee totaling \$35, and three bank credits charging off the negative account balance totaling \$290.90. (ROI Exhibit 7, pages 5-9; ROI Exhibit 8, pages 21-25) (See ROI, Table 1, pages 4 & 5)

18. Respondent certified that the campaign's 2018 G7 and 2019 Termination reports were true, correct, and complete when they were not.

#### Alleged Violation: Section 106.19(1)(b), Florida Statutes

- 19. Complainant alleged that Respondent violated Florida's election laws by failing to report contributions required to be reported by Chapter 106, Florida Statutes. The reporting periods at issue are the 2018 G4, 2018 G5, 2018 G6, 2018 G7, and 2019 TR reporting periods.
- 20. Based on the above analysis, Respondent had reportable financial activity during the relevant reporting periods that was not reported, i.e., one contribution (\$33.72) and four bank credits (\$300.90). However, the alleged violations are more appropriately charged under Section 106.07(5), Florida Statutes, above.

#### Alleged Violation: Section 106.19(1)(c), Florida Statutes

- 21. Complainant alleged that Respondent violated Florida's election laws by falsely reporting or deliberately failing to include information required by Chapter 106, Florida Statutes. The reporting periods at issue are the 2018 G4, 2018 G5, 2018 G6, 2018 G7, and 2019 TR reporting periods.
- 22. Based on the above analysis, Respondent had reportable financial activity during the relevant reporting periods that was not reported. Respondent's bank records reflect one monetary contribution totaling \$33.72, 13 expenditures totaling \$1,160.94, and five bank credits or fees totaling \$335.90 that Respondent failed to disclose on his 2018 G7 and 2019 Termination Reports. (ROI Exhibit 7, pages 4-9, & 20; ROI Exhibit 8, pages 16-25) (See ROI, Table 1, pages 4 & 5)
- 23. Chapter 106, Florida Statutes, requires candidates to report any contributions received and any expenditures made for the purpose of influencing the results of an election. Respondent deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2018 G7, and 2019 Termination reports.
- 24. Respondent was given multiple opportunities to respond to Commission staff's investigation, but failed to do so. (ROI, p. 2, ¶9; ROI Exhibit 6)
- 25. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. Schmitt v. State, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. Department of Highway Safety and Motor Vehicles v. Favino, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).
- 26. The facts set forth above show that Respondent was a 2018 candidate for State Representative, District 105. Respondent failed to timely file the required amendment to the

campaign's 2018 P5 Report within 7 days of receiving notification from the Division that the report was incomplete and required amendment. Respondent made or authorized an expenditure prohibited by Chapter 106, Florida Statutes. Respondent certified that the campaign's 2018 G7, and 2019 Termination reports were true, correct, and complete when they were not. Respondent deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2018 G7, and 2019 Termination reports. Respondent failed to report contributions required to be reported by Chapter 106, Florida Statutes, however, the alleged violations are more appropriately charged under Section 106.07(5), Florida Statutes.

Based upon these facts and circumstances, I recommend that the Commission find no probable cause to charge Respondent with violating Section 106.19(1)(b), Florida Statutes, and find probable cause to charge Respondent with violating the following:

#### Count 1:

On or about May 1, 2019, Javier Estevez violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2018 P5 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

#### Count 2:

On or about November 30, 2018, Javier Estevez violated Section 106.19(1)(d), Florida Statutes, when he made or authorized an expenditure prohibited by Chapter 106, Florida Statutes.

#### Count 3:

On or about November 2, 2018, Javier Estevez violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2018 G7 Report was true, correct, and complete when it was not.

#### Count 4:

On or about November 21, 2018, Javier Estevez violated Section 106.07(5), Florida Statutes, when he certified that the campaign's 2019 Termination Report was true, correct, and complete when it was not.

#### Count 5:

On or around November 2, 2018, Javier Estevez violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2018 G7 Report.

#### Count 6:

On or around November 21, 2018, Javier Estevez violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2019 Termination Report.

#### FLORIDA ELECTIONS COMMISSION REPORT OF INVESTIGATION Case No.: FEC 19-300

**Respondent:** Javier Estevez

**Complainant:** Division of Elections

On May 20, 2019, the Florida Elections Commission (Commission) received a referral alleging that Respondent violated Chapters 104 or 106, Florida Statutes. Commission staff investigated whether Respondent violated the following statute(s):

Section 106.07(2)(b)1., Florida Statutes, failed to correctly amend his campaign treasurer reports (CTRs) in the prescribed amount of time; and

Section 106.07(5), Florida Statutes, certified one more CTRs as true, correct, and complete when they were not; and

Section 106.19(1)(b), Florida Statutes, failed to report one or more contributions; and

Section 106.19(1)(c), Florida Statutes, falsely reported or deliberately failed to include information that was required in one or more of his CTRs; and

Section 106.19(1)(d), Florida Statutes, made or authorized one or more prohibited expenditures

#### I. Preliminary Information:

- 1. Respondent was a candidate for State Representative, District 105, in the 2018 election.
  - 2. The Division of Elections (Division) served as Respondent's filing officer.
- 3. On September 6, 2017, Respondent filed an Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 9). Respondent appointed himself as his own campaign treasurer. On September 13, 2017, Respondent filed a Statement of Candidate (DS-DE 84) with the Division. In signing the DS-DE 84, Respondent acknowledged he had been provided access to read, and understand the requirements of Chapter 106, Florida Statutes. To review the DS-DE 9 and DS-DE 84 refer to Exhibit 1.

4. On September 7, 2017, the Division sent an acknowledgment letter stating Respondent was on the active candidate list. Within the letter, the Division explained when Respondent's first CTR was due, informed Respondent that all of the Division's reporting forms were available on the Division's website, and warned Respondent that, "It is your responsibility to read, understand, and follow the requirements of Florida's election laws." To review the acknowledgment letter refer to Exhibit 2.

#### II. Alleged Violation of Section 106.07(2)(b)1., Florida Statutes:

- 5. I investigated whether Respondent violated this section of the election laws by failing to amend his 2018 P5 CTR in the prescribed amount of time.<sup>1</sup>
- 6. On February 28, 2019 and April 4, 2019, the Division sent letters to Respondent informing him that one or more campaign reports were incomplete. The correspondence was sent to Respondent's address provided on the DS-DE 9 and included an error report referencing the 2018 P5 CTR. To review the correspondence and error report, refer to Exhibit 3.
- 7. On April 19, 2019, the Division sent Respondent a letter marked "Final Notice" with delivery confirmation informing him that one or more campaign reports were incomplete. The letter was sent to Respondent's address provided on the DS-DE 9 and included an error report referencing the 2018 P5 CTR. It was confirmed delivered on April 24, 2019. To review the final notice letter, error report and delivery confirmation, refer to Exhibit 4.
- 8. In an email dated March 27, 2020, Division staff confirmed that as of that date, Respondent had not correctly amended the report at issue. To review the email from Division staff, refer to Exhibit 5.
- 9. Respondent did not respond to the referral. Respondent did not respond to the questionnaire-affidavit sent, and my attempts to reach him by telephone and email were unsuccessful. Because the affidavit has not been returned and there was no response from Respondent, I am unable to ascertain whether he has read Chapter 106, Florida Statutes and/or the *Candidate and Campaign Treasurer Handbook*. To review attempts to reach Respondent through telephone and email refer to Exhibit 6.

#### **III.** Alleged Violation of Section 106.19(1)(d), Florida Statutes:

- 10. I investigated whether Respondent authorized one or more prohibited expenditures based on an apparent deficit during the 2019 Termination Report (TR) reporting period.
- 11. During my investigation, I subpoenaed Respondent's campaign depository bank records at Wells Fargo in an attempt to find prohibited expenditures; my review encompassed the 2018 G4, G5, G6, G7, and 2019 TR reporting periods. There were no instances of a negative

bank balance during the 2018 G4, G5, G6, or G7 reporting periods. However, I found that there were four expenditures during the 2019 TR reporting period for which there were insufficient funds on account, which had been zeroed out on November 19, 2018.

- 12. The first such expenditure was a \$14.00 bank fee on November 30, 2018, causing a \$14.00 deficit balance to occur. The second was a \$227.90 expenditure for Facebook on December 3, 2018, which caused the deficit balance to increase to \$241.90. The third expenditure was a \$35.00 overdraft fee on December 4, 2018, relative to the \$227.90 expenditure to Facebook, which took the deficit balance to \$276.90. The expenditure to Facebook was authorized on November 30, 2018, but the campaign account balance at that time was already down to \$0.00. The final expenditure was a \$14.00 monthly bank fee on December 31, 2018, causing the deficit to further increase to \$290.90. On January 29, 2019, the \$290.90 deficit was "charged off" by the bank, again zeroing out the depository's balance to close out the account. To review the relevant bank statements, refer to Exhibit 7.
  - 13. Refer to paragraph 9 for my attempts to get a response from Respondent.

### IV. Alleged Violations of Sections 106.07(5), 106.19(1)(b), and 106.19(1)(c), Florida Statutes:

- 14. I investigated whether Respondent violated these sections of the election laws by certifying one or more CTRs as true, correct, and complete when they were not, falsely reporting or deliberately failing to report information required, and failing to report contributions.
- 15. Based on Division records of reported contributions and reported expenditures, Respondent had a deficit amount of \$1,059.24 after the 2019 TR was filed. To review the Sum of Contributions vs. Expenditures page, refer to Exhibit 10.
- 16. During my investigation I subpoenaed Respondent's campaign depository at Wells Fargo. Bank records were compared to what was reported in Respondent's CTRs for the 2018 G4, G5, G6, G7, and 2019 TR reporting periods. Respondent's 2018 G4, G5, and G6 CTRs reflect that all expenditures were reported. In addition, all contributions made by check were reported.<sup>2</sup>
- 17. However, it was found Respondent did not correctly report all reportable financial activity during the 2018 G7 and 2019 TR reporting periods. Refer to Exhibit 7 for relevant bank records. Refer to Exhibit 8 for the relevant CTRs from Respondent's campaign. To review Respondent's filing history, refer to Exhibit 9. Table 1 shows the comparison of reported finances to Respondent's campaign depository records.

On May 20, 2019, the Florida Elections Commission received a complaint alleging that you violated Florida's election laws. I have reviewed the complaint and find that it contains one or more **legally sufficient allegations**. The Commission staff will investigate the following alleged violations:

Section 106.07(2)(b)1., Florida Statutes: Respondent, a 2018 candidate for State Representative, District 105, acting as his own treasurer, failed to timely make necessary amendments to the following campaign treasurer reports, as alleged in the complaint:

- 2018 P5
- 2018 G5
- 2018 G7

**Section 106.07(5), Florida Statutes**: Respondent, a 2018 candidate for State Representative, District 105, may have certified one or more campaign treasurer reports were true, correct, and complete when they were not, as alleged in the complaint.

**Section 106.19(1)(b), Florida Statutes:** Respondent, a 2018 candidate for State Representative, District 105, may have failed to report one or more contributions required to be reported by Chapter 106, Florida Statutes, as alleged in the complaint.
