Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

If you are the Respondent, you may attend the hearing, and you or your attorney will have 5 minutes to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have 5 *minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, he must provide the Commission with written proof of his financial resources at the hearing. A financial affidavit form is available from the Commission Clerk.

SUMMARY: Florida Acre is a political committee (PC) registered with the State of Florida. The PC's chair is Jeff Brewington and its treasurer is William B. Willingham.

The PC is appealing the fine claiming that unusual circumstances existed that caused the 2016 D4 Report to be untimely filed. According to Mr. Willingham, "The unusual circumstance must occur within a time period that would clearly prevent the person responsible for filing the report from doing so in a timely manner. This is exactly the scenario here and the failure to act was merely a timing issue. Florida ACRE had no knowledge of, or control over, the ACH delivery of the \$13,313.81 contribution until the bank statement was received on November 4. The Action Committee for Rural Electrification usually sends ACH contributions to Florida ACRE three times a year and advises Florida ACRE that day that a contribution has been made via an email message. However, Florida ACRE did not receive an email notification of the October 31 contribution. Florida ACRE immediately rectified the situation upon becoming aware of the contribution through the bank reconciliation".

- The 2016 D4 Report covers the time period of 10/31/16.
- The 2016 D4 Queued-Transactions Report reflects that this report was created on 10/31/16 at approximately 4:28 pm, before being filed on 10/31/16 at approximately 4:28 pm.²
- In a 1/17/17 email with Kristi Reid-Bronson, FEC staff was informed, "The committee filed a notice of no activity (waiver) on 10/31/16. A waiver is not a report. On 11/4/16, the committee filed a report showing \$13,313.81 of activity. The fine is based on the report being filed 3 days late".

Please accept for filing, **Conda ACRE's Notice** of Appeal of a fine imposed by the Florida Division of Elections under Section 106.07(8), Florida Statutes. Pursuant to Rule 2B-1.005, F.A.C., and Rule 2B-1.0055, F.A.C., Florida ACRE submits the following in support of the repeal of **the \$130.00** late fine for the report due on November 1, which was timely filed on October 31. Due to an unusual circumstance over which Florida ACRE had no control, we were required to file an amended report as soon as we discovered that funds had been deposited into our account without our knowledge on October 31:

Background and Facts

On October 31, 2016 in accordance with Section 106.07(1), Florida Statutes, Florida ACRE (60473-PAC) electronically submitted Report 2016-D4-86 ("Report") to the Division of Elections. The coverage period for the Report was 10/31/2016 - 10/31/2016 and the report was due on 11/1/2016. On these dates, Florida ACRE was unaware of any contributions or expenditures to report, therefore, the Report was filed as a waiver and the "Waiver" box on the Report was checked accordingly. All amounts on the filed Report were zero. On November 4, 2016 Florida ACRE received a bank statement from the Florida Rural Electric Credit Union. During reconciliation of the bank statement, Florida ACRE learned that on October 31, 2016 an ACH contribution in the amount of \$13,313.81 was directly deposited from the Action Committee for Rural Electrification, which is located in Arlington, Virginia. In order to accurately reflect this contribution, on November 4, 2016, Florida ACRE immediately filed an amended 2016-D4-86 report showing the amount contributed by the Action Committee for Rural Electrification to Florida ACRE. On December 9, 2016, Florida ACRE received a letter from the Florida Department of State, Division of Elections, assessing a late fine of \$150.00 because the treasurer's report that was due on November 1, 2016, allegedly was filed on November 4, 2016. Florida ACRE has attached the relevant documents to this Notice of Appeal to assist in resolving this matter.

There were Unusual Circumstances that Justify a Waiver of the Fine

Rule 2B-1.0055, F.A.C., allows political committees to file late or amended reports if unusual circumstances occur. Under section 2B-1.0055(1): "Unusual circumstances mean uncommon, rare or sudden events **over which the actor has**

no control and which directly result in the failure to act..." (Emphasis added). The unusual circumstance must occur within a time period that would clearly prevent the person responsible for filing the report from doing so in a timely manner. This is exactly the scenario here and the failure to act was merely a timing issue. Florida ACRE had no knowledge of, or control over, the ACH delivery of the \$13,313.81 contribution until the bank statement was received on November 4. The Action Committee for Rural Electrification usually sends ACH contributions to Florida ACRE three times a year and advises Florida ACRE that day that a contribution has been made via an email message. However, Florida ACRE did not receive an email notification of the October 31 contribution. Florida ACRE immediately rectified the situation upon becoming aware of the contribution through the bank reconciliation.

Pursuant to Section 106.07(8)(c), Florida Statutes, the Florida Elections Commission ("Commission") must consider the mitigating and aggravating circumstances enumerated in Section 106.265(2), Florida Statutes when determining the amount of a fine, if any, to be waived. Also, pursuant to Section 106.265 (2), Florida Statutes, the Commission must consider the gravity of the act or omission and whether the political committee has shown good faith in attempting to comply with Chapter 106, Florida Statutes when assessing fines. Under the facts given above, Florida ACRE believes it acted expeditiously and in good faith. Upon discovering the \$13,313.81 contribution from the Action Committee for Rural Electrification, an amended report was immediately filed, just 3 days after the original due date. The gravity of the delayed omission of this contribution in the original filing was unintentional and unplanned and Florida ACRE believes that no harm, impairment or damage was caused by filing the newly discovered contribution. For most reporting periods Florida ACRE files

monthly reports with a 10-day grace period that provides an opportunity to review the monthly credit union statement to check for ACH deposits made by the Action Committee for Rural Electrification before filing the report. However, for daily and weekly reporting periods this option is not available. However, for future non-monthly reporting periods Florida ACRE will check with the credit union to verify whether any third party deposits have been made to our account for the reporting period to ensure compliance with the reporting requirements.

Florida ACRE believes we have demonstrated that the report was timely filed given the unusual circumstances beyond our control that caused the report to be amended after the filing date, and that a waiver of the fine is justified. We are available to discuss this issue or possibly provide further information if that would be helpful.


