She requests that the fine be waived due to these circumstances.

- The 2020 PTR Report shows that it was filed on 11/22/20.
- Sky White reported receiving 2 contributions while making 35 expenditures.

I would like to move forward with filing an appeal on the late report filing amount of \$1,192.92. I received notification of the imposed fine on November 23, 2020 by the Hillsborough County Supervisor of Elections (see attached). At this time, I am unable to pay the fine due to an unexpected financial hardship directly related to COVID-19. On August 3rd, 2020, I was relieved from my job due to the fact that I worked in a call center setting that was no longer able to accommodate social distancing guidelines. As a result of this job loss, I was placed in a financial hardship requiring deferment of many of my financial obligations and was unable to find steady employment until November 2020. However, this employment is only part time at the moment with anticipation of a possible second shut down.

I ask that you please consider these unusual and unexpected circumstances in your final decision regarding my appeals request with hopes of being able to waive the imposed fee. Please feel free to contact me with any further questions.

Your campaign treasurer's PTR report, which was due on November 16, 2020, was not received as of midnight on the due date.

Florida Statute 106.07 states any candidate failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first three days late and, thereafter, \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding the primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report. All fines must be paid from the candidate's personal funds – not campaign funds.

The Amount of your fine is \$1,192.94 based on your report having been six days late. Fines must be paid to the filing officer within 20 days of receipt of the payment due notice.

Section 106.265(1), Florida Statues, authorizes the Florida Elections Commission to impose a civil penalty up to \$1,000 per count for each willful violation of Chapter 106.

Section 106.07(8)(c), Florida Statues, states that in the case of an unusual circumstance surrounding the failure to file on the designated due date, each candidate or committee will have the option to file an appeal with the Florida Elections Commission. It is the responsibility of the candidate or committee to notify the filing officer in writing of his or her intention to submit an appeal. Any such requests shall be made within 20 days after receiving the notice of payment due.

Your campaign treasurer's PTR report, which was due on November 16, 2020, has not been received.

Florida Statute 106.07 states any candidate failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first three days late and, thereafter, \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding the primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report. All fines must be paid from the candidate's personal funds - not campaign funds.

Once your report is filed, our office will notify you of the specific amount of your fine. Fines must be paid to the filing officer within 20 days of receipt of the payment due notice.

Please be advised, however, that failure to file a campaign treasurer's report may constitute a violation of Chapter 106, Florida Statutes, independent of the automatic fine violation referenced above. Therefore, if you fail to file a report, the division will turn the matter over to the Florida Elections Commission.

Section 106.265(1), Florida Statues, authorizes the Florida Elections Commission to impose a civil penalty up to \$1,000 per count for each willful violation of Chapter 106.

Section 106.07(8)(c), Florida Statues, states that in the case of an unusual circumstance surrounding the failure to file on the designated due date, each candidate or committee will have the option to file an appeal with the Florida Elections Commission. It is the responsibility of the candidate or committee to notify the filing officer in writing of his or her intention to submit an appeal. Any such requests shall be made within 20 days after receiving the notice of payment due.
