**SUMMARY:** Branch Banking and Trust Company is a political committee (PC) registered with the State of Florida. The PC's chair is Christopher L. Henson and its treasurer is James Anthos.

The PC is appealing the fine claiming that they initially thought that the PAC had no activity during the reporting period and filed a waiver on September 10<sup>th</sup>. According to James Anthos, on September 19<sup>th</sup>, they realized that they had received two contributions to the PAC during the reporting period and immediately filed an amendment to the report. They have provided a copy of the EFS generated filed receipts for the original waiver and the amended report.

Dear Mr. Henson:

The Florida Elections Commission received a letter from James R. Anthos appealing the fine assessed against your committee for failing to timely file a required report. However, Section 106.07(8)(c), Florida Statutes, provide that only a *candidate or the chairman* of a political committee, may appeal a fine assessed by a filing officer for the late filing of a campaign treasurer's report.

Therefore, to preserve your right to appeal the fine, the Commission must receive a written statement signed by you indicating that the person signing the letter was representing you when the appeal was filed.
