ORDER OF PROBABLE CAUSE

THIS MATTER was heard by the Florida Elections Commission ("Commission") at its regularly scheduled meeting on May 25, 2021, in Tallahassee, Florida.

On March 29, 2021, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff's Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation(s):

Count 1:

On or about May 10, 2018, Henry Choice violated Section 106.07(7), Florida Statutes, when he failed to notify the filing officer in writing on the prescribed reporting date that he would not be filing a 2018 M4 Report.

Count 2:

On or about June 11, 2018, Henry Choice violated Section 106.07(7), Florida Statutes, when he failed to notify the filing officer

in writing on the prescribed reporting date that he would not be filing a 2018 M5 Report.

Count 3:

On or about June 29, 2018, Henry Choice violated Section 106.07(7), Florida Statutes, when he failed to notify the filing officer in writing on the prescribed reporting date that he would not be filing a 2018 P1 Report.

Count 4:

On or about July 6, 2018, Henry Choice violated Section 106.07(7), Florida Statutes, when he failed to notify the filing officer in writing on the prescribed reporting date that he would not be filing a 2018 P1A Report.

Count 5:

On or about July 13, 2018, Henry Choice violated Section 106.07(7), Florida Statutes, when he failed to notify the filing officer in writing on the prescribed reporting date that he would not be filing a 2018 P2 Report.

Count 6:

On or about July 20, 2018, Henry Choice violated Section 106.07(7), Florida Statutes, when he failed to notify the filing officer in writing on the prescribed reporting date that he would not be filing a 2018 P2A Report.

<u>Count 7:</u>

On or about July 27, 2018, Henry Choice violated Section 106.07(7), Florida Statutes, when he failed to notify the filing officer in writing on the prescribed reporting date that he would not be filing a 2018 P3 Report.

<u>Count 8:</u>

On or about August 3, 2018, Henry Choice violated Section 106.07(7), Florida Statutes, when he failed to notify the filing officer in writing on the prescribed reporting date that he would not be filing a 2018 P4 Report.

Count 9:

On or about August 10, 2018, Henry Choice violated Section 106.07(7), Florida Statutes, when he failed to notify the filing officer in writing on the prescribed reporting date that he would not be filing a 2018 P5 Report.

The Commission finds that there is no probable cause to charge Respondent with violating

Section 106.19(1)(c), Florida Statutes.

NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by <u>consent order</u> where you and Commission staff agree to resolve the violation(s) and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an <u>informal hearing</u> held before the Commission, if you <u>do not</u> dispute any material fact in the Staff Recommendation. You have thirty (30) days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to make written or oral arguments to the Commission concerning the legal issues related to the violation(s) and the potential fine. At the request of Respondent, the Commission will consider and determine willfulness at an informal hearing. Otherwise, live witness testimony is unnecessary.

STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the complaint in this case recommending that there is **probable cause** to charge Respondent with violating **Section 106.07(7)**, **Florida Statutes**, and **no probable cause** to charge Respondent with violating **Section 106.19(1)(c)**, **Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on February 15, 2021, the following facts and law support this staff recommendation.

1. On September 21, 2018, the Florida Elections Commission ("Commission") received a referral from the Division of Elections ("Division") alleging Henry Choice ("Respondent") violated Chapter 106, Florida Statutes.

2. Respondent was a candidate for Governor in the 2018 election. (ROI Exhibit 1, page 5; Attachment A)¹ Respondent's initial Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates form ("DS-DE 9") was filed with the Division on April 27, 2018. (ROI Exhibit 2, page 2) Respondent filed a second DS-DE 9 with the Division on June 18, 2018. (ROI Exhibit 2, page 1) Respondent was eliminated as a candidate because he failed to have a running mate designated and qualified by September 6, 2018. (ROI Exhibit 1, pages 1 and 2)

3. By letter dated January 16, 2019, the Executive Director notified Respondent that Commission staff would investigate the following alleged violations:

Section 106.07(7), Florida Statutes: As alleged in the complaint, Respondent, a 2018 candidate for the office of Governor, failed to notify the filing officer on the prescribed reporting date that no report would be filed on that date because he had not received funds, made contributions, or expended reportable funds during thefollowing reporting periods:

- 2018 M4
- 2018 M5
- 2018 P1

- 2018 P1A
- 2018 P2
- 2018 P2A
- 2018 P3
- 2018 P4
- 2018 P5

Section 106.19(1)(c), Florida Statutes: As alleged in the complaint, Respondent, a 2018 candidate for the office of Governor, may have falsely reported or deliberately failed to include information required by Chapter 106, Florida Statutes, during the following reporting periods:

- 2018 M4
- 2018 M5
- 2018 P1
- 2018 P1A
- 2018 P2
- 2018 P2A
- 2018 P3
- 2018 P4
- 2018 P5

4. By two letters dated May 3, 2018, Kristi Reid Bronson, Chief, Bureau of Election Records, Division of Elections, notified Respondent that his name had been placed on the 2018 active candidate list.² The letters advised Respondent that all candidates who file reports with the Division are required to use the Division's Electronic Filing System ("EFS") and provided Respondent with a user identification number and initial password to access the EFS. (ROI Exhibit 4, page 1 and 3)³

5. Ms. Bronson's May 3, 2018 letters further advised Respondent that all the Division's publications and reporting forms were available on the Division's website and it was Respondent's responsibility to read, understand, and follow the requirements of Florida's Election Laws. Ms. Bronson's letters also directed Respondent to print a copy of Chapters 104 and 106, Florida Statutes, the *Candidate and Campaign Treasurer Handbook* ("Handbook") and the *Calendar of Reporting Dates*. (ROI Exhibit 4, pages 2 and 4)

³ One of Ms. Bronson's May 3, 2018 letters informed Respondent his first campaign report was the 2018 M4 Report and it was due on May 10, 2018. Ms. Bronson's second May 3, 2018 letter informed Respondent his first campaign report was the 2018 M5 Report and it was due on June 11, 2018. (ROI Exhibit 4) Because Respondent became a candidate on April 27, 2018, Respondent was required to file a 2018 M4 Report on or before May 10, 2018. (ROI Exhibit 2, page 2; Exhibit 9, page 3)

6. Section 106.07(7), Florida Statutes, provides:

Notwithstanding any other provisions of this chapter, in any reporting period during which a candidate or political committee has not received funds, made any contributions, or expended any reportable funds, the filing of the required report for that period is waived. However, the next report filed must specify that the report covers the entire period between the last submitted report and the report being filed, and any candidate or political committee not reporting by virtue of this subsection on dates prescribed elsewhere in this chapter **shall notify the filing officer in writing on the prescribed reporting date that no report is being filed on that date.** (Emphasis added)

7. Respondent failed to file a 2018 M4, 2018 M5, 2018 P1, 2018 P1A, 2018 P2, 2018 P2A, 2018 P3, 2018 P4 and 2018 P5 Report or a notice of no activity for the 2018 M4, 2018 M5, 2018 P1, 2018 P1A, 2018 P2, 2018 P2A, 2018 P3, 2018 P4, and 2018 P5 reporting periods on or before the prescribed due dates. (Attachments A and B)

8. The Division notified Respondent by letter on more than one occasion that Respondent had not filed his 2018 M4, 2018 M5, 2018 P1, 2018 P1A, 2018 P2, 2018 P2A, 2018 P3, 2018 P4, and 2018 P5 Reports or a notice of no activity for the applicable reporting periods. (ROI Exhibit 5; ROI Exhibit 6, page 1; ROI Exhibit 7, page 1; ROI Exhibit 8, pages 1 through 7)

9. As of March 25, 2021, Respondent has not filed a notice of no activity for the 2018 M4, 2018 M5, 2018 P1, 2018 P1A, 2018 P2, 2018 P2A, 2018 P3, 2018 P4, and 2018 P5 reporting periods . (Attachment B)

10. Investigator Hinson subpoenaed copies of Respondent's campaign bank account records from Wells Fargo Bank. In response to the subpoena, Wells Fargo Bank sent a "Business Records Declaration" stating it was, "Unable to locate any records for Henry James Choice in the time scope of April 2018 – December 2018." (ROI Exhibit 10) Because Respondent did not have a campaign account during the reporting periods at issue, it appears Respondent did not have any financial transactions during the 2018 M4, 2018 M5, 2018 P1, 2018 P1A, 2018 P2, 2018 P2A, 2018 P3, 2018 P4, and 2018 P5 reporting periods and should have filed notices of no activity.⁴

11. On December 18, 2020, Investigator Hinson attempted to contact Respondent by telephone two times at the phone number on Respondent's DS-DE 9s. When Investigator Hinson attempted to call Respondent the first time, she reached a recorded message that stated, "The wireless customer you are calling is not available; please try again later." (ROI Exhibit 11, Phone Log Entries 9 and 10)

12. When Investigator Hinson called Respondent the second time on December 18, 2020, at the phone number Respondent listed on his DS-DE 9s, Investigator Hinson reached a recorded message that stated, "The wireless customer you are calling is not available; please try again later." (ROI Exhibit 11, Phone Log Entry 10)

13. On December 22, 2020, Investigator Hinson attempted to contact Respondent at the phone number listed on his DS-DE 9s. Investigator Hinson reached a recorded message that stated, "The wireless customer you are calling is not available; please try again later." (ROI Exhibit 11, Phone Log Entry 11)

14. "Probable Cause" is defined as a reasonable ground of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So.2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So.2d 305, 309 (Fla. 1st DCA 1995).

15. The above facts show that Respondent was a candidate for Governor in the 2018 election. Respondent failed to timely file his 2018 M4, 2018 M5, 2018 P1, 2018 P1A, 2018 P2, 2018 P2A, 2018 P3, 2018 P4, and 2018 P5 Reports or a notice of no activity for the corresponding reporting periods, whichever was applicable.

16. The above facts also show that between April 27, 2018 and August 3, 2018, Respondent did not have a campaign account. Therefore, it appears Respondent had no reportable financial activity and should have filed a notice of no activity for each of the reporting periods, which he failed to do.

Based on the foregoing, I recommend the Commission find probable cause to charge Respondent with the following violations:

Count 1:

On or about May 10, 2018, Respondent violated Section 106.07(7), Florida Statutes, when Respondent failed to notify the filing officer in writing on or before May 10, 2018, that Respondent would not be filing a 2018 M4 Report on the prescribed due date.

Count 2:

On or about June 11, 2018, Respondent violated Section 106.07(7), Florida Statutes, when Respondent failed to notify the filing officer in writing on or before June 11, 2018, that Respondent would not be filing a 2018 M5 Report on the prescribed due date.

Count 3:

On or about June 29, 2018, Respondent violated Section 106.07(7), Florida Statutes, when Respondent failed to notify the filing officer in writing on or before June 29, 2018, that Respondent would not be filing a 2018 P1 Report on the prescribed due date.

Count 4:

On or about July 6, 2018, Respondent violated Section 106.07(7), Florida Statutes, when Respondent failed to notify the filing officer in writing on or before July 6, 2018, that Respondent would not be filing a 2018 P1A Report on the prescribed due date.

Count 5:

On or about July 13, 2018, Respondent violated Section 106.07(7), Florida Statutes, when Respondent failed to notify the filing officer in writing on or before July 13, 2018, that Respondent would not be filing a 2018 P2 Report on the prescribed due date.

Count 6:

On or about July 20, 2018, Respondent violated Section 106.07(7), Florida Statutes, when Respondent failed to notify the filing officer in writing on or before July 20, 2018, that Respondent would not be filing a 2018 P2A Report on the prescribed due date.

Count 7:

On or about July 27, 2018, Respondent violated Section 106.07(7), Florida Statutes, when Respondent failed to notify the filing officer in writing on or before July 27, 2018, that Respondent would not be filing a 2018 P3 Report on the prescribed due date.

Count 8:

On or about August 3, 2018, Respondent violated Section 106.07(7), Florida Statutes, when Respondent failed to notify the filing officer in writing on or before August 3, 2018, that Respondent would not be filing a 2018 P4 Report on the prescribed due date.

Count 9:

On or about August 10, 2018, Respondent violated Section 106.07(7), Florida Statutes, when Respondent failed to notify the filing officer in writing on or before August 10, 2018, that Respondent would not be filing a 2018 P5 Report on the prescribed due date.

I further recommend the Commission find no probable cause to charge Respondent with violating Section 106.19(1)(c), Florida Statutes.

- 10. On July 10, 2018, the Division mailed Mr. Choice notification that the 2018 M5 treasurer's report had not been filed.
- On July 26, 2018, the Division mailed Mr. Choice final notification with delivery confirmation that the 2018 M5 treasurer's report had not been filed. (See attached letter and delivery confirmation.)

1. Respondent was a 2018 write-in candidate for Governor of Florida.¹ He was a first-time candidate. Respondent was required to have a Lt. Governor running mate designated and qualified by September 6, 2018. However, he failed to do so, and his name was removed from the active candidate list by the filing officer. To review the filing officer's memorandum dated September 10, 2018 and related emails, refer to Exhibit 1.

2. An Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 9) was filed on April 27, 2018. Respondent appointed himself as campaign treasurer. To review the DS-DE 9, refer to Exhibit 2.²

3. Respondent filed a Statement of Candidate with the Division on April 27, 2018 in which he certified he had been provided access to read and understand Chapter 106, F.S. To review a copy of the Statement of Candidate, refer to Exhibit 3.

4. Two acknowledgement letters were mailed to the address provided on the DS-DE 9 on May 3, 2018 advising Respondent that all candidates filing reports with the Division are required to file by means of the Division's electronic filing system (EFS). Respondent was provided with a user identification number and initial password allowing him access to the EFS.

5. The acknowledgement letters also advised Respondent that all the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Candidate & Campaign Treasurer Handbook* and the *Calendar of Reporting Dates*. The letters further advised Respondent that it was his responsibility to read, understand, and follow the requirements of Florida's election laws. To review the acknowledgement letters, refer to Exhibit 4.

¹ Respondent is a resident of Bainbridge, Georgia.

² Respondent filed a second DS-DE 9 on June 18, 2018, changing his designation from NPA to write-in.

6. The Division sent correspondence to Respondent notifying Respondent that he had not filed either a campaign report or notification that no reportable activity occurred for the following reporting period(s): 2018 M4, M5, P1, P1A, P2, P2A, P3, P4, and P5. The letter(s) included reference to the filing date(s) for the report(s). The correspondence was mailed to Respondent at the address provided on the DS-DE 9. To review the failure to file correspondence, refer to Exhibit 5.

7. On July 26, 2018, the Division sent Respondent a letter marked "Final Notice" with delivery confirmation stating that the following campaign report(s), or the required notification that no reportable activity occurred, had not been filed: 2018 M4. The letter was mailed to Respondent at the address provided on the DS-DE 9, and it was confirmed delivered on July 27, 2018. To review the letter marked "Final Notice" and delivery confirmation, refer to Exhibit 6.

8. On July 26, 2018, the Division sent Respondent a letter marked "Final Notice" with delivery confirmation stating that the following campaign report(s), or the required notification that no reportable activity occurred, had not been filed: 2018 M5. The letter was mailed to Respondent at the address provided on the DS-DE 9, and it was confirmed delivered on July 27, 2018. To review the letter marked "Final Notice" and delivery confirmation, refer to Exhibit 7.

9. On August 14, 2018, the Division sent Respondent multiple letters marked "Final Notice" with delivery confirmation in a single envelope stating that the following campaign report(s), or the required notification that no reportable activity occurred, had not been filed: 2018 P1, P1A, P2, P2A, P3, P4, and P5. The envelope was mailed to Respondent at the address provided on the DS-DE 9, and it was confirmed delivered on August 17, 2018. To review the letters marked "Final Notice" and delivery confirmation, refer to Exhibit 8.

II. Alleged Violation of Sections 106.07(7), and 106.19(1)(c), Florida Statutes:

9. I investigated whether Respondent violated these sections of the election laws either by not notifying the filing officer, in writing, that no report would be filed due to not receiving any contributions or making expenditures during the following reporting period(s) or by not filing campaign report(s) to reflect financial activity for the reporting period(s). To review a copy of Respondent's filing history and related documents, refer to Exhibit 9.

Candidates who are unopposed or eliminated after the 2018 primary election must dispose of all funds on deposit in the campaign account pursuant to the provisions of Section 106.141, Florida Statutes, within 90 days of the primary election. Therefore, your termination report (TR) must be filed using the Electronic Filing System (EFS) no later than **December 5, 2018** You are not required to close the campaign account prior to the due date; however, you must have written checks disposing of all surplus funds in the account by this date.

You may file your report at any time prior to the deadline once you have disposed of all funds. In order to file your termination report prior to December 5, 2018, you will need to change the cover period, which has been defaulted to an ending period of December 5, 2018, in the EFS (see attached example).

Before disposing of surplus funds, if you submitted petitions to a supervisor of elections and did not pay to have signatures verified because you filed an undue burden oath, you must reimburse the county for verifying the signatures pursuant to Section 106.141(7), Florida Statutes. Please contact any supervisor of elections that verified signatures for your campaign to determine the amount that must be reimbursed.
