**FINAL ORDER**

**THIS MATTER** was heard at an informal hearing held before the Florida Elections Commission (Commission) on May 20, 2015.

**STATEMENT OF THE ISSUE**

Whether Respondent violated Section 106.141(1), Florida Statutes, as alleged in the Commission's November 21, 2014 Order of Probable Cause.

**PRELIMINARY STATEMENT**

On July 16, 2013, the Commission received a referral from the Division of Elections

(Division) alleging a violation of Florida's election laws. Staff of the Commission conducted an investigation to determine whether the facts alleged in the complaint constituted probable cause to believe that Respondent violated the Florida Election Code.

On April 17, 2014, staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. On November 21, 2014, the Commission entered an Order of Probable Cause finding that there was probable cause to charge Respondent with the following violation:

**Count 1:**

On or about February 4, 2013, Respondent violated Section 106.141(1), Florida Statutes, by failing to file timely a report reflecting the disposition of all remaining funds in his campaign account within 90 days after he withdrew, became unopposed, was eliminated, or elected

Respondent did not timely elect to have a formal administrative hearing before an administrative law judge from the Division of Administrative Hearings and, therefore, the matter was set for an informal hearing before the Commission. At the informal hearing, the Commission adopted the undisputed facts set forth in the Staff's Recommendation as its findings of fact.

**FINDINGS OF FACT**

1. Respondent was a candidate for State Representative, District 102, in the 2012 election.
2. On November 9, 2012, Kristi Reid Bronson, Chief, Division of Elections, Bureau of Election Records sent Respondent a memorandum informing Respondent that his Termination Report (TR) was due by February 4, 2013. Respondent failed to file his TR by February 4, 2013.
3. Respondent's actions were willful. Respondent knew or should have known that

his TR was due by February 4, 2013, but he failed to file his TR.

### CONCLUSIONS OF LAW

4. The Commission has jurisdiction over the parties to and subject matter of this cause, pursuant to Section 106 26, Florida Statutes.

5. Respondent's conduct was willful. Respondent committed the act while knowing that, or showing reckless disregard for whether, the act was prohibited, or failed to perform the act while knowing that, or showing reckless disregard for whether, the act was required.

6. Respondent committed 1 count of violating Section 106.141(1), Florida Statutes, when he failed to file his TR by February 4, 2013,

7. In determining the amount of the civil penalty, the Commission considered the mitigating and aggravating circumstances set forth in Section 106 265, Florida Statutes.


### ORDER

8. The Commission finds that Respondent has violated Section 106 141(1), Florida Statutes, on 1 occasion and imposes a fine of \$500 for the violation.

Therefore it is

**ORDERED** that Respondent shall remit a civil penalty in the amount of \$500, inclusive of fees and costs. The civil penalty shall be paid to the Florida Elections Commission, Collins Building, Suite 224, 107 West Gaines Street, Tallahassee, Florida 32399, within 30 days of the date this Final Order is filed with the Commission and must be paid by money order, cashier's check or attorney trust account check.

**NOTICE OF RIGHT TO APPEAL**

This order is final agency action. Any party who is adversely affected by this order has the right to seek judicial review pursuant to Section 120.68, Florida Statutes, by filing a notice of administrative appeal pursuant to Rule 9.110, Florida Rules of Appellate Procedure, with the Clerk of the Florida Elections Commission at 107 West Gaines Street, Suite 224, Collins Building, Tallahassee, Florida 32399-1050 and by filing a copy of the notice of appeal with the appropriate district court of appeal. The party must attach to the notice of appeal a copy of this order and include with the notice of appeal filed with the district court of appeal the applicable filing fees. **The notice of administrative appeal must be filed within 30 days of the date this order is filed with the Commission.** The date this order was filed appears in the upper right-hand corner of the first page of the order.
