- The Division of Elections has one note entry from 03/18/16 that pertains to Mr. Byrd's 2016 M2 report.

Dear Commissioners,

The following recitation of facts, argument and attachments are submitted for your review in my appeal of the fine imposed pursuant to F.S. §106.07. The appeal and this submission are made pursuant to Rule 2B-1.005.

FACTS:

- 1. I am the Candidate for office and also the campaign Treasurer. I am the only person with the passwords to login to the filing system.
- 2. For the thirteen months preceding the month in question, all campaign treasurer reports were timely filed.
- 3. On March 10, 2016, I logged in to the campaign filing system, personally completed the contribution/expenditure report and filed the report.
- 4. On March 17, 2016, I received a letter from the Division of Elections dated March 11, 2016 alleging that the March report had not been received. (March 11, 2016 letter attached as Exhibit A)
- 5. Although the letter from the Division is dated March 11, 2016, the postmark on the letter is March 15, 2016 evidencing that the Division did not mail the letter until four days after it was drafted. (Photocopy of the envelope with postmark attached as Exhibit B)
- 6. On the morning of March 18, 2016 I telephoned the help desk listed in the March 11, 2016 letter to enquire as to the alleged late filing.

- 7. When I called on March 18th, I spoke to Malcolm.
- 8. During my conversation with Malcom he confirmed that I logged in to the filing system on March 10, 2016.
- 9. During my conversation with Malcom he confirmed that the thirteen previous reports had been timely filed.
- 10. During my conversation with Malcolm I explained that I had experienced some anomalies when I filed on March 10, 2016, including some information being pre-filled.
- 11. During my conversation with Malcolm he instructed me to login to the system and re-file the report.
- 12. The report was re-filed while on the phone conversation with Malcolm and he was able to confirm receipt of the re-filed report, filed at 9:14:58 AM. (A Copy of the filed report receipt is attached as Exhibit C)
- 13. Malcom indicated that he made notes of our entire conversation for the record.

ARGUMENT:

A. A Fine Should Not Be Imposed

As the candidate and treasurer, I am the only person who enters the information and files the treasurer reports. For the thirteen months preceding the 2016-M2-14 report all reports had been timely filed. One of the exceptions listed in Rule 2B-1.0055(e) constituting an unusual circumstance is, "Computer or equipment failure caused by events that could not have been anticipated and that made timely filing of the report impossible."

At the earliest possible time after receiving the notice of fine letter I called the Division and reported that I had logged in to the system and filed my report. I also explained that I experienced some unusual anomalies during the login on March 10, 2016. While Malcom

could not identify any computer problems on the Division's system, he was able to confirm that I had in fact logged in to the system on March 10, 2016. During my phone conversation with Malcolm I also re-filed the report.

My conversation with Malcolm was relatively brief, probably lasting less than five minutes. It would have been impossible for me to type in all of the information required for the filing during my phone conversation with him. As soon as he instructed me to re-file I was able to do so which evidences that all of the information was already in the system, which is confirmed by the fact that I logged in on March 10, 2016.

I am not a computer expert nor am I an internet connection expert. I do not know what happened between the login and filing of the report on March 10, 2016 and the receipt of the letter from the Division on March 17, 2016. It is without dispute that thirteen timely reports had previously been filed and that I logged in March 10, 2016.

In light of these undisputed facts, I contend that an unusual computer or equipment failure occurred by events that could not have been anticipated. As such, the imposed fine should be withdrawn.

B. The Fine Should Be Reduced

If the Commission does not believe that a fine should not be imposed due to unusual circumstances, then the fine should be reduced due to the Division of Elections failure to timely notify me of an issue with filing, causing the fine to be substantially higher than it could have been.

The statutory fine for filing up to three days late is \$50.00. If the untimely filing is more than three days late the fine imposed is \$500.00 or 25% of the total receipt or expenditures whichever is greater.

The letter from the Division notifying me that there was a problem with the March

report is dated March 11, 2016. The postmark on the envelope containing the March 11,

2016 letter is March 15, 2016. This means that the Division did not notify me timely of any

issues with the March report until after the three-day period for a \$50.00 fine had already

passed making it impossible for me or any candidate to correct any alleged deficiencies

and avoid a higher fine.

I received the letter postmarked on March 15th, on the afternoon of March 17th

which means the letter travelled from Tallahassee to Neptune Beach within two days. Had

the Division not delayed in mailing the letter by four days I would have received it within

two days affording me the opportunity to correct any issues within the three-day initial fine

period. The untimely mailing caused the fine to increase by \$643.75.

Pursuant to Rule 2B-1.0055(g) the lack of timely notice clearly interfered with the

timely filing of the report resulting in an unnecessary and unfair increase in the fine

imposed.

CONCLUSION:

Based upon the foregoing facts and argument the imposed fined should be waived or in the

alternative reduced to \$50.00.

Our records indicate that you have not filed either your campaign treasurer's report or notification that no reportable activity occurred, whichever is applicable. The filing date was March 10, 2016.

The law (s. 106.07(8)(b), Fla. Stat.) requires the filing officer to immediately notify you about the missed filing date and the automatic fines that will be assessed for late filing of a report, if a report was due.

- If reportable activity occurred and you have not filed a report, statutory fines are automatically assessed as follows until you file your report:
 - \$50 for the first 3 days late
 - \$500 per day for each day after the 3rd day late
 - If the required report immediately precedes a primary and general election, the automatic fine is \$500 for each late day.

The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period. Even if you end up filing your report late, we cannot waive the statutory fines. We will notify you of the specific amount of fines owed once you file your report. You have 20 days from the day you receive the notice to pay the fine or to appeal the fine to the Florida Elections Commission.

 If no reportable activity occurred for the report date(s), you are still required to notify us in writing, via the Division's Electronic Filing System, that no reportable activity occurred. No automatic fines are statutorily assessed.

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.

The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period. Even if you end up filing your report late, we cannot waive the statutory fines. We will notify you of the specific amount of fines owed once you file your report. You have 20 days from the day you receive the notice to pay the fine or to appeal the fine to the Florida Elections Commission.

 If no reportable activity occurred for the report date(s), you are still required to notify us in writing, via the Division's Electronic Filing System, that no reportable activity occurred. No automatic fines are statutorily assessed.

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.

In the event that the EFS is inoperable on the due date, the report will be accepted as timely filed if filed no later than midnight of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any candidate failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first 3 days late and, thereafter, \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for reports immediately preceding each primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the candidate and campaign treasurer and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.
