FINAL ORDER ON REMAND

THIS CAUSE came before the Florida Elections Commission (Commission) on August 18, 2006, for the purpose of vacating the Final Order filed in this matter on March 7, 2005, and entering a new order consistent with the decision of the Second District Court of Appeal and its mandate issued on July 17, 2006.

Pursuant to the Second District Court of Appeal's opinion and mandate in the matter of *James Jennings v. Florida Elections Commission*, Case No. 2D05-1750, June 30, 2006, the Commission hereby vacates the Final Order filed in this matter on March 7, 2005, accepts all the factual and legal findings set forth in the ALJ's Recommended Order entered on September 24, 2004, dismisses counts 27 through 56 set forth in the Order of Probable Cause, and finds Respondent guilty of violating counts 1 through 26 set forth in the Order of Probable Cause.

WHEREFORE, IT IS HEREBY ORDERED AND ADJUDGED that in the matter of *Florida Elections Commission* v. *James Jennings*, FEC

Case No. 03-160, the Commission hereby imposes a fine of \$200.00 for each of counts 3 through 26, \$1,000.00 for count 1, and \$500.00 for count 2 for a total fine of \$6,300.00. Counts 27 through 56 are hereby **DISMISSED**.

This Final Order shall take effect upon filing with the Clerk for the Florida Election Commission. The total fine of \$6,300 shall be due and owing within 30 days of entry of this order.
