SUMMARY: Good Government Foundation PAC is a political committee (PC) registered with the State of Florida. The PC's chair and treasurer is Jaime Parlade. Attorney Javier Banos Machado, Esquire is representing the PC in this matter.

The PC is appealing the fine claiming that all contribution entries were submitted on February 04, 2020 and that the only thing missing was the failure to submit the report before February 10th. He states that he is unsure if it was computer or human error.

According to Mr. Machado, they assumed the report was filed until they received notice from the filing officer. He states that the report was prepared along with four other reports/campaigns, one of which had password retrieval issues. Mr. Machado notes that the number of reports along with the password issues may have led to an inadvertent oversight. He states that once they received notice, they filed the report.

- The 2020 M01 Original Report covers the period from 01/01/20-01/31/20; it was due on 02/10/20.
- The 2020 M01 Transaction Report shows that it was created on 02/04/20 and filed on 02/18/20.
- Good Government Foundation PAC reported receiving 12 contributions, while making zero expenditures.
- The Supervisor of Elections office entered three notes on 02/18/20 that pertain to Good Government Foundation PAC's 2020 M01 report. Mr. Machado called regarding the report being submitted on 02/04/20 and was advised by staff that they would contact the vendor to check for entries. Upon review, it was discovered that entries were submitted on 02/04/20, however, the Pin numbers were not entered to complete the report.

COMES NOW, the Petitioner, GOOD GOVERNMENT FOUNDATION PAC, by and through his undersigned attorney, hereby files its Request for Appeal to fine totaling \$2,650.00 for failure to timely file the 20M01 Campaign Treasurer's Report Due on February 10, 2020.

The attached Exhibit "A," illustrates the time stamped electronic history of filings for this organization. There have been no prior fines in its short history, and all disclosures have complied with the requirements of the law.

Exhibit "A," further illustrates that all contributions entries were done on or about February 4, 2020 for the 20M01 reporting period, the only missing item was the failure to submit the report before February 10th, 2020. –(Report was submitted on February 18th, 2020 upon receipt of the letter from the department)

It is not entirely clear whether human error, or a computer issue may have led, to the error, but it is not the intention of the undersigned to make excuses, but to simply illustrate that there was no willful disregard for the law in this regard.

The preparer was thoroughly convinced that the report was timely submitted. The report was prepared along with the reports for 4 other entities or campaigns, none of which had any other penalties. However, one of those different reports without any entries had a password retrieval problem. It is quite possible that the number of reports combined with the password, may have simply confused the treasurer. It is very much human error in this regard.

The submission of the various reports at the same time, along with the one report with the password issue, may have led the treasurer to inadvertently assume

that any warnings pertaining to the failure to submit the report for the Petitioner was related to the report with the password issue (Miami First PAC).

Nonetheless, the penalty assessed, although statutory in its nature, it is also quite harsh for what a simple oversight especially when the report was ready for submission on February 4, 2020.

The Petitioner would respectfully request either a complete waiver of the penalty, or an abatement for the same to as low an amount as possible considering the situation at hand.

WHEREFORE, the undersigned hereby requests either a waiver of the penalty assessed or alternatively an abatement of the same, and if deem necessary of the Commission, a hearing for an opportunity to explain any concerns or questions the Commission may have.

Dear Mr. Parlade,

The 20M01 Campaign Treasurer's Report filed with our office was submitted on 2/18/2020 (#1200150). Since this report was not filed by the appropriate filing date, a fine is being assessed for each late day pursuant to Florida Statute 106.07(8)(b).

As such, fines are calculated at a rate of \$50.00 per day for the first 3 days and thereafter, \$500.00 per day for each late day. These fines are not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. Therefore, since the report was 8 days late, the fine is \$2,650.00, which is 3 days at \$50 per day and 5 days at \$500 per day. Said fine must be received by our office at 2700 NW 87th Avenue, Miami, FL 33172 within twenty (20) days of your receipt of this notice. The check should be made payable to Miami-Dade County.

Upon receipt of the report, the filing officer shall determine the amount of the fine which is due and shall notify the candidate or chair or registered agent of the political committee ..."

As such, I urge you to promptly respond to this matter to limit additional fines; and in accordance with Florida Statute 106.07(8)(d), we will be required to notify the Florida Elections Commission of your failure to file.

Miami-Dade County Elections Department Güidelínes to Successful Campaign Treasurer's Reports (Per Chapter 106, Florida Statutes)

Contributions

- Contributions entered must fall within the time period covered by the report.
- All Contributions must have complete itemized information including the date, name, complete address, contribution type, occupation (if over \$100) and dollar amount.
- Occupation needs to be specific. Do not use "Businessman/ woman, Business Owner, Salesman/woman, Sales," etc. Examples of acceptable occupations include Car Sales, Printing Shop Owner, Bank Manager, Attorney, etc.
- 4. There is no contribution limit to a political committee.
- The maximum cash contribution per election is \$50. A cashier's check is considered as cash.
- The contribution limit to a candidate is \$1,000 per election.
 For reporting purposes, a credit card, debit card, money order, or Paypal contribution is considered a check.
- Contributions collected via Paypal or a third-party vendor to collect contributions must be reported in full (transaction fees are not deducted from the contribution amount, but rather reflected as an expenditure).
- The person signing the check is the contributor, except for a company check that is a "Business" entity.
- In-kind contributions are subject to contribution limitations (\$1,000 per election, per contributor).
- Candidates cannot accept contributions from an Electioneering Communications Organization (ECO).

Expenditures

- Expenditures entered must fall within the time period covered by the report.
- All expenditures must have complete itemized information including the date, name, complete address, purpose of expenditure, and dollar amount.
- A reimbursement from the campaign account is allowable directly to an individual/organization that has incurred approved expenses on behalf of the campaign. The report must include the full name, full address, specific purpose, and amount of reimbursement.
- Campaign accounts may not provide a direct payment to the credit card of an individual/organization as a form of reimbursement.
- Poll workers should be paid with a campaign check and each poll worker paid should be itemized.
- Bank fees and fees assessed by Paypal or a third-party vendor to collect contributions must be reported as expenditures (not deducted from the contribution amount).
- ECOs are limited to electioneering communications and may not make contributions to candidates or political parties.

Petty Cash

- The Petty Cash Withdrawn limit is \$500 per calendar quarter prior to the end of qualifying. Thereafter, \$100 per week.
- It shall be spent only in amounts less than \$100 and only for office supplies, transportation expenses and other necessities.
- Petty Cash may not be used for time, space, or services from communications media.

- The Petty Cash Withdrawn must be reported in the period that it was withdrawn from the bank.
- The Petty Cash Spent must also be reported in the period that it was spent. Petty Cash Spent does not impact the Total Expenditures for the period, only when it is withdrawn.
- Petty Cash Withdrawn and Petty Cash Spent must equal at the end of the campaign.

Notices

- 1. You will be notified of any deficiencies or violations.
- Typical violations include late filing, fine due, and incomplete information on a campaign report.
- Following these guidelines will reduce notices sent to you and thus the number of amendment reports that will need to be filed.

Amending a Report

- To make any changes to a submitted report, click on the "amend" button of the Original Report to create an Amendment Report.
- In the Amendment Report, first click on the type of transaction to amend (i.e. "Enter Contributions", etc):
 - > To add new item, add a new sequence.
 - ➤ To amend existing item, click "Amend item from Orig Report" to view list of all items previously submitted. Click on desired sequence, enter edits, and click submit. This will display two transactions (one to "delete" original item and one to "add" new item).
 - > To delete existing Item, click "Amend Item from Orig Report", click on desired sequence, and just click submit. This will display two transactions (one to "delete" original item and one to "add" new item). Delete the "add" sequence, leaving only the "delete" sequence.

Fines

- Fines assessed to candidates must be paid from candidate's personal funds.
- Fines assessed to political parties, political action committees, electioneering communication organizations, and "independent expenditures over \$5,000" are to be paid from their campaign account.
- Fines must be paid to the filing officer within 20 days after receipt of the notice of payment due, unless an appeal is made to the Florida Elections Commission within 20 days after receipt of the notice of payment due.
- If fine was appealed to the Florida Elections Commission, and the fine is upheld, payment is due to the Elections Department as stated in the Final Order.
- 5. Reference Florida Statute 106.07(8)(b) for fine amounts.

Termination Report

- At the end of the campaign, or when closing out a political committee, the "Total Contributions to Date" and the "Total Expenditures to Date" on the Termination Report must equal; and, the campaign account must be closed.
- Prior to closing the campaign account, any remaining funds must be disposed of according to F.S. 106.141 (for candidates) and F.S. 106.03 (for political committees).


