ORDER OF PROBABLE CAUSE

Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation(s):

Count 1:

On or about January 10, 2019, Truth In Politics violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2018 M12 Report.

The Commission finds that there is **no probable cause** to charge Respondent with violating Section 106.19(1)(c), Florida Statutes.

NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by <u>consent order</u> where you and Commission staff agree to resolve the violation(s) and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an <u>informal hearing</u> held before the Commission, if you <u>do not</u> dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, he must provide the Commission with written proof of his financial resources at the hearing. A financial affidavit form is available from the Commission Clerk.

STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is probable cause to charge Respondent with violating Section 106.07(7), Florida Statutes, and that there is no probable cause to charge Respondent with violating Section 106.19(1)(c), Florida Statutes. Based upon a thorough review of the Report of Investigation submitted on August 20, 2019, the following facts and law support this staff recommendation:

- 1. On March 21, 2019, the Florida Elections Commission ("Commission") received a referral from the Department of State, Division of Elections ("Division"), alleging that Truth In Politics ("Respondent") violated Chapter 106, Florida Statutes.
 - 2. Respondent is a political committee registered with the Division. (ROI Exhibit 1)¹
- 3. By letter dated April 17, 2019, the Executive Director notified Respondent that Commission staff would investigate the following statutory provisions:

Section 106.07(7), Florida Statutes: As alleged in the complaint, Respondent, a political committee registered with the Division of Elections, failed to notify the filing officer on the prescribed reporting date that no report would be filed on that date because it had not received funds, made contributions, or expended reportable funds during the following reporting period:

2018 M12

Section 106.19(1)(c), Florida Statutes: As alleged in the complaint, Respondent, a political committee registered with the Division of Elections, may have falsely reported or deliberately failed to include information required by Chapter 106, Florida Statutes, when it failed to file a report on the prescribed reporting date for the following reporting period:

- 2018 M12
- 4. By letter dated November 7, 2018, Kristi Reid Willis, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that the Division had received its Statement of

Organization and Appointment of Campaign Treasurer and Designation of Campaign Depository for Political Committees forms. (ROI Exhibit 3, page 1)

- 5. The acknowledgment letter advised Respondent that all political committees filing reports with the Division are required to use the electronic filing system ("EFS"), and provided Respondent with a user identification number and initial password to grant access to the EFS. (ROI Exhibit 3, page 1) The letter further advised Respondent that all of the Division's publications and reporting forms were available on its website and directed Respondent to print out the *Calendar of Reporting Dates* as well as other relevant documents. (ROI Exhibit 3, page 2)
- 6. Respondent's 2018 M12 Report was due to be filed by January 10, 2019; however, Respondent failed to timely file the report or notify the filing officer that no report would be filed. (ROI Exhibit 8, page 1) By letters dated January 11, 2019, January 23, 2019, and March 1, 2019, the Division notified Respondent that its 2018 M12 Report had not been received. The letters also notified Respondent that it was still required to notify the Division if the committee had no reportable financial activity. (ROI Exhibits 4-6) The March 1, 2019 letter was confirmed delivered. (ROI Exhibit 7)
- 7. A subpoena was issued to Respondent's designated campaign depository to ascertain whether any financial activity occurred during the relevant reporting period, i.e., December 1, 2018 December 31, 2018. The financial institution did not have any records responsive to Commission staff's subpoena. (ROI Exhibit 9)
- 8. Respondent failed to respond to Commission staff's investigation. (ROI Exhibit 10)
- 9. As it appears that Respondent had no financial activity, Respondent was required to notify the filing officer in writing that it would not be filing its 2018 M12 Report on the prescribed reporting date, but failed to do so. Therewith, it does not appear that Respondent falsely reported or deliberately failed to include information in its 2018 M12 Report as the report was waived due to a lack of reportable financial activity.
- 10. As of July 26, 2019, Respondent had not filed the report or submitted a notice of no activity. (ROI Exhibit 8, page 1)
- 11. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. Schmitt v. State, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. Department of Highway Safety and Motor Vehicles v. Favino, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).
- 12. The facts set forth above show that Respondent is a political committee registered with the Division. Respondent failed to timely file its 2018 M12 Report or notify the filing

officer that no report would be filed. It appears that Respondent had no financial activity during the relevant reporting period, and therefore, was required to notify the filing officer in writing that it would not be filing the committee's 2018 M12 Report on the prescribed reporting date, but failed to do so. Therewith, it does not appear that Respondent falsely reported or deliberately failed to include information in its 2018 M12 Report as the report was waived due to a lack of reportable financial activity.

Based upon these facts and circumstances, I recommend that the Commission find no probable cause to charge Respondent with violating Section 106.19(1)(c), Florida Statutes, and find probable cause to charge Respondent with violating the following:

Count 1:

On or about January 10, 2019, Truth In Politics violated Section 106.07(7), Florida Statutes, when it failed to notify the filing officer in writing on the prescribed reporting date that it would not be filing its 2018 M12 Report.

Respondent: Truth In Politics

Complainant: Division of Elections

Pursuant to Section 106.25(2), Florida Statutes, on March 21, 2019, the Florida Elections Commission ("Commission") received information from the Division of Elections ("Division") that Respondent violated Chapter 106, Florida Statutes. Therefore, Commission staff investigated whether Respondent violated the following statutes:

Section 106.07(7), Florida Statutes, failure of a political committee that did not receive any contributions or make any expenditures during a reporting period to notify timely the filing officer, in writing, that no report is being filed; and

Section 106.19(1)(c), Florida Statutes, prohibiting a person or organization from falsely reporting or deliberately failing to report information required by Chapter 106, Florida Statutes.

I. Preliminary Information:

- 1. Respondent is a political committee ("PC") registered with the Division since November 6, 2018; Respondent's account number with the Division is #73903. Kristopher Guzman is its chairman and treasurer. Respondent is a statewide committee to support or oppose candidates for statewide, legislative, multi-county, county or municipal office and other activities allowed under Florida Statutes, and Election Law. To review its Statement of Organization of Political Committee (Form DS-DE 5) and Appointment of Campaign Treasurer and Designation of Campaign Depository for Political Committees (Form DS-DE 6), refer to Exhibits 1 and 2, respectively.
- 2. Complainant is the Division. Respondent's filing officer is Kristi Reid Willis, Chief, Bureau of Election Records.
- 3. By letter dated November 7, 2018, Ms. Willis acknowledged Respondent's name has been placed on the active committee list as a political committee and provided its identification number 73903. To review her acknowledgment letter, refer to Exhibit 3.

II. Alleged Violation of Section 106.07(7), Florida Statutes:

4. I investigated whether Respondent violated this section of the election laws by not notifying the filing officer on the prescribed reporting date that no report would be filed on that date because the political committee had not received funds, made contributions, or expended

reportable funds during the 2018 M12 reporting period of December 1 through 31, 2018. A report or notice-of-no-activity was due on January 10, 2019.

- 5. Complainant alleges that Respondent failed to file a report after notice or failure to file a notification to the filing officer in writing that no report was being filed on the prescribed reporting date.
- 6. On January 11, 2019, the Division mailed Mr. Guzman notification that the 2018 M12 report had not been filed. To review the first notice, refer to Exhibit 4.
- 7. On January 23, 2019, the Division mailed Mr. Guzman a second notification that the 2018 M12 report had not been filed. To review the Division's second notice, refer to Exhibit 5.
- 8. On March 1, 2019, the Division mailed Mr. Guzman final notification with delivery confirmation that the 2018 M12 report had not been filed. To review the Division's final notice with delivery confirmation, refer to Exhibits 6 and 7, respectively.
- 9. In her Affidavit, Ms. Willis affirmed that Mr. Guzman did not notify the Division prior to or on the prescribed reporting date for the 2018 M12 reporting period that no report was to be filed. And as of March 20, 2019, Mr. Guzman has not filed the 2018 M12 report.
- 10. On July 26, 2019, according to its filing history, Respondent's 2018 M12 report or notice-of-no-activity has not been filed. However, notices-of-no-activity for the 2018 M11 and 2019 M1 reporting periods—the reporting periods before and after the 2018 M12 reporting period—were filed. To review its filing history and campaign finance activity, refer to Exhibit 8.
- 11. I attempted to obtain Respondent's bank records by subpoena to the campaign depository (Chase Bank now known as JPMorgan Chase Bank, N.A.) identified on its Form DS-DE 6; however, Bank staff have been unable to locate an account for Respondent and records responsive to the subpoena. To review Bank staff's letter, refer to Exhibit 9.
- 12. On June 12, 2019, I mailed a questionnaire to Respondent's chairman, Kristopher Guzman, to ascertain why the 2018 M12 report or notice-of-no-activity had not been filed; however, at the time of this report of investigation ("ROI"), he has not completed the questionnaire, and it was not returned by the USPS.
- 13. I found no record of previous complaints to indicate that Respondent had violated this section of Florida's election laws.

III. Alleged Violation of Section 106.19(1)(c), Florida Statutes:

- 14. I investigated whether Respondent violated this section of the election laws by falsely reporting or deliberately failing to report information required by Chapter 106, Florida Statutes.
- 15. To review information regarding this section of the election laws, refer to paragraphs 5 through 12 in this ROI.

ROI (07/16) 2

16. I found no records of previous complaints to indicate that Respondent had violated this section of Florida's election laws.

IV. FEC History:

17. Respondent had no history of additional complaints filed against it with the Commission at the time of our receipt of the referral from the DOE.

Conclusion:

- 18. Respondent's chairman was offered an opportunity to make comments regarding the referral and investigation, however, he did not complete and return a questionnaire that was mailed on June 12, 2019, and I was unable to reach him by telephone. To review the phone log, refer to Exhibit 10.
- 19. In the November 7, 2018 acknowledgment letter (Exhibit 3), Respondent's chairman was informed that all the Division's publications were available online at the Division's website. In the letter, he was admonished as follows: It is your responsibility to read, understand, and follow the requirements of Florida's election laws. Therefore, please print a copy of the following documents: Chapter 106, Florida Statutes, *Political Committee Handbook*, Calendar of Reporting Dates, and Rule 1S-2.017, Florida Administrative Code.
- 20. Mr. Guzman is familiar with the reporting requirements of a PC required to file CTRs or notices-of-no-activity with the Division as he served as chairman for a PC with the same name as Respondent, Truth In Politics, (#73701), between July and September 2018 and is currently chairman and treasurer of another PC, Floridians For Truth PC, since October 2018, in addition to his service to Respondent, (#73903), since November 2018. (Note: All three PCs were referred by the Division to the *Political Committee Handbook* last revised on March 15, 2018.) To review relevant documents, refer to Exhibits 11 and 12. To review relevant pages of the *Political Committee Handbook*, refer to Exhibit 13.

EFS is inoperable on the due date, the report will be accepted as timely filed if filed no later than midnight, Eastern Standard Time, of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any political committee failing to file a report on the designated due date is subject to a fine of \$50 per day for the first 3 days and, thereafter, \$500 per day for each day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding each primary and general election, the fine shall be \$500 per day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the chairperson and campaign treasurer and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.

An online instruction guide is available to you on the EFS to assist with navigation, data entry, and submission of reports. The Division of Elections will also provide assistance to all users by contacting the EFS Help Desk at (850) 245-6280.

Dear Mr. Guzman:

Our records indicate that you have not filed either your campaign treasurer's report or notification that no reportable activity occurred, whichever is applicable. The filing date was January 10, 2019.

The law (s. 106.07(8)(b), Fla. Stat.) requires the filing officer to immediately notify you about the missed filing date and the automatic fines that will be assessed for late filing of a report, if a report was due.

- If reportable activity occurred and you have not filed a report, statutory fines are automatically assessed as follows until you file your report:
 - \$50 per day for the first 3 days late
 - \$500 per day for each day after the 3rd day late
 - If the required report immediately precedes a primary and general election, the automatic fine is \$500 for each late day.

The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period. Even if you end up filing your report late, we cannot waive the statutory fines. We will notify you of the specific amount of fines owed once you file your report. You have 20 days from the day you receive the notice to pay the fine or to appeal the fine to the Florida Elections Commission.

• If no reportable activity occurred for the report date(s), you are still required to notify us in writing, via the Division's Electronic Filing System, that no reportable activity occurred. No automatic fines are statutorily assessed.

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.

Our records indicate that you have not filed either your campaign treasurer's report or notification that no reportable activity occurred, whichever is applicable. The filing date was January 10, 2019.

We mailed, via regular mail, the first notice of the failure to file the above-mentioned report or notification to the address on file with our office on January 11, 2019.

The first notice which we provided to you specifically explained the automatic fine provisions in the law (s. 106.07(8)(b), Fla. Stat.) for failure to file a required report. Such fines are continuing to accrue for a late-filed report. 



EFS is inoperable on the due date, the report will be accepted as timely filed if filed no later than midnight, Eastern Standard Time, of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any political committee failing to file a report on the designated due date is subject to a fine of \$50 per day for the first 3 days and, thereafter, \$500 per day for each day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding each primary and general election, the fine shall be \$500 per day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the chairperson and campaign treasurer and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.

Instructions and Assistance

An online instruction guide is available to you on the EFS to assist with navigation, data entry, and submission of reports. The Division of Elections will also provide assistance to all users by contacting the EFS Help Desk at (850) 245-6280.

All of the Division's publications and reporting forms are available on the Division of Elections' website at http://dos.myflorida.com/elections/. It is your responsibility to read, understand, and follow the requirements of Florida's election laws. Therefore, please print a copy of the following documents: Chapter 106, Florida Statutes, *Political Committee Handbook*, Calendar of Reporting Dates, and Rule 1S-2.017, Florida Administrative Code.



Chapter 10: Filing Campaign Reports

Each campaign treasurer designated by a political committee shall file regular reports of all contributions received and all expenditures made by or on behalf of such political committee.

The chairperson and campaign treasurer shall certify as to the correctness of each report. Each person so certifying shall bear the responsibility for the accuracy and veracity of each report. Any campaign treasurer or chairperson who willfully certifies the correctness of any report while knowing that such report is incorrect, false or incomplete commits a misdemeanor of the first degree.

(Sections 106.011 and 106.07, F.S.)

Where to File

A campaign treasurer is required to file campaign treasurer's reports with the officer with whom the committee registers.

Committees filing reports with the Division are required to file using the <u>Electronic Filing System</u> (see <u>Chapter 11, Electronic Filing of Campaign Reports</u>). If the committee's filing officer is other than the Division, contact the appropriate filing officer to find out the requirements.

The web address for filing online with the Division is: https://efs.dos.state.fl.us

(Section 106.07(2), F.S.)

When to File

Reports must be filed on the 10th day following the end of each calendar month from the time the committee registers. If the 10th day occurs on a Saturday, Sunday or legal holiday, the report shall be filed on the next business day that is not a Saturday, Sunday or legal holiday.

A political committee required to file reports with the Division must file reports:

- On the 60th day immediately preceding the primary election, and each week thereafter, with the last weekly report being filed on the 4th day immediately preceding the general election.
- On the 10th day immediately preceding the general election, and each day thereafter, with the last daily report being filed the 5th day immediately preceding the general election.

For political committees that file with the Division, see the "Campaign Finance Reporting Dates" at:

http://dos.myflorida.com/elections/candidat es-committees/campaign-finance/

Any political committee required to file reports with a filing officer other than the division must file reports on the 60th day immediately preceding the primary election and bi-weekly on each Friday thereafter through and including the 4th day immediately preceding the general election, with additional reports due on the 25th and 11th days before the primary election and the general election.

Unless the electronic filing requirements of Section 106.0705, Florida Statutes, apply, reports shall be filed no later than 5 p.m. of the day designated. A report postmarked by the U.S. Postal Service no later than midnight of the day designated is deemed timely filed. A report received by the filing officer within 5 days after the designated due date that was delivered by the U.S. Postal Service is deemed timely filed unless it has a postmark indicating the report was mailed after the designated due date. A certificate of mailing obtained from and dated by the U.S. Postal Service at the time of mailing or a receipt from an established courier company, which bears a date on or before the date on which the report is due, is proof of mailing in a timely manner.

Reports filed with the Division through the <u>Electronic Filing System (EFS)</u> are due no later than midnight, Eastern Time, of the due date. (See <u>Chapter 11</u>, <u>Electronic Filing of Campaign Reports</u>.)

(Sections 106.07, 106.0705, and 106.141, F.S.)

Penalty for Late Filing

Any political committee failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first three days late and, thereafter, \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports due immediately prior to the primary and general elections, the fine shall be \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

(Section 106.07(8), F.S.)

Notice of No Activity

When there has been no reportable activity in the campaign account during a reporting period (no funds expended or received) the filing of the report is waived. The political committee shall notify the filing officer in writing on or before the prescribed reporting date that no report is being filed on that date. The next report filed must specify that the report covers the entire period between the last submitted report and the report being filed.

(Section <u>106.07</u>, F.S.)

A notice of no activity filed with the Division must be filed electronically using the Division's electronic filing system.

(Section <u>106.0705</u>, F.S.)

Special Election Reports

When a special election is called to fill a vacancy in office, all political committees making contributions or expenditures to influence the results of the special election shall file campaign treasurers' reports with the filing officer on the dates set by the Department of State pursuant to Section 100.111, F.S.

When an election is called for an issue to appear on the ballot at a time when no candidates are scheduled to appear on the ballot, all political committees making contributions or expenditures in support of or in opposition to such issue shall file reports on the 18th and 4th days prior to such election.

Committees are to include on the special election campaign treasurer's reports only

Chapter 11: Electronic Filing of Campaign Reports

The <u>Electronic Filing System</u> (EFS) is an Internet system for recording and reporting campaign finance activity by reporting period. Each political committee required to file reports with the Division pursuant to Section <u>106.07</u>, F.S., must file such reports with the Division via the <u>EFS</u>.

Reports filed:

- Must be completed and filed through the <u>EFS</u> not later than midnight of the due date. Reports not filed by midnight of the day designated are late filed and are subject to the penalties under Section <u>106.07(8)</u>, F.S., as applicable.
- Are considered to be under oath by the chairperson and treasurer, and such persons are subject to provisions of Section 106.07(5), F.S. Persons given a secure signon to the EFS are responsible for protecting such from disclosure and are responsible for all filings using such credentials, unless they have notified the Division that their credentials have been compromised.

(Sections 106.0705 and 106.0706, F.S.)

Accessing the EFS

You can access the <u>EFS</u> at https://efs.dos.state.fl.us. Each person filing a report is provided an identification number and initial password to gain entry. Once you log in using the initial password, you will be prompted to change it to a confidential one.

You are responsible for protecting the password from disclosure. Contact the Division immediately if your password has been compromised.

Creating Reports

Campaign reports must be entered, saved, reviewed, and filed via the <u>EFS</u> either by directly entering data into the web application or by uploading data using an approved vendor's software. The Division maintains a list of approved software vendors whose programs meet the file specifications for filing campaign reports. Instructions for uploading reports are provided in the <u>Political Committees User Guide - PDF (DS-DE 110B)</u> located at:



Submitting Reports

Reports will be held in pending status until the report is ready to be filed. Each person eligible to file a report will receive a PIN (personal identification number) that allows the person to file reports via the <u>EFS</u>. A person's PIN is considered the same as that person's signature on a filed report.

Electronic Receipts

The person filing a report on the <u>EFS</u> may print an electronic receipt verifying the report was filed with the Division. Each report filed via the EFS is considered to be under oath and such persons filing the report are subject to the provisions of <u>Chapter 106</u>, F.S.

Chapter 15: Florida Elections Commission

The Florida Elections Commission is a separate and independent entity from the Division of Elections. Commissioners are appointed by the Governor from lists of names submitted by legislative leaders.

Automatic Fine Appeal Process

A political committee may appeal or dispute a fine for a late filed campaign treasurer's report. The appeal must be based upon, but not limited to, unusual circumstances surrounding the failure to file on the designated due date. The political committee may request and is entitled to a hearing before the Florida Elections Commission, which has the authority to waive the fine in whole or in part. The Florida Elections Commission must consider the mitigating and aggravating circumstances contained in Section 106.265(1), F.S., when determining the amount of a fine, if any, to be waived.

The appeal must be made within 20 days of the receipt of the notice of payment due. The committee must, within the 20 day period, notify the filing officer in writing of his or her intention to bring the matter before the Commission.

(Section 106.07(8)(c), F.S.)

Complaint Process

Any person who has information of a violation of Chapters 104 or 106, F.S., shall file a sworn complaint with the Florida Elections Commission, 107 West Gaines Street, Suite 224, Tallahassee, Florida 32399- 1050 or call 850-922-4539. A complaint form (FEC Form 1) may be obtained from the Florida Elections Commission or downloaded from the Commission's website at www.fec.state.fl.us. (Sections 106.25 and 106.28, F.S.)





Dear Mr. Guzman:

On March 21, 2019, the Florida Elections Commission received a complaint alleging that your committee violated Florida's election laws. I have reviewed the complaint and find that it contains one or more **legally sufficient allegations**. The Commission staff will investigate the following alleged violations:

Section 106.07(7), Florida Statutes: As alleged in the complaint, Respondent, a political committee registered with the Division of Elections, failed to notify the filing officer on the prescribed reporting date that no report would be filed on that date because it had not received funds, made contributions, or expended reportable funds during the following reporting period:

2018 M12

Section 106.19(1)(c), Florida Statutes: As alleged in the complaint, Respondent, a political committee registered with the Division of Elections, may have falsely reported or deliberately failed to include information required by Chapter 106, Florida Statutes, when it failed to file a report on the prescribed reporting date for the following reporting period:

2018 M12

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. Based on the results of the investigation, a staff attorney will make a written recommendation (Staff Recommendation or SR) to the Commission as to whether there is probable cause to charge respondent with violating Chapters 104 or 106, Florida Statutes. You

Stat.) that are applicable only to campaign finance reports.

As we stated in the prior notices, even if you now file the report or notification, the untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.
