SUMMARY: Coral Springs Fraternal Order of Police Lodge 87 PAC is a political committee (PC) registered with the State of Florida. The PC's chair is Corey Logan, and its treasurer is William Reid.

The PC is appealing the fine. According to Mr. Logan, he usually receives emails about upcoming reports but did not receive any email communications regarding due dates of the daily filings leading up to the November election. He also notes that the calendar on the website did not have the daily filings dates listed. He requests a waiver or reduction of fees due to the circumstances.

- The 2020 D4 Original Report covers the period from 10/26/20-10/26/20; it was due on 10/27/20.
- The 2020 D4 Queued Transaction Report shows that it was created and filed on 10/29/20¹.
- Coral Springs Fraternal Order of Police Lodge 87 PAC reported receiving zero contributions while making 1 expenditure.
- FEC staff was advised, "The committee filed a notice of no activity (waiver) on 10/29/20. A waiver is not a report. On 11/01/20, the committee filed a report showing \$250.00 of activity. The fine is based on 25% of the activity."
- The Division of Elections does not have any notes that pertain to Coral Springs Fraternal Order of Police Lodge 87 PAC's 2020 D4 report.

PRIOR CASES: None.

Earlier this year, I was appointed as the Chairman of the Coral Springs Fraternal Order of Police Lodge 87 PAC #64163. During this time, I have never filed a late report while learning the campaign finance system. This past month, I filed 5 late reports totaling an assessed late fee of \$350. The 5 late reports were only reports listing expenditures and no contributions. I now realized, I could have just filed a late waiver report and listed all the expenditures on the G6 report that was filed on time. I am used to receiving emails about upcoming reports, but I did not receive any email communications about due dates of the daily filing dates leading up to the election. Also, I looked at the calendar on the website and the one I reviewed did not have the daily filing dates leading up to the November election.

I admit to being at fault for the late filing of these reports, but for these listed reasons, I am requesting a waiver of late penalty fees or a reduced amount. Also, I am not requesting a hearing, rather a ruling by your Commission. This letter was also sent to the Florida Elections Commission.

Dear Mr. Logan:

Our records indicate that you have not filed either your campaign treasurer's report or notification that no reportable activity occurred, whichever is applicable. The filing date was October 27, 2020.

The law (s. 106.07(8)(b), Fla. Stat.) requires the filing officer to immediately notify you about the missed filing date and the automatic fines that will be assessed for late filing of a report, if a report was due.

- If reportable activity occurred and you have not filed a report, statutory fines are automatically assessed as follows until you file your report:
 - * \$50 per day for the first 3 days late
 - \$500 per day for each day after the 3rd day late
 If the required report immediately precedes a primary and general election, the automatic fine is \$500 for each late day.

The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period. Even if you end up filing your report late, we cannot waive the statutory fines. We will notify you of the specific amount of fines owed once you file your report. You have 20 days from the day you receive the notice to pay the fine or to appeal the fine to the Florida Elections Commission.

• If no reportable activity occurred for the report date(s), you are still required to notify us in writing, via the Division's Electronic Filing System, that no reportable activity occurred. No automatic fines are statutorily assessed.

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.

Pin Numbers

Pin numbers are confidential secure credentials that allow you to submit reports and update information. The enclosed sealed envelope provides a confidential pin number for the chairperson. By copy of this letter, a confidential pin number to access the EFS was sent to the treasurer.

Each political committee chairperson is required to provide the Division of Elections with confidential personal information that may be used to allow access in the event that the password is forgotten or lost. When you enter the campaign account screen, there will be a drop down box where you pick a question (such as *What is your mother's maiden name?*) and supply an answer. All passwords and answers to questions are stored as encrypted data and cannot be viewed by Division staff and given out over the phone. Please notify the Division if your credentials have been compromised.

Timely Filing

All reports must be completed and filed through the EFS no later than midnight, Eastern Standard Time, of the due date. Reports not filed by midnight of the due date are late filed and subject to the penalties in Section 106.07(8), Florida Statutes. In the event that the EFS is inoperable on the due date, the report will be accepted as timely filed if filed no later than midnight, Eastern Standard Time, of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any political committee failing to file a report on the designated due date is subject to a fine of \$50 per day for the first 3 days and, thereafter, \$500 per day for each day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding each primary and general election, the fine shall be \$500 per day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the chairperson and campaign treasurer and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.
