NOTICE OF VIRTUAL HEARING (AUTOMATIC FINE)

A hearing will be held in this case before the Florida Elections Commission on February 23, 2021 at 8:30 am, EST, or as soon thereafter as the parties can be heard.

Please note that because of COVID-19, this will be a virtual meeting conducted by remote video or teleconference. Enclosed you will find additional details on joining the video conference via GoToWebinar, 9-Digit Webinar ID 627-359-707, or via teleconference by dialing (877) 309-2071 and entering the meeting access code 324-720-215, when prompted. If you wish to speak before the Commission, you will need to appear by webcam and will be sworn in remotely. Please be advised that the Commission will consider multiple cases, so you will need to wait until your case is considered. If you have any questions, please contact Commission staff at (850) 922-4539.

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

If you are the Respondent, you may attend the hearing, and you or your attorney will have 5 minutes to present your case to the Commission. However, some cases (including those in which motions to dismiss or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which motions to dismiss or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have 5 *minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing*. The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

SUMMARY: ABCD: Accountability= Better Community Direction is a political committee (PC) registered with the State of Florida. The PC's chair is Stephanie Gibson and its treasurer is Conni Brunni.

The PC is appealing the fine claiming that the previous treasurer, Rebecca Cyphert, unexpectedly quit and that the new treasurer did not receive the Division of Elections credentials until after the reporting deadline had passed.

According to the new treasurer, Conni Brunni, multiple issues regarding deficient DSDE6 forms delayed the receipt of credentials. She notes that the form was filed three times before they received the credentials in their P.O Box on or about July 3rd. Ms. Brunni also states that she had issues regarding her computer and was unable to file the report until it was repaired. A copy of emails to the Division of Elections and certified mail receipts have been provided.

- The 2020 P2 Original Report covers the period from 06/20/20-06/26/20; it was due on 07/03/20.
- The 2020 P2 Queued Transaction Report shows that it was created and filed on 07/10/20.
- ABCD: Accountability= Better Community Direction reported receiving 2 contributions, while making zero expenditures.
- The Division of Elections has four notes on file that pertain to ABCD: Accountability= Better Community Direction's 2020 P2 report. An entry dated 6/24/20 shows the confidential pin number was released to the treasurer, Conni Brunni, over the phone. Three other entries refer to the incomplete DSDE6 form.

Re: automatic fine appeal

Ladies and Gentlemen of the Florida Division of Elections,

On July 24, 2020, our organization received 2 letters dated 7/14/20 regarding automatic assessed late fine for a Treasurer's report that was doe 6/19/20 of \$22.26, and for a Treasurer's report due on 7/3/20 of \$15.33. Pursuant to FAC Rule 2B-1.005 and 2B-10055 (1)(e) and (f), we hereby formally appeal said fines for the following reasons:

On 6/2/20 our Treasurer, Rebecca Cyphert, unexpectedly and abruptly notified the rest of the group that she quit. This was a circumstance over which we, the appealing party, had no control. Up to that point, Ms. Cyphert had filed reports timely and regularly. I as new Treasurer phoned the Elections Records Help Desk at (850) 245-6240. Based on that conversation, I emailed the info to electecords@dos.myflorida.com on 6/2/20 at 12:26pm (copy of email attached). I received an email response at 12:38pm from Kristi Reid Willis, Chief of Bureau of Election Records to submit forms. I also filled out the new DSDE6 with a letter explaining what had occurred to the Division of Elections address by overnight USPS mail (tracking #EJ64002625US) Copies of all documents and USPS receipt attached.

On 6/7/20, I believe by phone, we were notified that a deficiency in the DSDE6 occurred, so new paperwork was submitted. In my haste, I did not retain a copy of what was submitted. It was mailed 6/7/20 by USPS overnight mail tracking #EJ351578065US. Because we knew a report was due 6/10/20, we did everything in our power to ensure we could file reports. Unfortunately, we were informed that the Treasurer's online credential had been killed because she abruptly left, as indicated in our 6/2/20 correspondence; THIS WAS BEYOND OUR CONTROL. All activities were performed in good faith with no purpose of evasion.

On 6/19/20, we were again informed that something in the DSDE6 was deficient. So new paperwork was submitted again! The third set of paperwork was mailed by priority mail tracking #9505516012820172549794 on 6/20/20; copies are attached. At that point the 6/10/20 deadline for our report had passed.

We subsequently received a letter from the Division of Elections dated 6/24/20, and postmarked 6/25/20 with the Treasurer's credential. Given that the fine letters were postmarked 7/16/20 and received by us on 7/24/20, it is reasonable to believe a similar delivery time for the credential. That would mean it was received in our PO box on or about 7/3/20. At that time, my computer had failed and was taken to Lemon Bay Computer Services for repair. This was beyond my control and VERY distressing.

When the computer was up and running, we filed all reports since the abrupt and unexpected loss of our Treasurer on 7/10/20. All subsequent filings have been and will be timely. All attempts to submit new paperwork were performed in good faith and without purpose of evasion. The only money into the account was the opening deposit of \$100 form me, the Treasurer and the expense was a bank charge for check printing. We respectfully and humbly appeal the automatically assessed late fine of \$22.26 and \$15.33, respectively, for the periods stated above.

Dear Ms. Gibson:

Our records indicate that you have not filed either your campaign treasurer's report or notification that no reportable activity occurred, whichever is applicable. The filing date was July 3, 2020.

The law (s. 106.07(8)(b), Fla. Stat.) requires the filing officer to immediately notify you about the missed filing date and the automatic fines that will be assessed for late filing of a report, if a report was due.

- If reportable activity occurred and you have not filed a report, statutory fines are automatically assessed as follows until you file your report:
 - \$50 per day for the first 3 days late
 - \$500 per day for each day after the 3rd day late
 - If the required report immediately precedes a primary and general election, the automatic fine is \$500 for each late day.

The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period. Even if you end up filing your report late, we cannot waive the statutory fines. We will notify you of the specific amount of fines owed once you file your report. You have 20 days from the day you receive the notice to pay the fine or to appeal the fine to the Florida Elections Commission.

• If no reportable activity occurred for the report date(s), you are still required to notify us in writing, via the Division's Electronic Filing System, that no reportable activity occurred. No automatic fines are statutorily assessed.

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.


