**SUMMARY:** FCCFA Political Action Committee is a political committee (PC) registered with the State of Florida. The PC's chair is Keenan Knopke and its treasurer is John Williams.

- In a 2/13/17 email with Kristi Reid-Bronson, FEC staff was informed, "The committee filed a notice of no activity (waiver) on 8/5/15. A waiver is not a report. On 8/18/15, the committee filed a report showing \$2515 pc activity. The fine is based on 25% of the activity reported".

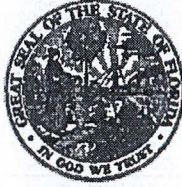
