**SUMMARY:** Libertarian Party of Florida is a political party executive committee (PAC) registered with the State of Florida. The PAC's chair is Steven Nekhaila and its treasurer is John Olivadoti

The PAC is appealing the fine claiming that they filed a waiver and originally reported the information with the Federal Elections Commission (FEC). According to Mr. Nekhaila, the Libertarian Party of Florida decided to begin filing their federal funds separate from state funds. As such, they created a new bank account exclusively for federal funds and began filing with DOE beginning September of 2019. Mr. Nekhaila states that he directed the treasurer to move all records from the FEC to DOE. He states that the funds were reported with the FEC and that amendments were made to the waiver. He requests a waiver of the fine as there were no funds unreported.

- The 2019 Q2 Original Report covers the period from 04/01/19-06/30/19; it was due on 07/10/19.
- The 2019 Q2 Queued Transaction Report shows that it was created and filed on 07/02/19.<sup>1</sup>
- Libertarian Party of Florida reported receiving 36 contributions, while making 13 expenditures.
- FEC staff was advised, "The committee filed a notice of no activity (waiver) on 07/02/19. A waiver is not a report. On 09/20/19, the committee filed a report showing \$1,554.36 of activity. The fine is based on 25% of the activity.
- The Division of Elections does not have any notes that pertain to Libertarian Party of Florida's 2019 Q2 report.

To whom it may concern,

My name is Steven Nekhaila, Chairman of the Libertarian Party of Florida (LPF). On May 28, 2020 I received a letter from the Bureau of Election Records regarding an alleged late filling for a report that was due on July 10<sup>th</sup>, 2019, which was filed on September 20<sup>th</sup>, 2019. After contacting the Division of Elections, I found that the report in question was our Q2 report to the DoE which filed as a waiver report. The reason being, is that for many years the LPF reported exclusively with the Federal Elections Commission all transactions, which under Florida law, any transaction which is recorded with the FEC does not need to be recorded with the DoE as a redundancy.

The Libertarian Party of Florida had decided to begin filing our Federal transactions separately from our State funds, in doing so, we have decided to begin reporting with the DoE beginning in September of 2019 all fillings and filing only Federal activity to the FEC. This also resulted in the creation of a new bank account exclusively for Federal funds. In the process, our Treasurer, John Olivadoti, was directed by me, Chairman and previous Treasurer, to move all records from the FEC to the DoE to be correct. Our FEC report for the period between July and September shall show the amendments made to reflect the Federal Funds account. We worked in tandem with the Federal Elections Committee on this arrangement which they have found satisfactory.

The Libertarian Party of Florida Executive Committee is dedicated to following both State and Federal reporting laws and ethics, and with the aid and support of our Audit Committee, remain stewards of Florida law and transparent for our members. I am formally requesting an appeal to the fine as no funds were unreported and should not be considered filed late, even if an amendment was filed on a previously waived report, it was not due to unreported funds. 
