ORDER OF PROBABLE CAUSE

THIS MATTER was heard by the Florida Elections Commission (Commission) at its regularly scheduled meeting on February 28, 2017, in Tallahassee, Florida.

On December 16, 2016, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff's Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation(s):

Count 1:

On or about November 6, 2015, Respondent violated Section 106.07(1), Florida Statutes, when Respondent failed to file Save Miami Beach's 2015 R1 Report.

Count 2:

On or about November 13, 2015, Respondent violated Section 106.07(1), Florida Statutes, when Respondent failed to file Save Miami Beach's 2015 R2 Report.

Count 3:

On or about December 10, 2015, Respondent violated Section 106.07(1), Florida Statutes, when Respondent failed to file Save Miami Beach's 2015 M11 Report.

Count 4:

On or about January 11, 2016, Respondent violated Section 106.07(1), Florida Statutes, when Respondent failed to file Save Miami Beach's 2015 M12 Report.

Count 5:

On or about February 10, 2016, Respondent violated Section 106.07(1), Florida Statutes, when Respondent failed to file Save Miami Beach's 2016 M1 Report.

Count 6:

On or about February 19, 2016, Respondent violated Section 106.07(1), Florida Statutes, when Respondent failed to file Save Miami Beach's 2016 G1 Report.

Count 7:

NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating **Section 106.07(1)**, **Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on November 17, 2016, the following facts and law support this staff recommendation:

- 1. On April 26, 2016, the Florida Elections Commission ("Commission") received a sworn complaint from Rafael E. Granado, City Clerk for the City of Miami Beach, alleging Stephen Cody ("Respondent") violated Chapter 106, Florida Statutes.
- 2. Respondent was the treasurer and chairperson for Save Miami Beach, a political committee registered with the Miami Beach City Clerk's Office. A Statement of Organization of Political Committee ("DS-DE 5") was filed with the City Clerk's Office on June 22, 2015. (ROI Exhibit 1)¹
- 3. By letter dated August 25, 2016, the Executive Director notified Respondent that Commission staff would investigate the following statutory provision:

Section 106.07(1), Florida Statutes: Respondent, Treasurer for Save Miami Beach, failed to timely file the following campaign treasurer's reports: 2015 R1, 2015 R2, 2015 M11, 2015 M12, 2016 M1, 2016 G1, 2016 G2, and 2016 G3.

- 4. On June 22, 2015, an Appointment of Campaign Treasurer and Designation of Campaign Depository for Political Committees ("DS-DE 6") was filed with the City Clerk's Office designating Respondent as Save Miami Beach's treasurer. (ROI Exhibit 2)
- 5. By letter dated June 23, 2015, Rafael E. Granado, City Clerk, City of Miami Beach, notified Respondent that the DS-DE 5 and DS-DE 6 forms were filed with the Miami Beach Office of the City Clerk on June 22, 2015. Enclosed with the letter was a form entitled, "Important Dates and Deadlines," which listed the dates on which campaign treasurer's reports were due. The letter specifically drew Respondent's attention to that form and reminded Respondent of the due date for the next campaign treasurer's report. Attached to the letter was a copy of the *Political*

The Report of Investigation shall be referred to herein as "ROI."

Committee Handbook. The letter invited Respondent to contact their office with any questions. (ROI Exhibit 3 and Exhibit 4)

- 6. Respondent failed to file the following campaign treasurer's reports for Save Miami Beach: 2015 R1 (due November 6, 2015), 2015 R2 (due November 13, 2015), 2015 M11 (due December 10, 2015), 2015 M12 (due January 11, 2016), 2016 M1 (due February 10, 2016), 2016 G1 (due February 19, 2016), 2016 G2 (due March 4, 2016), and 2016 G3 (due March 11, 2016). (ROI Exhibit 4, Exhibit 8 and Attachment A)
- 7. By letter dated December 1, 2015, Rafael E. Granado, City Clerk, City of Miami Beach, sent Respondent written notification that Save Miami Beach's 2015 R1 and 2015 R2 reports had not been received and reminded Respondent of the due date for the 2015 M11 report (December 10, 2015). The notification was sent via certified mail and was delivered on December 5, 2015. (ROI Exhibit 5)
- 8. On March 7, 2016, Rafael E. Granado, City Clerk, City of Miami Beach, sent Respondent written notification that Save Miami Beach's 2015 R1, 2015 R2, 2015 M11, 2015 M12, 2016 M1, 2016 G1, and 2016 G2 reports had not been received. The notification also reminded Respondent of the due date for the 2016 G3 report (March 11, 2016) and warned Respondent that if he failed to submit all due campaign reports by March 28, 2016, the Commission would be notified of the non-compliance. The notification was sent via certified mail and was delivered on March 12, 2016. (ROI Exhibit 6)
- 9. On December 7, 2016, the Office of the City Clerk, City of Miami Beach, confirmed via email that as of that date, Respondent had not filed any of the aforementioned reports and had not filed any waivers of the reports. (Attachment B)
- 10. Respondent was given multiple opportunities by Commission staff to submit documentation to the Commission in response to the complaint, but he failed to do so.
- 11. The Office of the City Clerk, City of Miami Beach, indicated that all of Respondent's prior reports had been waivers of report. (Attachment C)
- 12. Based upon the information above, it appears that Respondent failed to file the following campaign treasurer's reports for Save Miami Beach: 2015 R1, 2015 R2, 2015 M11, 2015 M12, 2016 M1, 2016 G1, 2016 G2, and 2016 G3.
- 13. "Probable Cause" is defined as a reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So.2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So.2d 305, 309 (Fla. 1st DCA 1995).
- 14. The above facts show that Respondent was the treasurer for Save Miami Beach, a political committee registered with the Miami Beach City Clerk's Office. Respondent failed to file the following campaign treasurer's reports for Save Miami Beach: 2015 R1 (due November 6,

2015), 2015 R2 (due November 13, 2015), 2015 M11 (due December 10, 2015), 2015 M12 (due January 11, 2016), 2016 M1 (due February 10, 2016), 2016 G1 (due February 19, 2016), 2016 G2 (due March 4, 2016), and 2016 G3 (due March 11, 2016). Despite receiving written notifications from the Miami Beach City Clerk's Office that the reports had not been received and needed to be filed, as of December 7, 2016, Respondent had not filed any of the aforementioned reports and had not filed waivers of the reports.

Based upon these facts and circumstances, I recommend that the Commission find probable cause to charge Respondent with the following:

Count 1:

On or about November 6, 2015, Respondent violated Section 106.07(1), Florida Statutes, when Respondent failed to file Save Miami Beach's 2015 R1 Report.

Count 2:

On or about November 13, 2015, Respondent violated Section 106.07(1), Florida Statutes, when Respondent failed to file Save Miami Beach's 2015 R2 Report.

Count 3:

On or about December 10, 2015, Respondent violated Section 106.07(1), Florida Statutes, when Respondent failed to file Save Miami Beach's 2015 M11 Report.

Count 4:

On or about January 11, 2016, Respondent violated Section 106.07(1), Florida Statutes, when Respondent failed to file Save Miami Beach's 2015 M12 Report.

Count 5:

On or about February 10, 2016, Respondent violated Section 106.07(1), Florida Statutes, when Respondent failed to file Save Miami Beach's 2016 M1 Report.

Count 6:

On or about February 19, 2016, Respondent violated Section 106.07(1), Florida Statutes, when Respondent failed to file Save Miami Beach's 2016 G1 Report.

Count 7:

On or about March 4, 2016, Respondent violated Section 106.07(1), Florida Statutes, when Respondent failed to file Save Miami Beach's 2016 G2 Report.

Count 8:

On or about March 11, 2016, Respondent violated Section 106.07(1), Florida Statutes, when Respondent failed to file Save Miami Beach's 2016 G3 Report.

Respondent: Stephen Cody

Complainant: Rafael E. Granado

On April 26, 2016, the Florida Elections Commission ("Commission") received a sworn complaint alleging that Respondent violated Chapter 106, Florida Statutes. Commission staff investigated whether Respondent violated the following statute:

Section 106.07(1), Florida Statutes, failure of the treasurer of a political committee to file timely regular reports of all contributions received, and all expenditures made, by or on behalf of the committee.

I. Preliminary Information:

- 1. Respondent, Stephen Cody, was the treasurer and chairperson for Save Miami Beach, a political committee registered with the Miami Beach City Clerk's office.
- 2. A Statement of Organization was filed with the city clerk's office on June 22, 2015. The committee declared its area, scope and jurisdiction as, "Civic engagement and issues in Miami Beach, Florida." To review a copy of the DS-DE 5 form, refer to Exhibit 1.
- 3. Complainant, Rafael E. Granado, is the city clerk for the City of Miami Beach; he served as the filing officer for Respondent's political committee.

II. Alleged Violation of Section 106.07(1), Florida Statutes:

- 4. I investigated whether Respondent violated this section of the election laws by failing to file the committee's 2015 R1, R2, M11, M12 and 2016 M1, G1, G2 and G3 reports after receiving notice that the reports were due.
- 5. On June 22, 2015, an Appointment of Campaign Treasurer and Designation of Campaign Depository for Political Committees (DS-DE 6) form was filed with the Miami Beach City Clerk's office. Respondent was appointed as treasurer of the committee. To review a copy of the DS-DE 6 form, refer to Exhibit 2.
- 6. On June 23, 2015, Complainant sent Respondent a letter acknowledging that his office had received paperwork relative to the political committee. The letter also alluded to a document entitled, "Important Dates and Deadlines," listing the dates that campaign reports were due. Additionally, the letter also mentioned that Complainant was including the Political

Committee Handbook, dated June 2014, as prepared by the Florida Department of State. To review a copy of Complainant's letter, refer to Exhibit 3. To review a copy of the document, "Important Dates and Deadlines," refer to Exhibit 4.

- 7. On December 1, 2015, Complainant's office sent Respondent a letter informing him that his office had not received the committee's 2015 R1 and 2015 R2 reports. The letter goes on the explain that the committee's next report, 2015 M11, will be due on December 10, 2015. In addition, Complainant provided confirmation that the letter was delivered to Respondent's address on December 6, 2015. To review a copy of the December 1, 2015 letter and delivery confirmation, refer to Exhibit 5.
- 8. On March 7, 2016, Complainant's office sent Respondent a letter marked "Final Notice of Late Reports" informing him that his office had not received the committee's 2015 R1, 2015 R2, 2015 M11, 2015 M12, 2016 M1, 2016 G1 and 2016 G2 reports. The letter goes on the explain that the committee's next report, 2016 G3, will be due on March 11, 2016. In addition, Complainant provided confirmation that the letter was delivered to Respondent's address on March 12, 2016. To review a copy of the March 7, 2016 letter and delivery confirmation, refer to Exhibit 6.
- 9. In a telephone interview on October 17, 2016, Complainant stated that the reports have not been filed. Additionally, Complainant stated he notified Respondent by way of certified mail that the political committee's registration had been revoked for having failed to submit campaign reports in over six months¹. To review a copy of the letter regarding the revocation of the political committee, refer to Exhibit 7.
- 10. According to Complainant's office, there were seven reporting periods prior to the 2016 R1 report; Respondent filed waivers for each reporting period. With the exception of two reporting periods, the 2015 M8 and the 2015 G1, all waivers were filed timely. To review the report summary, refer to Exhibit 8.
- 11. No record was found to indicate that Respondent has previously violated this section of the election laws.

III. FEC History:

12. Respondent has no prior history with the Florida Elections Commission as a respondent. In FEC 11-049, Respondent was a complainant in a complaint filed against a political committee. He had alleged that the political committee failed to file campaign reports timely and had not reported contributions and expenditures. The complaint was dismissed as being legally insufficient. To review correspondence from FEC 11-049, refer to Exhibit 9.

Conclusion:

13. On April 29, 2016, the Commission sent Respondent a letter via certified mail

informing him that a complaint had been filed against him. The letter advised Respondent he had 14 days to respond to the allegation and was delivered to Respondent's address on May 2, 2016. Respondent did not provide a response. To review the letter of April 29, 2016, and delivery confirmation, refer to Exhibit 10.

- 14. On August 25, 2016, the Commission sent Respondent a letter informing him that the complaint was found to be legally sufficient and the Commission would be investigating Respondent's failure to file timely the committee's 2015 R1, 2015 R2, 2015 M11, 2015 M12, 2016 M1, 2016 G1, 2016 G2 and 2016 G3 reports. The letter advised Respondent he could file a notarized statement providing any information regarding the facts surrounding the allegation. Respondent did not provide a notarized statement. To review the letter of August 25, 2016, refer to Exhibit 11.
- 15. On September 15, 2016, I sent Respondent an affidavit asking him to state the reason he has not filed the committee's reports mentioned in the complaint. As of the date of this report, Respondent has not returned the affidavit, and the affidavit has not been returned by the post office. To review a copy of the questionnaire-affidavit, refer to Exhibit 12.
- 16. On October 19, 2016, I spoke with Respondent via telephone. Respondent said that the committee basically consisted of himself and that he never raised or spent money; however, he did not address the reason as to why he did not file the reports at issue. Respondent added that he was unaware of the complaint². It was agreed that I would e-mail him a copy of the complaint as well as a copy of the questionnaire-affidavit. As of the date of this report, Respondent has not returned the affidavit, and the affidavit has not been returned by the post office.





Pursuant to Florida Statutes §106.07(8)(d) and §106.07(8)(9), the appropriate filling officer shall notify the Florida Elections Commission of the repeated late filing by a candidate or political committee, the failure of a candidate or political committee to file a report after notice, or the failure to pay the fine imposed. The commission shall investigate only those alleged late filing violations specifically identified by the filing officer and as set forth in the notification.

Please mail all due Campaign Reports to the Office of the City Clerk at 1700 Convention Center Drive, Miami Beach, Florida 33139 by March 28, 2016. Failure to submit all due Campaign Reports by that date will result in this office notifying the Florida Elections Commission of the non-compliance.

This letter is to inform you that we have not received your Campaign Reports 2015-R1 or 2015-R2. The 2015-R1 report was due on November 6, 2015, and covered the period of October 30, 2015 through October 30, 2015. The 2015-R2 report was due on November 13, 2015, and covered the period of October 31, 2015 through November 12, 2015. Please be advised that the 2015-M11 report will be due on December 10, 2015, and covers the period of November 13, 2015 through November 30, 2015.

Pursuant to Florida Statutes §106.07(8)(b), upon determining that a report is late, the filing officer shall immediately notify the candidate or chair of the political committee as to the failure to file a report by the designated due date and that a fine is being assessed for each late day. The fine shall be \$50 per day for the first 3 days late and, thereafter, \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding each special primary election, special election, primary election, and general election, the fine is \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Please send the requested campaign reports as soon as possible to the City of Miami Beach, c/o Office of the City Clerk, 1700 Convention Center Drive, Miami Beach, Florida 33139.
