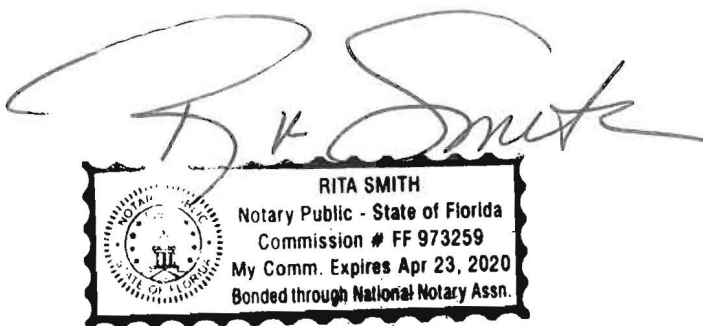

Subject: Delinquent Reports

Please be advised that your Treasurer's Report (G1) which was due September 9, covering the period 08/27/16 through 09/02/16 was not received until 09/19/16. In addition to this, your Treasurer's Report (G1A) which was due September 16, covering the period 09/03/16 through 09/09/16 was also received on 09/19/16. Therefore, you are fined \$445.00 for the (10) ten days late in submitting the (G1) Report, representing 25% of the expenditures on that report and \$150.00 for the (3) late in submitting the (G1A) Report.

We are enclosing copies of the List of 2016 Reporting Dates and the Political Committee Handbook, which are also available on the Division of Elections website for your information with respect to filing of future reports. As a reminder, your next Treasurer's Report, (G2) is due on September 23, 2016.

Section 106.07(8)(b), Florida Statutes, requires that the filing officer notify you of the failure to file said report and that a fine of \$50 per day for the first three days late and, thereafter, \$500 per day for each day late will be assessed; however, the fine may not exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. Once your report is received, this office will notify you of the specific amount of your fine. Fines must be paid to the filing officer within 20 days of receipt of the payment due notice, unless appealed to the Florida Elections Commission. Section 106.7(8)(c), Florida Statutes, provides for appealing or disputing the assessed fine by submitting a notice of appeal in writing to the



Florida Elections Commission within 20 days of the date of receipt of the notice of payment due. A failure to file such notice will constitute a waiver of the right of appeal.

Please be advised that a willful failure to file a campaign treasurer's report constitutes a violation of Chapter 106, Florida Statutes, independent of the automatic fine violation referenced above. Therefore, if you fail to file a report, such failure will be considered a willful violation of Chapter 106, Florida Statutes, and this office will turn the matter over to the Florida Elections Commission for prosecution. Section 106.265(1), Florida Statutes, authorizes the Florida Elections Commission, upon finding a willful violation of Chapter 106, Florida Statutes, to impose a civil penalty up to \$1,000.00 per count for each willful violation of Chapter 106. Moreover, pursuant to Section 106.19, Florida Statutes, the knowing, willful and deliberate failure to file a report constitutes a misdemeanor of the first degree, punishable as provided in Sections 775.082 or 775.083, Florida Statutes.

We urge your prompt attention to this matter.
