If you are the Respondent, you may attend the hearing, and you or your attorney will have 5 minutes to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an en masse vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will not be individually heard

If you are the Complainant, you may attend the hearing, but you will not be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an en masse vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will not be individually heard

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have 5 minutes to present your case to the Commission

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date As an Appellant, Respondent or Complainant in one case, you will not be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing

Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider an appeal from an automatic fine, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106 265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a consent order before a determination of probable cause has been made, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing. The Commission will only decide whether Respondent should be charged with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced

If this is an **informal hearing**, it will be conducted pursuant Sections 120 569 and 120 57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1 004, Florida Administrative Code At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful The Respondent may also address the appropriateness of the recommended fine If Respondent claims that his limited resources make him unable to pay the statutory fine, he must provide the Commission with written proof of his financial resources at the hearing A financial affidavit form is available from the Commission Clerk

SUMMARY: BOMA Florida PAC was a committee of continuous existence (CCE) registered with the State of Florida. The CCE's chair was Chris Rotolo and its treasurer is Richard Beaver. BOMA Florida PAC has hired Emmett Mitchell IV to represent them

The CCE is appealing the fine claiming that the treasurer incorrectly thought that he had filed the 2013 Q3 Report prior to the due date. According to Mr Mitchell, the CCE was required to disburse of all funds on deposit and cease operations no later than 9/30/13 BOMA disbursed of all their funds by donating to a charitable entity on 8/14/13. He states that a report was created in the EFS system detailing the donation "However, because the CCE was not listed as closed with the Division of Elections and the reporting cycle did not end until September 30, 2013, the EFS system would not allow the Treasurer, Richard Beaver, to actually "file" the report. The report was access again on September 23, 2013, but the report could still not be "filed". On October 1, 2013, Mr. Beaver attempted to access the EFS system to file the report. He believed he had successfully filed the report on October 1, 2013. The report was not due until October 10, 2013. He believed the report had been successfully filed until he received a notice from the Division." Mr. Mitchell states that the report was filed on 10/28/13, immediately after Mr. Beaver received the failure-to-file notice "He also contacted the Division by telephone on October 28, 2013 to ensure that the report was correctly filed."

- The 2013 O3 Report covers the time period from 7/1/13 through 9/30/13
- The CCE reported receiving 0 contributions, while making 1 expenditure
- The 2013 Q3 Queued-Transactions Report reflects that this report was created on 8/14/13 at approximately 5:02 pm, reviewed and recalculated on 8/14/13 and 9/23/13, before being filed on 10/28/13 at approximately 5:01 pm

In a 1/15/14 telephone interview with David Beach, DOE representative, I was advised that the earliest the 2013 Q3 Report could have been filed would have been on 9/30/13, the last day of the reporting period.

PRIOR CASES: This CCE has appeared before the Commission on one previous occasion In FEC 09-111; no unusual circumstances was found for a violation of 106 07(1), Florida Statutes.

This firm represents BOMA Florida PAC (BOMA), a closed committee of continuous existence (CCE), in the above-referenced automatic fine matter. A Notice of Appearance has previously been filed with your office

As you know, statutory changes became effective in 2013 requiring CCEs to disburse all funds on deposit and cease operations no later than September 30, 2013. In accordance with its bylaws and in advance of the September 30, 2013 deadline imposed by Chapter 2013-37, Laws of Florida, BOMA donated \$29,056.10 to a charitable entity on August 14, 2013. The donation zeroed out the CCE bank account

Also on August 14, 2013, a report was created in the State of Florida Electronic Filing System (EFS), detailing the above-mentioned donation. However, because the CCE was not listed as closed with the Division of Elections (Division) and the reporting cycle did not end until September 30, 2013, the EFS system would not allow the Treasurer, Richard Beaver, to actually "file" the report. The report was accessed again on September 23, 2013, but the report could still not be "filed". On October 1, 2013, Mr. Beaver attempted to access the EFS system to file the report. He believed he had successfully filed the report on October 1, 2013. The report was not due until October 10, 2013. He believed the report had been successfully filed until he received a notice from the Division.

On October 23, 2013, thirteen days after the report's due date, the Division issued a letter to BOMA informing it that the October 10, 2013 report had not been received. Mr. Beaver received this letter on Saturday, October 26, 2013, by US Mail. Upon receipt of the letter, Mr. Beaver took immediate steps to correct the error, as evidenced by the fact that the EFS system was accessed and the report filed on October 28, 2013. He also contacted the Division by telephone on October 28, 2013 to ensure that the report was correctly filed

As previously stated, Mr. Beaver believed the report had been filed on October 1, 2013. As the Division of Elections states in its October 23, 2013 letter, the Division is required to "immediately" notify filers of any reports not received by the Division. Unfortunately, the Division's letter was not even

generated until 13 days after the report due date. Because of this delay, the maximum automatic fine has been imposed. Had BOMA been notified more timely, the amount of the automatic fine would have been significantly less.

Additionally, the fine amount is based upon 25% of the dissolution expenditure of \$29,056.10 No contributions were collected by BOMA during the reporting period and the only expenditure was to zero out the account by making a donation to a charitable entity. As such, imposing a \$7,264.03 fine upon the officers of a closed CCE seems particularly harsh. Since the CCE is closed and all funds have been disbursed in accordance with Florida Statutes, the officers of the CCE are jointly and severally liable for the imposed automatic fine.

BOMA has been exceptionally responsive to this matter as evidenced by the filing of the October 10, 2013 report immediately after BOMA received notification that it had not been received by the Division Additionally, in response to the Division's fine letter generated on October 30, 2013, Mr. Beaver sent a letter to the Division on November 4, 2013, requesting that the automatic fine be waived. When he was informed that an appeal must be filed with the Florida Elections Commission, he took immediate steps to file the appeal, speaking with the Commission Clerk and emailing an appeal letter to her on November 8, 2013

For the foregoing reasons, BOMA respectfully requests that the fine of \$7,264.03 be waived in its entirety.

Section 106 04(9)(b), Florida Statutes, requires that the filing officer immediately notify you of the failure to file this report and that a fine will be assessed of \$50 per day for the first 3 days a report is late and, thereafter \$500 per day, although a fine cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report

Once your report is filed, this office will notify you of the specific amount of your fine. Fines must be paid to the filing officer within 20 days of receipt of the payment due notice

Please be advised, however, that failure to file a campaign treasurer's report may constitute a violation of Chapter 106, Florida Statutes, independent of the automatic fine violation referenced above. Therefore, if you fail to file a report, the division will turn the matter over to the Florida Elections Commission

Section 106.265(1), Florida Statutes, authorizes the Florida Elections Commission to impose a civil penalty up to \$1,000 per count for each willful violation of Chapter 106


