SUMMARY: The Honorable Joelle Ann Ober was a candidate for reelection for Hillsborough County Court Judge, Group 3 in the 2018 elections. Judge Ober was her own treasurer.

Judge Joelle Ann Ober is appealing the fine claiming that she was unable to file the TR report timely due to an error by SunTrust bank. She has provided exhibits detailing the transactions at issue with the bank. According to Judge Ober, she spoke with staff from the Supervisor of Elections office and was told that the TR report could not be filed until the campaign account balance reflected zero dollars. Judge Ober also notes that as soon as the account was closed, she filed the report. She requests that the fine be waived in full due to the SunTrust bank error and her immediate efforts to remedy the error.

- The 2018 TR Original Report covers the period from 05/04/18-08/02/18; it was due on 08/02/18.
- The 2018 TR Original Report shows that it was filed on 08/07/18.
- Judge Joelle Ann Ober reported receiving zero contributions, while making 23 expenditures.
- Enjoli White, Hillsborough County Candidate Services Liaison, sent an email to staff stating the she spoke with Judge Ober multiple times regarding her termination report. She also states that on August 3rd Judge Ober stated that she was aware the report was late and was going to submit it by the end of the day. She also requested the FEC's contact information.

Notice of Appeal

Please consider this letter to be my official notice of appeal and reconsideration of the late fee/fine imposed by Hillsborough County Supervisor of Elections for the late filing of my termination report for my recent reelection to County Court Judge Group 3, Hillsborough County, Florida, a position I've held for twenty-three and a half years.

My termination report was due on Thursday, August 2, 2018. The report was not filed until Tuesday, August 7, 2018 at 2:28:48 p.m. SEE EXHIBIT 1. I received a notice that same day from Enjoli White at the Hillsborough County Supervisor of Elections regarding a fine imposed due to this late filing. SEE EXHIBITS 2 A & B. This late filing was due to an error by SunTrust Bank, P.O. Box 305783, Nashville, Tennessee 37230-5783, which held my campaign account and funds. Acount number 1000201855821 was opened at the SunTrust downtown Tampa branch located at 401 East Jackson Street, Tampa, Florida 33602 by employee Tammy Lehoullier. SEE EXHIBIT 3 (containing Ms. Lehoullier's address, phone number and email address).

All expenditures for the return of the excess funds from this account were written and mailed on June 6, 2018. SEE EXHIBTS 4 A & B. Check #120 dated June 6, 2018 to Older Lundy Alvarez and correctly written for \$165.16 was incorrectly paid by SunTrust for \$765.16 causing the account to be overdrawn by \$600.00. SEE EXHIBIT 4C. This in turn caused check #122 issued to Malik Law for \$660.63 to be returned for insufficient funds. SEE EXHIBT 5A. I received notice of this issue around July 19, 2018. SEE EXHIBIT 5B. I called Ms. Lehoullier, however she was not able to determine the issue. I received my bank statement for June and discovered the error of the improper payment on check #120. The bank was notified and needed a day or two to refund the amount to my account. This required me to request that outstanding check #111 for #330.30 be held until further notice. SunTrust refunded my account the \$600.00 on July 26, 2018, as well as refunded the fees associated with the insufficient funds issue. SEE EXHIBIT 6.

I had to write a new check to Malik Law, on July 31, 2018, check #125 for \$660.63, which was promptly mailed to their address in Maitland, Florida. Malik Law cashed the check on August 3, 2018. **SEE EXHIBIT 7.** I received a called on August 3, 2018 from Candidate Services Liason Enjoli White with the Hillsborough County Supervisor of Elections regarding my late report. I explained to her the above circumstances. She informed me that I would be unable to file my termination report until my bank account was a zero balance. After the \$600.00 was returned, I repeatedly requested the recipient of the last check #111 to cash that check; however, that check was not cashed until August 7, 2018. **SEE EXHIBIT 8.** After that last check was cashed, I immediately closed the account with the remaining funds being returned to me as my pro rata share of the remaining contributions. **SEE EXHIBIT 9.**

I immediately filed my termination report. SEE EXHIBIT 1.

I am asking for consideration of all mitigating factors applicable under Florida Statutes section 106.265(2). In particular the following subsections:

(a) ommission due to bank error--unable to distribute excess contributions by

(b) no prior acts in more than twenty-three years of public service as a County

(d) good faith shown in attached exhibits of intent to timely comply

I am asking for a full waiver of all fines/fees due to the SunTrust bank error and my immediate efforts to remedy the error.

Dear Judge Ober,

Your campaign treasurer's TR report, which was due on August 2, 2018 was not received as of midnight on the due date.

Florida Statute 106.07 states any candidate failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first three days late and, thereafter, \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding the primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report. All fines must be paid from the candidate's personal funds – not campaign funds.

The Amount of your fine is \$1,150 based on your report having been five days late. Fines must be paid to the filing officer within 20 days of receipt of the payment due notice.

Section 106.265(1), Florida Statues, authorizes the Florida Elections Commission to impose a civil penalty up to \$1,000 per count for each willful violation of Chapter 106.

Section 106.07(8)(c), Florida Statues, states that in the case of an unusual circumstance surrounding the failure to file on the designated due date, each candidate or committee will have the option to file an appeal with the Florida Elections Commission. It is the responsibility of the candidate or committee to notify the filing officer in writing of his or her intention to submit an appeal. Any such requests shall be made within 20 days after receiving the notice of payment due.
