Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

**If you are the Respondent**, you may attend the hearing, and you or your attorney will have 5 minutes to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

**If you are the Complainant**, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

**If you are an Appellant**, and you have requested a hearing, you may attend the hearing, and you or your attorney will have 5 *minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, he must provide the Commission with written proof of his financial resources at the hearing. A financial affidavit form is available from the Commission Clerk.

**SUMMARY:** ABC PAC is a political committee (PC) registered with the State of Florida. The PC's chair is Peter M. Dyga and its treasurer is Carol Bowen.

The PC is appealing the fine claiming that unusual circumstances existed that caused the 2016 G3 Report to be untimely filed. According to Ms. Bowen, she had evacuated to Boston, Massachusetts to avoid Hurricane Matthew and was unable to go through her records to verify if any financial activity occurred during the 2016 G3 reporting period, until she returned and her office opened back up on October 10, 2016. Ms. Bowen filed a waiver on 10/6/16. "I apologize that these circumstances have led to a proposed fine, but I believe that faced with the unusual circumstances of Hurricane Matthew, its ever changing track, the increased projections of the dangers and the proposed devastation, and of the ever constant recommendations to evacuate before it's too late, that I did the best I could to file by the deadline, and then to acknowledge my error and rectify the situation immediately upon the return to normalcy, the morning of October 10<sup>th</sup>".

- The 2016 G3 Report covers the time period from 9/24/16 through 9/30/16.
- The 2016 G3 Queued-Transactions Report reflects that this report was created on 10/6/16 at approximately 8:22 am, before being filed on 10/6/16 at approximately 8:24 am.<sup>2</sup>
- In a 1/31/17 email with Kristi Reid-Bronson, FEC staff was informed, "The committee filed a notice of no activity (waiver) on 10/6/16. A waiver is not a report. On 10/10/16, the committee filed a report showing \$03000.00 of activity. The fine is based on the report being 3 days late".

Peter,

This email is in regards to the letter received from the Department of State regarding the ABC PAC 112. The letter states that I filed the 2016 G3 report passed the October 7, 2016 deadline. This email is to explain the circumstances surrounding the filing of the 2016 G3 report, and to provide you with the ability to appeal the imposition of fines directly to the Florida Elections Commission.

- (1) On October 3, 2016 Governor Scott began issuing warnings to the residents of Florida regarding Hurricane Matthew and the potential turn towards our state, specifically the Southeastern corridor of the state.
- (2) Our office is located in Broward County.
- (3) On October 4, 2016 Governor Scott increased the severity of his warnings encouraging those in certain areas, who experience flooding, to begin dealing with evacuation plans.
- (4) My family and I live in Boca Raton just outside of Deerfield Beach/Hillsboro Boulevard where the new projections had the storm entering our state. My husband made the decision to send my seven year old and me to Boston to stay with my family.
- (5) On October 5, 2016 our office began the process of shutting down and sending people home. I was in Boston during this time.
- (6) On October 5, 2016 I realized I could not remotely access our campaign toolbox files we utilize for tracking our contributions and expenditures for PAC 112.
- (7) On October 5, 2016 I contacted my point of contact with Campaign Toolbox to see if he could provide me with a link to our accounts. This is not a service campaign toolbox provides.
- (8) On October 5, 2016 I began going through old emails and communications regarding our check cutting to try and recall when I had cut checks and to which candidates.
- (9) Based on my recollection, I did not believe there had been any action on the account for the period covered by the G3 report.
- (10)I filed a waiver, due to my belief of lack of activity, prior to the end of the October 7<sup>th</sup> deadline.
- (11)Our office remained closed until October 10<sup>th</sup>.
- (12)The morning of October  $10^{\circ}$  I went through campaign toolbox and my files and realized I had been in error. I called the division of elections and asked for instructions on how to amend a report that had initially been filed as a waiver.
- (13)I filed an amended report on October 10th.

I apologize that these circumstances have led to a proposed fine, but I believe that faced with the unusual circumstances of Hurricane Matthew, its ever changing track, the increased projections of the dangers and the proposed devastation, and of the ever constant recommendations to evacuate before it's too late, that I did the best I could to file by the deadline, and then to acknowledge my error and

rectify the situation immediately upon the return to normalcy, the morning of October 10<sup>th</sup>.
