This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

If you are the Respondent, you may attend the hearing, and you or your attorney will have 5 minutes to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have 5 *minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, he must provide the Commission with written proof of his financial resources at the hearing. A financial affidavit form is available from the Commission Clerk.

ORDER OF PROBABLE CAUSE

THIS MATTER was heard by the Florida Elections Commission (Commission) at its regularly scheduled meeting on August 17, 2016, in Tallahassee, Florida.

Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation(s):

Count 1:

On or around June 10, 2014, Mollie O'Dell Moore violated Section 106.19(1)(c), Florida Statutes, when she deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2014 M5 Report.

Count 2:

On or around February 11, 2015, Mollie O'Dell Moore violated Section 106.19(1)(c), Florida Statutes, when she deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2015 Termination Report.

Count 3:

On or around April 30, 2015, Mollie O'Dell Moore violated Section

106.19(1)(c), Florida Statutes, when she falsely reported information required by Chapter 106, Florida Statutes, on the campaign's amended 2014 M5 Report.

Count 4:

On or around April 30, 2015, Mollie O'Dell Moore violated Section 106.19(1)(c), Florida Statutes, when she falsely reported information required by Chapter 106, Florida Statutes, on the campaign's amended 2015 Termination Report.

Count 5:

On or about March 14, 2015, Mollie O'Dell Moore violated Section 106.07(2)(b)1., Florida Statutes, when she failed to file an addendum to the campaign's 2014 M5 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 6:

On or about March 14, 2015, Mollie O'Dell Moore violated Section 106.07(2)(b)1., Florida Statutes, when she failed to file an addendum to the campaign's 2015 Termination Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by <u>consent order</u> where you and Commission staff agree to resolve the violation(s)s and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an <u>informal hearing</u> held before the Commission, if you <u>do not</u> dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to make written or oral arguments to the Commission concerning the legal issues related to the violation(s) and the potential fine. At the request of Respondent, the Commission will consider and determine willfulness at an informal hearing. Otherwise, live witness testimony is unnecessary.

Third, you may request a <u>formal hearing</u> held before an administrative law judge in the Division of Administrative Hearings (DOAH), if you dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to present evidence relevant to the violation(s) listed in this order, to cross-examine opposing witnesses, to impeach any witness, and to rebut the evidence presented against you.

If you do not elect to resolve the case by consent order or request a formal hearing at the DOAH or an informal hearing before the Commission within 30 days of the date this Order of Probable Cause is filed with the Commission, the case will be sent to the Commission for a formal or informal hearing, depending on whether the facts are in dispute. The date this order was filed appears in the upper right-hand corner of the first page of the order.

STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating **Sections 106.07(2)(b)1., and 106.19(1)(c), Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on June 17, 2016, the following facts and law support this staff recommendation:

- 1. On April 9, 2015, the Florida Elections Commission ("Commission") received a referral from the Department of State, Division of Elections ("Division"), alleging that Mollie O'Dell Moore ("Respondent") violated Chapter 106, Florida Statutes.
- 2. Respondent was the treasurer for Bruno Moore, a 2014 candidate for State Senator, District 32.
- 3. By letter dated May 29, 2015, the Executive Director notified Respondent that Commission staff would investigate the following statutory provisions:

Section 106.07(2)(b)1., Florida Statutes: Respondent, treasurer for Bruno Moore, 2014 candidate for Florida Senate, District 32, failed to timely make necessary amendments to the campaign's 2015 M5 and TR reports, as alleged in the complaint.¹

Section 106.19(1)(c), Florida Statutes: Respondent, treasurer for Bruno Moore, 2014 candidate for Florida Senate, District 32, falsely reported or deliberately failed to include information required by Chapter 106, Florida Statutes.

4. On December 23, 2013, Bruno Moore filed his Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates form ("DS-DE 9") appointing Respondent as treasurer for his campaign. (ROI Exhibit 2, page 1)²

¹ The reference to the 2015 M5 reporting period in the letter finding legal sufficiency is a scrivener's error. The Division's referral and supporting documentation alleges violations occurring during the 2014 M5 and 2015 Termination reporting periods. Therefore, the scope of the investigation was limited to the 2014 M5 and 2015 Termination reporting periods consistent with the Division's referral.

² The Report of Investigation is referred to herein as "ROI."

- 5. By letter dated December 23, 2013, Kristi Reid Bronson, Chief, Bureau of Election Records, sent Bruno Moore a letter acknowledging that the Division had received his DS-DE 9 and that his name was placed on the 2014 active candidate list. (ROI Exhibit 3, page 1) A copy of the acknowledgment letter was sent to Respondent. (ROI Exhibit 3, page 3)
- 6. The acknowledgment letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system ("EFS"), and provided Respondent with a user identification number and initial password to grant access to the EFS. (ROI Exhibit 3, page 1) The letter further advised Respondent that all of the Division's publications and reporting forms were available on its website and directed Respondent to print out the 2013 Calendar of Reporting Dates as well as other relevant documents. (ROI Exhibit 3, page 3)

Alleged Violation: Section 106.19(1)(c), Florida Statutes

- 7. Complainant alleged that Respondent violated Florida's election laws by falsely reporting or deliberately failing to include information required by Chapter 106, Florida Statutes. The reporting periods at issue are the 2014 M5 (May 1, 2014 May 31, 2014) and the 2015 Termination reporting periods (November 5, 2014 February 2, 2015). Respondent's 2014 M5, and 2015 Termination reports were filed on June 10, 2014, and February 11, 2015, respectively. Respondent's amended 2014 M5, and amended 2015 Termination reports were filed on April 30, 2015.
- 8. A subpoena was issued to Respondent's designated campaign depository to ascertain whether any contributions were received or expenditures were made during the relevant reporting periods which were not reported or falsely reported.
- 9. A summary of the unreported financial activity that took place during the campaign's 2014 M5 reporting period is shown in Table 1, below. (ROI Exhibits 7 & 11)

- 12. Respondent was given multiple opportunities to respond to Commission staff's investigation by filing a sworn statement with the Commission, but failed to do so.
- 13. Respondent's bank records reflect 23 contributions and expenditures totaling \$970.34 that Respondent failed to disclose on the campaign's 2014 M5 and 2015 Termination reports. (ROI Exhibits 7, 8, 11, & 12)

⁵ The financial activity was falsely reported in the amended 2014 M5 Report and the amended 2015 Termination Report. Therefore, the date of the violations is the date the amended reports were filed.

- 14. Additionally, Respondent's bank records do not reflect the 12 contributions and expenditures totaling \$2,927.33 as disclosed on the campaign's amended 2014 M5 and amended 2015 Termination reports. (ROI Exhibits 7, 8, 11, & 12)
- 15. Respondent deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2014 M5 and 2015 Termination reports. Respondent falsely reported information required by Chapter 106, Florida Statutes, on the campaign's amended 2014 M5 and amended 2015 Termination reports.

Alleged Violation: Section 106.07(2)(b)1., Florida Statutes

- 16. Complainant alleged that Respondent violated Florida's election laws by failing to file the required amendments to the campaign's 2014 M5 and 2015 Termination reports within seven days of receiving notification from the Division that the reports were incomplete and required amendment.
- 17. Respondent's 2014 M5, and 2015 Termination reports were filed on June 10, 2014, and February 11, 2015, respectively. (ROI Exhibit 10, page 1) The reports were incomplete when filed.
- 18. The Division sent two letters notifying Respondent that the campaign's reports were incomplete and that Respondent was required to amend the reports within seven days of receipt of the notification. An Error Report showing why each report was incomplete was attached to each notification. (ROI Exhibits 4 & 5) The final notification was confirmed delivered. (ROI Exhibit 5, page 6) As of June 15, 2016, Respondent had not filed the required amendments to the campaign's reports. (ROI Exhibit 9)
- 19. Respondent was given multiple opportunities to respond to Commission staff's investigation by filing a sworn statement with the Commission, but failed to do so.
- 20. Respondent failed to file the required amendments to the campaign's 2014 M5 and 2015 Termination reports within seven days of receiving notification from the Division that the reports were incomplete and required amendment.
- 21. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).
- 22. The facts set forth above show that Respondent was the treasurer for Bruno Moore, a 2014 candidate for State Senator, District 32. Respondent deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2014 M5 and 2015

Termination reports. Respondent falsely reported information required by Chapter 106, Florida Statutes, on the campaign's amended 2014 M5 and amended 2015 Termination reports. Respondent failed to file the required amendments to the campaign's 2014 M5 and 2015 Termination reports within seven days of receiving notification from the Division that the reports were incomplete and required amendment.

Based upon these facts and circumstances, I recommend that the Commission find **probable cause** to charge Respondent with violating the following:

Count 1:

On or around June 10, 2014, Mollie O'Dell Moore violated Section 106.19(1)(c), Florida Statutes, when she deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2014 M5 Report.

Count 2:

On or around February 11, 2015, Mollie O'Dell Moore violated Section 106.19(1)(c), Florida Statutes, when she deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2015 Termination Report.

Count 3:

On or around April 30, 2015, Mollie O'Dell Moore violated Section 106.19(1)(c), Florida Statutes, when she falsely reported information required by Chapter 106, Florida Statutes, on the campaign's amended 2014 M5 Report.

Count 4:

On or around April 30, 2015, Mollie O'Dell Moore violated Section 106.19(1)(c), Florida Statutes, when she falsely reported information required by Chapter 106, Florida Statutes, on the campaign's amended 2015 Termination Report.

Count 5:

On or about March 14, 2015, Mollie O'Dell Moore violated Section 106.07(2)(b)1., Florida Statutes, when she failed to file an addendum to the campaign's 2014 M5 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Count 6:

On or about March 14, 2015, Mollie O'Dell Moore violated Section 106.07(2)(b)1., Florida Statutes, when she failed to file an addendum to the campaign's 2015 Termination Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

On April 9, 2015, the Florida Elections Commission received information from the Division of Elections (DOE) alleging that Respondent violated Chapter 106, Florida Statutes. The Commission staff investigated whether Respondent violated the following statutes:

Section 106.07(2)(b)1, Florida Statutes, failure of a campaign treasurer of a candidate to file an addendum to an incomplete report after receiving notice from the filing officer; and

Section 106.19(1)(c), Florida Statutes, prohibiting a person or organization from falsely reporting or deliberately failing to report information required by Chapter 106, Florida Statutes.

I. Preliminary Information:

- 1. Respondent was the campaign treasurer for the 2014 election campaign of Bruno Moore. This was Respondent's first-time serving as a campaign treasurer. Mr. Moore was defeated in his bid for election.
 - 2. Complainant is the Division of Elections.
- 3. Respondent's filing officer is Kristi Reid-Bronson, Chief, Bureau of Election Records.

II. Alleged Violation of Section 106.07(2)(b)1, Florida Statutes:

- 4. I investigated whether Respondent violated this section of the election laws by not filing addendums to the 2014 M5 and 2015 TR Reports, after receiving notice from the filing officer that they were incomplete.
- 5. On April 9, 2015, DOE staff representative, Kristi Reid-Bronson, submitted a sworn affidavit regarding Respondent's failure to amend the 2014 M5 and 2015 TR Reports. To review the April 9, 2015 sworn affidavit, refer to exhibit 1.
- 6. On December 23, 2013, Mr. Bruno Moore filed his Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 9) with his filing officer. Mr. Moore appointed Respondent as his campaign treasurer. To review a copy of the DS-DE 9 form appointing Respondent as campaign treasurer, refer to exhibit 2.

- 7. On December 23, 2013, Complainant mailed the campaign a letter acknowledging receipt of the DS-DE 9 form. This letter also informed the campaign of the confidential "PIN" number to access the Division of Election's electronic filing system (EFS) to submit campaign treasurer's reports and waivers. To review a copy of the December 23, 2013 acknowledgement letter, refer to exhibit 3.
- 8. On February 13, 2015, Complainant mailed Respondent a letter informing her that the 2014 M5 and 2015 TR Reports were incomplete. Complainant attached a list of errors to this letter that specifically stated the errors that required amending. This letter was sent to the address provided on the DS-DE 9 form (Exhibit 2). To review a copy of the February 13, 2015 letter, refer to exhibit 4.
- 9. On March 2, 2015, Complainant mailed Respondent a "Final Notice" via certified mail that the 2014 M5 and 2015 TR Reports were incomplete. Complainant also attached a list of errors to this letter that specifically stated the errors that required amending. This letter was also sent to the address provided on the DS-DE 9 form (Exhibit 2). To review a copy of the March 2, 2015 "Final Notice" letter with delivery confirmation receipt, refer to exhibit 5.
- 10. On March 25, 2015, Complainant contacted the candidate, Bruno Moore, to advise him that the 2014 M5 and 2015 TR Reports had not been amended and remained incomplete. To review notes from the Division regarding this contact, refer to exhibit 6.
- 11. On April 30, 2015, records from the DOE reflect that the 2014 M5 Report and the 2015 TR Report were both amended. These reports were certified to be complete and correct. To review a copy of the amended 2014 M5 with the queued-transaction report, refer to exhibit 7. To review a copy of the amended 2015 TR with the queued-transaction report, refer to exhibit 8.
- 12. In a June 17, 2016 email with Kristi Reid-Bronson, FEC staff was advised that the 2014 M5 and 2015 TR Reports remain incomplete. To review the June 17, 2016 email, refer to exhibit 9. To review a copy of Respondent's filing history, refer to exhibit 10.
- 13. There is no record that Respondent has previously violated this section of the election laws.

III. Alleged Violation of Section 106.19(1)(c), Florida Statutes:

- 14. I investigated whether Respondent violated this section of the election laws by falsely reporting or deliberately failing to include information required by Chapter 106, Florida Statutes.
- 15. On January 5, 2016, I subpoenaed the campaign account records for Bruno Moore from TD Bank, the campaign depository listed on Mr. Moore's DS-DE 9 form (Exhibit 2)¹. To review the campaign depository records that are associated with the 2014 M5 reporting period, refer to exhibit 11. To review the campaign depository records that are associated with the 2015 TR reporting period, refer to exhibit 12. The information that was located during the review of the records from the campaign depository will be displayed in the following tables.

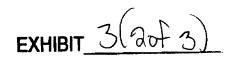
Timely Filing

All reports filed must be completed and filed through the EFS not later than midnight of the due date. Reports not filed by midnight of the due date are late filed and subject to the penalties in Section 106.07(8), Florida Statutes. In the event that the EFS is inoperable on the due date, the report will be accepted as timely filed if filed no later than midnight of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any candidate failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first 3 days late and, thereafter, \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for reports immediately preceding each primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the candidate and campaign treasurer and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.

Dear Ms. Moore:

On April 9, 2015, the Florida Elections Commission received a complaint alleging that you violated Florida's election laws. I have reviewed the complaint and find that it contains one or more legally sufficient allegations. The Commission staff will investigate the following alleged violations:

Section 106.07(2)(b)1., Florida Statutes: Respondent, treasurer for Bruno Moore, 2014 candidate for Florida Senate, District 32, failed to timely make necessary amendments to the campaign's 2015 M5 and TR reports, as alleged in the complaint.

Section 106.19(1)(c), Florida Statutes: Respondent, treasurer for Bruno Moore, 2014 candidate for Florida Senate, District 32, falsely reported or deliberately failed to include information required by Chapter 106, Florida Statutes.

You may respond to the allegations above by filing a notarized statement providing any information regarding the facts and circumstances surrounding the allegations. Your response will be included as an attachment to the investigator's report.

When we conclude the investigation, a copy of the Report of Investigation will be mailed to you at the above address. You may file a response to the report within 14 days from the date the report is mailed to you. Based on the results of the investigation, legal staff will make a written recommendation to the Commission on whether there is probable cause to believe you have violated Chapter 104 or 106, Florida Statutes. A copy of the Staff Recommendation will be mailed to you and you may file a response within 14 days from the date the recommendation is

mailed to you. Your timely filed response(s) will be considered by the Commission when determining probable cause.

The Commission will then hold a hearing to determine whether there is probable cause to believe you have violated Chapters 104 or 106, Florida Statutes. You and the complainant will receive a notice of hearing at least 14 days before the hearing. The notice of hearing will indicate the location, date, and time of your hearing. You will have the opportunity to make a brief oral statement to the Commission, but you will not be permitted to testify or call others to testify, or introduce any documentary or other evidence.

At any time before a probable cause finding, you may notify us in writing that you want to enter into negotiations directed towards reaching a settlement via consent agreement.

The Report of Investigation, Staff Recommendation, and Notice of Hearing will be mailed to the above address as this letter. Therefore, if your address changes, you must notify this office of your new address. Otherwise, you may not receive these important documents. Failure to receive the documents will not delay the probable cause hearing.

Under section 106.25, Florida Statutes, complaints, Commission investigations, investigative reports, and other documents relating to an alleged violation of Chapters 104 and 106, Florida Statutes, are confidential until the Commission finds probable cause or no probable cause. The confidentiality provision does not apply to the person filing the complaint. However, it does apply to you unless you waive confidentiality in writing. The confidentiality provision does not preclude you from seeking legal counsel. However, if you retain counsel, your attorney must file a notice of appearance with the Commission before any member of the Commission staff can discuss this case with him or her.

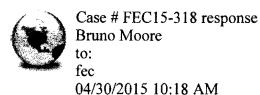

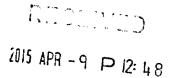

Each candidate is required to provide the Division of Elections with confidential personal information that may be used to allow access in the event this password is forgotten or lost. When you enter the campaign account screen, there will be a drop down box where you pick a question (such as What is your mother's maiden name?) and supply an answer. All passwords and answers to questions are stored as encrypted data and cannot be viewed by Division staff and given out over the phone. Please notify the Division if your credentials have been compromised.

Timely Filing

All reports filed must be completed and filed through the EFS not later than midnight of the due date. Reports not filed by midnight of the due date are late filed and subject to the penalties in Section 106.07(8), Florida Statutes. In the event that the EFS is inoperable on the due date, the report will be accepted as timely filed if filed no later than midnight of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any candidate failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first 3 days late and, thereafter, \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for reports immediately preceding each primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the candidate and campaign treasurer and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.
