NOTICE OF HEARING (AUTOMATIC FINE)

A hearing will be held in this case before the Florida Elections Commission on, **May 14, 2019 at 8:30 am**, or as soon thereafter as the parties can be heard, at the following location: **Senate Office Building, 404 South Monroe Street, Room 110-S, Tallahassee, Florida 32399**. Due to heightened security access requirements, please bring only essential items into the building and plan to arrive early to allow for delays coming through security.

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

If you are the Respondent, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

SUMMARY: New Nation Rising was a political committee (PC) formerly registered with the State of Florida. The PC's chair and treasurer was Shane Ogunnaike. Erza W. Reese, Jacquelyn K. Lopez, and Andrea T. Levin, Esq., are representing the PC in this matter.

The PC is appealing the fine claiming that it did not understand the intricacies of Florida's campaign finance laws. According to Mr. Reese, New Nation Rising ("NNR") began its engagement in Florida using the non-contribution account of its federal PAC and assumed compliance with federal campaign finance law would suffice for its field program in Florida. He states that when NNR registered as a PC in Florida, it registered its entire non-contribution account with the Division of Elections instead of opening a separate bank account for Florida-specific spending. Mr. Reese states that because of this misstep, under Florida law, NNR was required to track and report all its activity taking place across the country. He notes that between October and November, NNR's grassroots program involved hundreds of locally-based canvassers in 14 different counties. As such, it was difficult to gather the information and report on Florida's filing schedule. He states that as soon as the election, recounts, and runoffs were over, NNR worked diligently to collect all the information necessary to file accurate reports. The process was not complete until January for the 2018 M11 report.

- The 2018 M11 Original Report covers the period from 11/02/18-11/30/18; it was due on 12/10/18.
- The 2018 M11 Queued Transaction Report shows that it was created and deleted multiple times before being filed on 01/10/19.
- New Nation Rising reported receiving 3 contributions, while making 475 expenditures.
- The Division of Elections does not have any notes that pertain to New Nation Rising's 2018 M11 report.

To whom it may concern:

We write as counsel to New Nation Rising (“NNR”). On January 25, 2019, NNR received a notice, dated January 23, 2019, from the Division of Elections regarding the late filing of a campaign treasurer’s report. The notice stated that NNR had failed to timely file the report due on December 10, 2018, and, because of the late filing, the Division had automatically imposed a \$14,150.00 fine. We write to appeal the imposition of this fine on the ground that unusual circumstances prevented NNR from timely submitting this report.

NNR is a coalition of community organizers and religious leaders who seek to facilitate a more informed electorate and mobilize historically disengaged voters of color. In 2017, NNR filed a Statement of Organization with the Federal Election Commission to further its mission and engage in election-related political spending. During the 2018 election cycle, NNR put together an ambitious multi-state field program to engage community members in politics and to get out the vote; this program included canvassing in Florida.

Without understanding the intricacies of Florida’s campaign finance laws, NNR began its engagement in Florida using the non-contribution account of its federal PAC and assumed compliance with federal campaign finance law would suffice for its field program in Florida. To that end, when NNR registered as a political committee in Florida, it registered its entire non-contribution account with the Division of Elections instead of opening a separate bank account for Florida-specific spending. Because of this misstep, under Florida law, NNR was required to track and report all of its activity taking place across the country, a situation likely not contemplated by Florida law and its daily-weekly-monthly reporting schedule.

Between October and November, NNR’s grassroots program involved hundreds of locally-based canvassers in 14 different counties. As each field program in each county was maintaining its own records, it was difficult to gather the information and report on Florida’s filing schedule. NNR struggled to balance its competing priorities of conducting a successful multi-state field program and keeping up with the requisite recordkeeping. However, once the elections, recounts, and runoffs were over, NNR worked diligently to collect all the information necessary to file accurate reports with the Division. Unfortunately, that process was not complete until January.

Florida law provides that a “political committee may appeal or dispute [to the Florida Elections Commission a late-filing] fine, based upon, but not limited to, unusual circumstances surrounding the failure to file on the designated due date.” Fla. Stat. § 106.07(8)(c). Once an


appeal has been filed, the Commission "must consider the mitigating and aggravating circumstances contained in s. 106.265(2) when determining the amount of a fine, if any, to be waived." *Id.* Such circumstances include "(a) The gravity of the act or omission; (b) Any previous history of similar acts or omissions; (c) The appropriateness of such penalty to the financial resources of the . . . political committee. . . ; and (d) Whether the . . . political committee . . . has shown good faith in attempting to comply with the provisions of" Florida election law. Fla. Stat. § 106.265.

Further, Florida regulation provides that if the appealing party demonstrates "that there were unusual or other circumstances beyond the control of the . . . committee that caused the report to be filed late," then the Commission must waive the fine. 2 Fla. Admin. Code 2B-1.005(3). The regulations set forth a non-exhaustive list of what constitutes unusual circumstances, but generally defines such circumstances as "uncommon, rare or sudden events over which the actor has no control and which directly result in the failure to act according to the filing requirements," which "must occur within a time period that would clearly prevent the person legally responsible for filing the report from doing so in a timely manner." 2 Fla. Admin. Code 2B-1.0055.

Here, a brand new political committee with an ambitious civic engagement program misunderstood its reporting requirements and, once it realized its mistake, made a good faith effort to speedily ensure that it disclosed all the information it was required to by law. Indeed, its effort was so diligent that it was able to collect the required information and submit its report to the Division in a mere month.

Due to the unusual circumstances surrounding NNR's December campaign treasurer's report, NNR respectfully requests that the Elections Commission waive or reduce the fine imposed by the Division of Elections.

We mailed, via regular mail, the first notice of the failure to file the above-mentioned report or notification to the address on file with our office on December 11, 2018.

The first notice which we provided to you specifically explained the automatic fine provisions in the law (s. 106.07(8)(b), Fla. Stat.) for failure to file a required report. Such fines are continuing to accrue for a late-filed report. Also, that notice explained that if no reportable activity occurred for the report date(s), you are still required to provide notification in writing that no reportable activity occurred. Dear Mr. Ogunnaike:

Our records indicate that you have not filed either your campaign treasurer's report or notification that no reportable activity occurred, whichever is applicable. The filing date was December 10, 2018.

The law (s. 106.07(8)(b), Fla. Stat.) requires the filing officer to immediately notify you about the missed filing date and the automatic fines that will be assessed for late filing of a report, if a report was due.

- If reportable activity occurred and you have not filed a report, statutory fines are automatically assessed as follows until you file your report:
 - \$50 per day for the first 3 days late
 - \$500 per day for each day after the 3rd day late
 - If the required report immediately precedes a primary and general election, the automatic fine is \$500 for each late day.

The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period. Even if you end up filing your report late, we cannot waive the statutory fines. We will notify you of the specific amount of fines owed once you file your report. You have 20 days from the day you receive the notice to pay the fine or to appeal the fine to the Florida Elections Commission.

- If no reportable activity occurred for the report date(s), you are still required to notify us in writing, via the Division's Electronic Filing System, that no reportable activity occurred. No automatic fines are statutorily assessed.

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.



Chapter 6: Campaign Depository

Primary Campaign Depository

A political committee shall designate a primary campaign depository with any bank, savings and loan association, or credit union authorized to do business in the state of Florida. A political committee that deposits all contributions in a national depository is not required to designate a depository in Florida. All contributions must be deposited into such account and all expenditures must be drawn by a check on such account. A political committee must file the name and address of the primary campaign depository with the same officer with whom the political committee registers on Form DS-DE 6 (Appointment of Campaign Treasurer and Designation of Campaign Depository for Political Committees).

The campaign account must be separate from any personal or other account and used only for depositing campaign contributions and making expenditures.

All funds received by the campaign treasurer shall, prior to the end of the fifth business day following the receipt thereof, Saturdays, Sundays, and legal holidays excluded, be deposited in a campaign depository designated pursuant to Section 106.021, F.S., in an account that contains the name of the committee.

Note: Except for contributions to political committees made by payroll deduction, all deposits must be accompanied by a bank deposit slip containing the name of each contributor and the amount contributed by each.

(Sections 106.021(1) and 106.05, F.S.)

Secondary Campaign Depository

A political committee may designate one secondary depository in each county where an election is held in which the committee participates for the sole purpose of depositing contributions for transfer into the primary depository.

A political committee must file the name and address of each secondary campaign depository with the same officer with whom the committee files the name of his or her campaign treasurer on Form DS-DE 6.

If a contribution is deposited in a secondary depository, the depository shall forward the full amount of the deposit, along with a copy of the deposit slip, to the primary depository prior to the end of the first business day following the deposit.

(Section 106.021(1), F.S.)

Separate Interest-Bearing Accounts and Certificates of Deposit

In the event funds are available in the primary campaign depository that are not currently needed for the disbursement of expenditures, the campaign treasurer or deputy campaign treasurer may deposit such funds into a separate interest-bearing account designated as "(Name of Committee) Separate Interest-Bearing Campaign Account" or may purchase a certificate of deposit with the available funds.

Any bank, savings and loan association or credit union authorized to transact business in Florida may be used for this purpose. The separate interest-bearing account or certificate of deposit shall be separate from any personal or other account or certificate of deposit.

13. How long are campaign records kept at the Division of Elections or the supervisor of elections?

Ten years from the date of receipt.

(Sections 98.015(5) and 106.22(4), F.S.)

14. Is there a fee to register as a political committee?

No, there is no fee to register as a political committee.

15. Do you have to be incorporated to start a committee?

The Florida Election Code does not require a person as defined in chapter 106, to incorporate in order to register as a political committee. However, requirements for conducting business in the state may be applicable but are outside the jurisdiction of the Division of Elections. Please contact the Division of Corporations at (850) 245-6052 or visit www.sunbiz.org with any questions.

16. Do I need an Employer Identification Number (EIN) to become a political committee?

The Division of Elections does not require you to obtain an EIN. However, some banks require that you obtain an EIN from the Internal Revenue Service. Contact the IRS at 1-800-829-1040 for additional information.

17. May a Florida political committee make contributions to an out-of-state political entity, a federal political action committee (PAC), a candidate for federal office, or a person seeking selection as the chair of a political party?

No. A Florida political committee must use its funds solely for Florida political activities, *i.e.*, depositing contributions and making expenditures, which by definition in Florida law, are for the purpose of influencing only *Florida* elections. Florida law defines "election" as one held in Florida for the purpose of nominating or electing candidates to "public office," which definition is further limited to state, county, municipal, or school or other district offices or positions that are filled by the vote of the electors. A contribution to an out-of-state political entity, to a federal PAC, to a candidate for federal office (even one running for a federal office from Florida), or to a person seeking selection as the chair of a political party does not fall within the applicable definitions of "election" or "public office." This also means that funds in the Florida political committee's bank account may not be used for the purpose of influencing elections outside of Florida, such as giving funds to candidates in other states or donating funds to an out-of-state political entity or federal PAC.

(Sections 106.011(5), (7), (16), & (17), 106.03, 106.05, 106.07, and 106.11, F.S.)

18. What are the consequences of an out-of-state political entity or a federal political action committee (PAC) contributing to a Florida political committee?

Depending upon the circumstances of how the out-of-state entity, federal PAC, or another state's PAC collects its donations and makes expenditures in Florida, one of two different scenarios could result.

First, an out-of-state political entity or federal PAC, like any other contributor, can give unlimited contributions to one or more Florida political committees, if the out-of-state political entity or federal PAC is not itself receiving "contributions." "Contributions" are defined as only those made for the purpose of influencing the results of a Florida election. An out-of-state political entity or federal PAC that has only received donations that were *not* made for the purpose of influencing the results of Florida elections has not received contributions under Florida law; therefore, it can make contributions to a Florida political committee without having to register as a Florida political committee.

On the other hand, if an out-of-state political entity or federal PAC receives "contributions" as defined above (donations made for the purpose of influencing the results of a Florida election), the out-of-state political entity or federal PAC must register as a Florida political committee. A Florida political committee must maintain a separate bank account solely for Florida political activities (*i.e.*, depositing contributions and making expenditures, which again, by definition, are for the purpose of influencing only Florida elections). All contributions to a Florida political committee must be deposited into that separate bank account.

If the activities of an out-of-state political entity or federal PAC cause it to become a Florida political committee under the chapter 106 definition of "political committee," the Florida political committee's funds may not be commingled with funds from the out-of-state political entity or federal PAC. This means that funds in the Florida political committee's bank account may not be used for the purpose of influencing elections outside of Florida, such as giving funds to candidates in other states or donating funds to an out-of-state political entity or federal PAC.

(Sections 106.011(5), (7), (16), & (17), 106.03, 106.05, 106.07, and 106.11, F.S.)

This is in response to your letter requesting an advisory opinion in answer to substantially the following questions:

1. May one political committee make a contribution to another political committee?
2. Does such an act as described in question 1, constitute making a contribution in violation of s. 106.08(3), F.S., which prohibits making "a contribution in support or opposition to...an issue through or in the name of another directly or indirectly, in any election?"
3. Must political committees, which are supporting or opposing the same statewide issue, maintain separate campaign depositories?

Section 106.011(3), F.S. (1977), defines the term "contribution" for the purposes of Chapter 106 and includes the following act within the meaning of that term:

"(b) A transfer of funds between political committees. . ."

Section 106.021(1), F.S. (1977), requires each political committee to appoint a campaign treasurer and to designate a primary campaign depository. The only exception to these requirements is for those political committees which deposit all contributions in a national depository for subsequent distribution. See s. 106.021(1)(d), F.S. (1977). All contributions received and expenditures made by a political committee are through the committee's duly appointed campaign treasurer, s. 106.021(3), F.S.

The making of contributions to one political committee from another such committee seems clearly contemplated by the election law. The definition of "contribution" includes "A transfer of funds between political committees. . . ." s. 106.011(3)(b), F.S. Furthermore, the statute prescribing limitations on the amount which may be contributed provides:

"No person or political committee shall make contributions to any candidate or political committee in this state, for any election, in excess of . . ." s. 106.08(1), F.S.

Therefore, in answer to your first question, contributions by one political committee to another political committee are permissible, provided they are made through the campaign treasurer and deposited in the receiving committee's primary depository campaign account. Except for political committees supporting or opposing statewide issues, the contribution limitations of s. 106.08(1), F.S., are applicable. It should be noted that an opinion of this office (DE 76-31, October 5, 1976),

previously determined that such contributions between committees of continuous existence were appropriate.

Section 106.08(3), F.S. (1977) states in part:

"(3) No person shall make any contribution. . . in support of or opposition to an issue, or to any political committee, through or in the name of another, directly or indirectly in any election."

Your second question inquires as to whether a contribution from one political committee to another constitutes a contribution given, directly or indirectly, through or in the name of another as prohibited by s. 106.08(3), F.S. This statute is intended to prevent the use of conduits or earmarked contributions in this state. All contributions must be made directly to the recipient committee (or candidate) and may not be forwarded through the account of some third party. (See DE 78-37, August 21, 1978). The delivery of a contribution by a third party is not prohibited provided the contribution is directly made and no commingling of funds occurs such that the contribution comes from some third account prior to deposit in the receiving committee's campaign account. See DE 78-40 (October 5, 1978).

Federal campaign finance laws do permit conduits and earmarking of contributions. Specific language is included there to authorize such handling of contributions:

"all contributions made by a person, either directly or indirectly, on behalf of a particular candidate, including contributions which are in any way earmarked or otherwise directed through an intermediary or conduit to such candidate, shall be treated as contributions from such person to such candidate." 2 U.S.C. s. 441a(b).

The Federal Election Commission has by rule defined "earmarked" as meaning "a designation, instruction, or encumbrance (including those which are direct or indirect, express or implied, oral or written) which results in all or any part of a contribution or expenditure being made to, or expended on behalf of, a clearly identified candidate. . ." 11 C.F.R. 110.6(b). Such provisions are not found in Florida law, and, as a result of such absence, must be considered as indicating the legislature's desire to not authorize such earmarked contributions.

A contribution from one political committee to another political committee as discussed in question 1 with respect to an issue does not constitute a prohibited act under s. 106.08(3), F.S. In that earmarking is not permitted in Florida, a political committee exercises complete direction and control over the funds in its possession. A contribution to a political committee which is earmarked, i.e., clearly understood by the contributor and the first recipient committee to be in turn contributed by that committee to a specified second committee, is not authorized under Florida law and would constitute an indirect contribution given in the name of another s. 106.08(3), F.S. However, in the absence of such earmarking, your second question is answered in the negative.

As previously stated, each political committee is required to designate a primary depository. This campaign account of the political committee is required by law to "be separate from any personal or other account...." s. 106.11(1), F.S. Thus, the commingling of funds of different political committees is

prohibited by Florida law. This is not to say in light of the discussion above in answer to question 1 that a committee may not contribute to another, but rather that two or more political committees may not jointly use the same account for depositing contributions and making expenditures. Accordingly, your third question is answered in the affirmative.

SUMMARY

A political committee may make a contribution to another political committee, and may do so even if both are supporting or opposing the same candidate or issue. In the absence of prohibited earmarking, such contributions do not constitute making an indirect contribution in the name of another. Each political committee is required to designate a separate primary depository and its funds cannot be commingled with those of any other political committee, candidate, or person.

Establishing federal and nonfederal bank accounts

All political committees must register an official committee depository. A committee engaging in both federal and nonfederal election activity has two options:

- Set up one federal account (accepting only contributions subject to the limits and prohibitions of the *Federal Election Campaign Act* (the Act)) to support both federal and nonfederal candidates and report all activity to the FEC; or
- Set up two accounts—one for federal elections and another for state and local elections.

The second option permits the committee to maintain a separate nonfederal account that has no federal registration or reporting obligations. When conducting an activity that relates to both federal and nonfederal elections however, the committee must allocate the costs between the two accounts. Also, please note that any activity (including reporting requirements) by nonfederal accounts is governed by relevant state law. A nonfederal account generally has no reporting obligations with the FEC.

Note: Because PACs established, financed, maintained or controlled by a federal candidate may not accept federally impermissible funds, even those funds in the nonfederal account of a leadership PAC must comply with federal limits and prohibitions. In fact, the total contributions from individuals to the PAC's federal and nonfederal accounts may not exceed \$5,000 per calendar year.

Non-contribution account

Consistent with the *Emily's List v. FEC* and *Carey v. FEC* decisions, the Commission no longer enforces the statutory contribution limits, as well as any implementing regulations, against any nonconnected political committee with regard to contributions from individuals, political committees, corporations, and labor organizations, as long as:

- The committee deposits the contributions into a separate bank account for the purpose of financing independent expenditures, other advertisements that refer to a federal candidate, and generic voter drives (*i.e.*, a non-contribution account);
- The non-contribution account remains segregated from any accounts that receive source-restricted and amount-limited contributions for the purpose of making contributions to candidates; and
- Each account pays a percentage of administrative expenses that closely corresponds to the percentage of activity for that account.

Until such time as the Commission adopts a new regulation, nonconnected political committees that wish to establish a separate non-contribution account consistent with the stipulated judgment in *Carey* should:

- Notify the Commission of their intent to do so, using this form; and
- Report all receipts and disbursements for both accounts pursuant to the Act and Commission regulations, following the specific reporting guidance put out by the Commission on October 5, 2011.
