NOTICE OF HEARING (AUTOMATIC FINE)

A hearing will be held in this case before the Florida Elections Commission on, **February 17, 2016 at 9:00 am, or as soon thereafter as the parties can be heard**, at the following location: **Florida State Conference Center, 555 West Pensacola Street, Room #108, Tallahassee, Florida 32306.**

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

If you are the Respondent, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

SUMMARY: North Beach Neighbors Alliance is a political committee (PC) registered with the City of Miami Beach, Florida. The PC's chair and treasurer is Brad Bonessi.

The PC is appealing the fine claiming that unusual circumstances existed that caused the report to be untimely filed. According to Mr. Bonessi, "We live at 7330 Ocean Terrace and the items that had been sent to our building did not have my signature for Proof of Delivery nor the front desk and I did receive it two weeks later and hence missed the dates to send in the campaign itemized treasury report on time. I went to City Hall and the city clerk, Rafael Granado was very helpful and he explained exactly what I had to do and I then did the summary report and he explained that I would be fined, but that I could appeal to "Florida Election commission" and I'm hoping you will be understanding that this was the first time we ever ran a campaign and hopefully my last. Thank you so much for understanding this in advance".

- The 2015 G3 Report covers the time period from 10/17/15 through 10/29/15.
- The PC reported receiving 12 contributions, while making 4 expenditures during this reporting period.

PRIOR CASES: This PC is currently being investigated for the alleged late filing of an additional campaign report. Case #15-515 will also be heard during the February 2016 Commission meeting

To: Florida Election commission pursuant 106.07(8)(C),

We are writing you today to appeal the fine that we received for the 2015-G3 and the 2015-R2 in the amount of \$1,978.61. We are a grassroots organization called "North Beach Neighbors Alliance" which we registered on October 21st 2015. Because we had never had run a political campaign and we needed to add this to our lawn signs, which we did not know until after the fact. The campaign was "Save Ocean Terrace" to help preserve the small Ocean side area from being overdeveloped and we took on the Developer "Ocean Terrace LLC" that spent \$800,000 (compared to our \$7,000) on his campaign and we won the ballot question with 55% against 45% of the vote.

We live at 7330 Ocean Terrace and the items that had been sent to our building did not have my signature for Proof of Delivery nor the front desk and I did receive it two weeks later and hence missed the dates to send in the campaign itemized treasury report on time.

I went to City Hall and the city clerk, Rafael Granado was very helpful and he explained exactly what I had to do and I then did the summary report and he explained that I would be fined, but that I could appeal to "Florida Election commission" and I'm hoping you will be understanding that this was the first time we ever ran a campaign and hopefully my last.


This letter is to inform you that your Campaign Reports 2015-G3; 2015-R1; and 2015-R2 were received on **November 20, 2015**, but were all filed late. The 2015-G3 report was due on October 30, 2015 (**21 days late**), the 2015-R1 report was due on November 6, 2015 (**14 days late**), and the 2015-R2 report was due on November 13, 2015 (**7 days late**).

Pursuant to Florida Statutes §106.07(8)(b), upon determining that a report is late, the filing officer shall immediately notify the candidate or chair of the political committee as to the failure to file a report by the designated due date and that a fine is being assessed for each late day. The fine shall be \$50 per day for the first 3 days late and, thereafter, \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures; whichever is greater, for the period covered by the late report. However, for the reports immediately preceding each special primary election, special election, primary election, and general election, the fine is \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

The fine, according to this calculation, is \$1,637.50 for the 2015-G3 report; \$0.00 for the 2015-R1 report; and \$341.11 for the 2015-R2 report. **The total fine is \$1,978.61.** This fine is payable to the City of Miami Beach, c/o Office of the City Clerk, 1700 Convention Center Drive, Miami Beach, Florida 33139, and made payable to the City of Miami Beach within 20 days after receipt of the notice of payment due, unless appeal is made to the Florida Elections Commission pursuant to §106.07(8)(c). 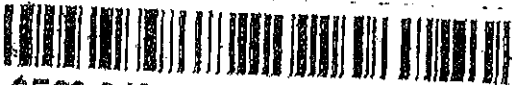

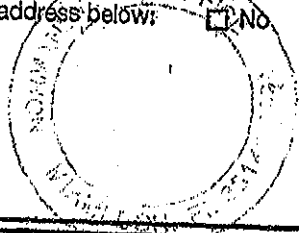
