**SUMMARY:** Tiger Pride is a political committee (PC) registered with the State of Florida. The PC's chair is Donald Peace and its treasurer is Cheryl Vinson.

The PC is appealing the fine claiming that their organization was undergoing a staff change as their previous bookkeeper of 4 years, Brenda Weinzel, left abruptly. According to Mr. Peace, Ms. Weinzel was the only person who knew how to complete and file campaign reports. He states that after her departure, they scrambled to figure out how to file and had their treasurer, Cheryl Vinson, complete the report and file it on August 14<sup>th</sup>. He notes that they have since hired a new bookkeeper.

- The 2018 P5 Original Report covers the period from 07/28/18-08/03/18; it was due on 08/10/18.
- The 2018 P5 Queued Transaction Report shows that it was created on 08/01/18 and filed on 08/14/18 at approximately 9:06pm.
- Tiger Pride reported receiving zero contributions, while making 3 expenditures.
- The Division of Elections has 1 note dated 08/03/18 that pertains to Tiger Pride's 2018 P5 report.

To Whom It May Concern;

I am writing this letter to appeal the fine of \$375 issued on August 22, 2018 (see enclosed copy of letter). Our organization, United School Employees of Pasco, was undergoing a staff change, as our previous bookkeeper of 4 years, Brenda Weinzetl, left employment on July, 25, 2018. She was the person who was responsible in our organization to file the Tiger Pride campaign treasurer's reports, and quite frankly, the only one who knew how to complete them.

After her abrupt exit, we scrambled to find out the details of how to file, and had our Treasurer, Cheryl Vinson, a full-time teacher, attempt to complete the report. Cheryl completed the report and filed it on August 14, 2018, two business days late.

On August 13, 2018, we hired a new bookkeeper, Tania Hensley, who has been briefed on the requirements of campaign filing, and has completed that process with-out neglect to date.

We did not neglect filing the proper information, but we did have a break in service of our staff which complicated the filing process. Due to the size of our organization (staff of 8 people), we did the best we could under the circumstances to meet the guidelines provided, albeit two days late. In light of the fact that we were caught unaware of this bookkeeper transition, and the fact that we were able to file as quickly as we did, I am asking for a waiver of this fine. We, as an organization, have been here for over 40 years, and have complied with election law in a timely manner before this transition, and have met obligations since the transition, proving we are responsible, when staffed. Please understand our plight and see fit to grant this request of waiver.

Dear Ms. Blankenship:

Our records indicate that you have not filed either your campaign treasurer's report or notification that no reportable activity occurred, whichever is applicable. The filing date was August 10, 2018.

The law (s. 106.07(8)(b), Fla. Stat.) requires the filing officer to immediately notify you about the missed filing date and the automatic fines that will be assessed for late filing of a report, if a report was due.

- If reportable activity occurred and you have not filed a report, statutory fines are automatically assessed as follows until you file your report:
  - \$50 per day for the first 3 days late
  - \$500 per day for each day after the 3rd day late
  - If the required report immediately precedes a primary and general election, the automatic fine is \$500 for each late day.

The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period. Even if you end up filing your report late, we cannot waive the statutory fines. We will notify you of the specific amount of fines owed once you file your report. You have 20 days from the day you receive the notice to pay the fine or to appeal the fine to the Florida Elections Commission.

- If no reportable activity occurred for the report date(s), you are still required to notify us in writing, via the Division's Electronic Filing System, that no reportable activity occurred. No automatic fines are statutorily assessed.

However, in all cases, failure to file and/or untimely filing of a report of reportable activity, or if applicable, a notice that no reportable activity occurred, may constitute an apparent violation of chapter 106, Fla. Stat. If we refer such matter to the Florida Elections Commission, the Commission may subsequently impose a civil penalty for each violation under chapter 106.265(1), Fla. Stat.

She said she had already refunded the money back in to the account and wanted help showing that refund.			
I guided her through listing it as a negative amount refund in the P2 report. I also explained that she is required to send in a letter of explanation for the expenditure and refund. I stressed that she needed to be as detailed as possible in the letter.
