ORDER OF PROBABLE CAUSE

THIS MATTER was heard by the Florida Elections Commission (Commission) at its regularly scheduled meeting on May 17, 2017, in Tallahassee, Florida.

On March 29, 2017, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff's Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation(s):

Count 1:

On or about September 22, 2016, Respondent violated Section 106.07(7), Florida Statutes, when Respondent failed to notify the filing officer on the prescribed reporting date for the 2016 Termination Report that no report would be filed because Respondent had not received funds, made contributions, or expended reportable funds during the 2016 termination reporting period.

The Commission also finds there is no probable cause to charge Respondent with violating Sections 106.141(1) and 106.19(1)(c), Florida Statutes.

NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by <u>consent order</u> where you and Commission staff agree to resolve the violation(s)s and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an <u>informal hearing</u> held before the Commission, if you <u>do not</u> dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the complaint in this case recommending that there is **probable cause** to charge Respondent with violating Section 106.07(7), Florida Statutes, and **no probable cause** to charge Respondent with violating Section 106.141(1) and 106.19(1)(c), Florida Statutes. Based upon a thorough review of the Report of Investigation submitted on March 15, 2017, the following facts and law support this staff recommendation.

1. On October 21, 2016, the Florida Elections Commission ("Commission") received a referral from the Division of Elections ("Division") alleging that Randi Marie Doan ("Respondent") violated Chapter 106, Florida Statutes.

2. Respondent was a candidate for State Representative, District 27, in the 2016 election. She did not qualify. Respondent's Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates form was filed with the Division on March 14, 2016. Respondent appointed herself as her own campaign treasurer and designated Bank of America as her campaign depository. (ROI Exhibit 1 and Attachment A)¹

3. On February 8, 2017, the Executive Director sent Respondent notification that Commission staff would investigate the following sections of law:

Section 106.07(7), Florida Statutes: As alleged in the complaint, Respondent, a 2016 candidate for State Representative, may have failed to notify the filing officer on the prescribed reporting date that no report would be filed on that date because she had not received funds, made contributions, or expended reportable funds during the 2016 termination reporting period.

Section 106.141(1), Florida Statutes: As alleged in the complaint, Respondent, a 2016 candidate for State Representative, failed to timely file her 2016 Termination Report reflecting the disposition of all remaining campaign funds.

¹ The Report of Investigation shall be referred to herein as "ROI."

Section 106.19(1)(c), Florida Statutes: As alleged in the complaint, Respondent, a 2016 candidate for State Representative, may have falsely reported or deliberately failed to include information in her 2016 Termination Report, as required by Chapter 106, Florida Statutes.

4. By letter dated March 15, 2016, Kristi Bronson, Chief, Bureau of Election Records, notified Respondent that her name had been placed on the 2016 active candidate list. The letter advised Respondent that all candidates who file reports with the Division are required to use the electronic filing system ("EFS") and provided Respondent with a user identification number and initial password to access the EFS. (ROI Exhibit 2, page 1)

5. Ms. Bronson's March 15, 2016 letter further advised Respondent that all the Division's publications and reporting forms were available on the Division's website and directed Respondent to print a copy of the *Candidate and Campaign Treasurer Handbook* ("Handbook") and the *Calendar of Reporting Dates* as well as other documents. (ROI Exhibit 2, page 3)

6. Section 106.07(7), Florida Statutes, provides:

Notwithstanding any other provisions of this chapter, in any reporting period during which a candidate or political committee has not received funds, made any contributions, or expended any reportable funds, the filing of the required report for that period is waived. However, the next report filed must specify that the report covers the entire period between the last submitted report and the report being filed, and any candidate or political committee not reporting by virtue of this subsection on dates prescribed elsewhere in this chapter shall notify the filing officer in writing on the prescribed reporting date that no report is being filed on that date. (Emphasis added)²

7. Respondent's 2016 Termination Report ("TR") reflecting the disposition of all remaining funds in Respondent's campaign account was due on September 22, 2016. Respondent failed to timely file a 2016 TR or notification that no reportable activity occurred. (Section 106.141(1), Florida Statutes; Attachment C; and Attachment D)

8. On September 23, 2016, the Division sent Respondent notification that she had not filed her 2016 TR or notice that no reportable activity occurred, whichever was applicable. (ROI Exhibit 3)

² The requirement to file a notice of no reportable activity for a reporting period in which a candidate did not receive funds, make any contributions, or expend any reportable funds is also explained on page 47 of the Handbook. (Attachment B)

9. On October 3, 2016, the Division sent a letter to Respondent marked "Final Notice." The notification stated that the Division had not yet received Respondent's 2016 TR or notice that no reportable activity occurred, whichever was applicable. The Division's October 3, 2016 letter was confirmed delivered on October 5, 2016. (ROI Exhibit 4)

10. Investigator Smith subpoenaed copies of Respondent's campaign bank records from Respondent's campaign depository. On February 14, 2017, Bank of America notified the Commission it was unable to locate any accounts or records requested with the information provided. Because Respondent did not have a campaign account, it appears Respondent did not accept any contributions or make any expenditures during the 2016 termination reporting period. (ROI Exhibit 5 and Attachment E)

11. During a March 3, 2017 telephone call, Respondent told Investigator Smith that she had difficulty understanding the filing of certain documents with the Division and when she called them for assistance, they were "not very helpful" so she did not pursue the matter. (Attachment F, Phone Log Entry 1)³

12. As of March 23, 2017, Respondent has failed to file a 2016 Termination Report or notice of no reportable activity for the 2016 termination reporting period. (Attachment D)⁴

13. Based on the information above, it appears Respondent was not required to file a 2016 Termination Report. It also appears Respondent failed to notify the filing officer in writing on the prescribed due date for the 2016 Termination Report that she would not be filing a report because she did not receive funds, make contributions, or expend any reportable funds during the 2016 termination reporting period.

14. "Probable Cause" is defined as a reasonable ground of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So.2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So.2d 305, 309 (Fla. 1st DCA 1995).

³ Pages 12, 13, 45, and 46 of the *Candidate EFS User's Guide* ("Guide") explain the steps a candidate should take to notify the Division in writing on the prescribed reporting date that no report will be filed for the reporting period using the EFS. Specifically, at the top of page 13, the Guide states that if the report is a "waiver of report (no activity)," the user should click the box next to "Waiver." (Attachment G)

⁴ Respondent successfully filed notices of no activity for three reporting periods prior to the reporting period at issue in this case. (ROI Exhibit 6, page 2 and Attachment D)

15. The above facts show Respondent was a candidate for State Representative, District 27, in the 2016 election. Respondent did not qualify. Respondent's 2016 Termination Report was due on September 22, 2016, however, Respondent failed to timely file a 2016 Termination Report or notice that no reportable activity occurred. Respondent's campaign depository was unable to locate any accounts or records for Respondent's campaign so it appears Respondent did not accept any contributions or make any expenditures during the 2016 termination reporting period.

16. The above facts also show that Respondent was not required to file a 2016 Termination Report. However, Respondent was required to file a notice that no reportable activity occurred during the 2016 termination reporting period on the prescribed due date for the 2016 Termination Report. As of March 23, 2017, Respondent has not filed a 2016 Termination Report or notice of no reportable activity for the 2016 termination reporting period.

Based on the foregoing, I recommend the Commission find probable cause to charge Respondent with the following violation:

Count 1:

On or about September 22, 2016, Respondent violated Section 106.07(7), Florida Statutes, when Respondent failed to notify the filing officer on the prescribed reporting date for the 2016 Termination Report that no report would be filed because Respondent had not received funds, made contributions, or expended reportable funds during the 2016 termination reporting period.

I further recommend the Commission find no probable cause to charge Respondent with violating Sections 106.141(1) and 106.19(1)(c), Florida Statutes.

Candidate & Campaign Treasurer Handbook

An individual seeking a publicly elected position on a political party executive committee who receives a contribution or makes an expenditure must file a single report of all contributions and expenditures on the 4th day immediately preceding the primary election. (See <u>Chapter 18, Reporting</u> for Individuals Seeking a Publicly Elected <u>Position on a Party Executive Committee.</u>)

Unless the electronic filing requirements of Section 106.0705, Florida Statutes, apply, reports shall be filed no later than 5 p.m. of the day designated. A report postmarked by the U.S. Postal Service no later than midnight of the day designated is deemed timely filed. A report received by the filing officer within 5 days after the designated due date that was delivered by the U.S. Postal Service is deemed timely filed unless it has a postmark indicating the report was mailed after the designated due date. A certificate of mailing obtained from and dated by the U.S. Postal Service at the time of mailing or a receipt from an established courier company, which bears a date on or before the date on which the report is due, is proof of mailing in a timely manner. Reports filed with the Division through the Electronic Filing System (EFS) are due no later than midnight, Eastern Time, of the due date.

> (Sections <u>106.07</u>, <u>106.0705</u> and <u>106.141</u>, F.S.)

Penalty for Late Filing

Any candidate failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first three days late and, thereafter, \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is

greater, for the period covered by the late for report. However, the reports immediately preceding the primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report. For a candidate's termination report, the fine shall be \$50 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater for the period covered by the late report. All fines must be paid from the candidate's personal funds - not campaign funds.

(Section 106.07(2) and (8), F.S.)

Notice of No Activity

In any reporting period during which a candidate has not received funds or made any expenditures, the filing of the required report for that period is waived. However, the candidate must notify the filing officer in writing on or before the prescribed reporting date that no report is being filed on that date. (A notice of no activity filed with the Division must be filed electronically using the <u>EFS</u>.) The next report filed must specify that the report covers the entire period between the last submitted report and the report being filed.

(Section <u>106.07</u>, F.S.)

Incomplete Reports

If a campaign treasurer files a report that is deemed incomplete, it shall be accepted on a conditional basis. The campaign treasurer will be notified by the filing officer as to why the report is incomplete. The campaign





FLORIDA ELECTIONS COMMISSION REPORT OF INVESTIGATION Case No.: FEC 16-606

Respondent: Randi Marie Doan

Complainant: Division of Elections

Pursuant to Section 106.25, Florida Statutes, on October 21, 2016, the Florida Elections Commission received information from the Division of Elections alleging that Respondent violated Chapter 106, Florida Statutes. The Division's referral was mandated pursuant to Section 106.07(8)(d), Florida Statutes. Commission staff, therefore, investigated whether Respondent violated the following statutes:

> Section 106.07(7), Florida Statutes, failure of a candidate who did not receive any contributions or make any expenditures during a reporting period to notify timely the filing officer, in writing, that no report is being filed;

> Section 106.141(1), Florida Statutes, failure of a candidate to dispose of funds remaining in his campaign account within 90 days after he withdrew, became unopposed, was eliminated, or elected and to file a report reflecting the disposition of all remaining funds; and

Section 106.19(1)(c), Florida Statutes, prohibiting a person or organization from falsely reporting or deliberately failing to report information required by Chapter 106, Florida Statutes.

I. Preliminary Information:

1. Respondent, Randi Marie Doan, was a 2016 candidate for State Representative, District 27. Subsequently, she did not qualify¹.

2. Complainant is the Division of Elections (Division).

3. Respondent's filing officer is Kristi Reid Bronson, Chief, Bureau of Election Records.

4. On March 14, 2016, Respondent's Appointment of Campaign Treasurer and Designation of Campaign Depository form (DS-DE 9) was filed with the Division. Respondent

¹ According to the Division, the only documents on file for Respondent are: DS-DE 9, an acknowledgment letter from the Division to Respondent, Statement of Candidate, and two failure-to-file letters.





appointed herself to serve as campaign treasurer for her campaign. To review the DS-DE 9 form, refer to Exhibit 1.

5. On March 15, 2016, Ms. Bronson sent Respondent a letter acknowledging her name had been placed on the 2016 active candidate list. The letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system (EFS), and provided Respondent with her user identification number and initial password allowing her access to the EFS.

6. The letter also advised Respondent that all of the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Candidate and Campaign Treasurer Handbook*, and the Calendar of Reporting Dates. The letter further advised Respondent that it was her responsibility to read, understand, and follow the requirements of Florida's election laws.

7. The acknowledgement letter also states, "An online instruction guide is available to you on the EFS to assist with navigation, data entry, and submission of reports" and provides the telephone number for the Division's EFS Help Desk. To review the acknowledgment letter, refer to Exhibit 2.

8. On September 23, 2016, the Division sent Respondent a letter informing her that she had not filed her termination report or notification that no reportable activity occurred. The letter was mailed to Respondent at the address provided on her DS-DE 9 form. To review the September 23, 2016 letter, refer to Exhibit 3.

9. On October 3, 2016, the Division sent Respondent a letter marked "Final Notice" informing her that her termination report or the required notification that no reportable activity occurred had not been filed. The final notice was delivered to Respondent at the address provided on the DS-DE 9 form. To review the October 3, 2016 letter and the delivery confirmation, refer to Exhibit 4.

10. On October 21, 2016, the Commission received a referral from the Division alleging that Respondent failed to report campaign activity during her 2016 Termination Report, or in the alternative, failed to notify the filing officer that no report would be filed. The allegations will be addressed in the paragraphs that follow.

II. Alleged Violation of Section 106.07(7), Florida Statutes:

11. I investigated whether Respondent violated this section of the election laws by failing to notify the filing officer, in writing, that no report would be filed for the 2016 Termination Report.

12. On February 9, 2017, I subpoenaed Respondent's campaign account records from her campaign depository, Bank of America. A written statement from the campaign depository read, "The Bank is unable to locate any accounts or records requested with the information





provided²." To review the statement from the bank, refer to Exhibit 5.

13. Based upon the statement from Respondent's campaign depository, it appears that Respondent was required to notify the filing officer, in writing, that no report would be filed for the 2016 Termination Report. According to the Division, Respondent's Campaign Finance Activity indicates that she filed a notice-of-no-activity for the reporting periods covering March 14 – March 31, 2016, April 1 – April 30, 2016 and May 1 – May 31, 2016. According to Respondent's filing history, Respondent timely filed a notice-of-no-activity for the three reporting periods. To review a copy of Respondent's filing history, refer to Exhibit 6.

14. Respondent did not provide a written response to the referral.

15. No record was found to indicate that Respondent has previously violated this section of the election laws.

III. Alleged Violation of Section 106.141(1), Florida Statutes:

16. I investigated whether Respondent violated this section of the election laws when she failed to timely file a 2016 Termination Report reflecting the disposition of all remaining campaign funds.

17. To review the circumstances regarding Respondent's campaign activity, please refer to paragraphs 12 and 13 of this report.

18. No record was found to indicate that Respondent has previously violated this section of the election laws.

IV. Alleged Violation of Section 106.19(1)(c), Florida Statutes:

19. I investigated whether Respondent violated this section of the election laws by failing to report campaign activity during the 2016 termination-reporting period.

20. To review the circumstances regarding Respondent's campaign activity, please refer to paragraphs 12 and 13 of this report.

21. No record was found to indicate that Respondent has previously violated this section of the election laws.

V. FEC History:

22. Respondent has no prior history with the Florida Elections Commission.

Conclusion:

² The subpoena requested any and all records relative to any account opened by Respondent with respect to her campaign for State Representative, District 27. The subpoena also stated that the name of the account may be listed as, but not limited to: Campaign Account of Randi Marie Doan; Randi Marie Doan for State Representative, District 27; Randi Marie Doan Campaign for State Representative; or Randi Marie Doan Campaign Account.

23. On October 28, 2016, the Commission sent Respondent a letter via certified mail informing her that it received a referral from the Division alleging violations of Florida's election laws. The letter advised Respondent she had 14 days to respond to the allegation in the referral; Respondent did not provide a response to the letter. To review a copy of the Commission's October 28, 2016 letter and delivery confirmation, refer to Exhibit 7.

24. On January 27, 2017, and February 8, 2017, the Commission sent Respondent a letter informing her that the Division's referral was found to be legally sufficient and the Commission would be investigating several sections of the election laws. The letter advised Respondent she could file a notarized statement providing any information regarding the facts surrounding the allegations. Respondent did not provide a response to the letter. To review a copy of the Commission's February 8, 2017 letter, refer to Exhibit 8.

25. On February 16, 2017, I sent Respondent a questionnaire-affidavit asking her to state the reason why she did not notify the filing officer regarding a 2016 Termination Report. As of the date of this report, Respondent has not returned the affidavit, and the affidavit has not been returned by the post office³. To review a copy of the affidavit, refer to Exhibit 9.

26. On March 9, 2017, I left a voice-mail message asking Respondent to return my call so that she may have an opportunity to respond to the allegations in the Division's referral. As of the date of this report, Respondent has not returned my call.

27. Respondent executed a Statement of Candidate form indicating that she had been provided access to read and understand the requirements of Chapter 106, Florida Statutes; the form is dated as having been signed March 31, 2016. To review a copy of the Statement of Candidate, refer to Exhibit 10.





Any candidate failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first 3 days late and, thereafter, \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for reports immediately preceding each primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the candidate and campaign treasurer and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.

Section 106.141(1), Florida Statutes: As alleged in the complaint, Respondent, a 2016 candidate for State Representative, failed to timely file her 2016 Termination Report reflecting the disposition of all remaining campaign funds.

Section 106.19(1)(c), Florida Statutes: As alleged in the complaint, Respondent, a 2016 candidate for State Representative, may have falsely reported or deliberately failed to include information in her 2016 Termination Report, as required by Chapter 106.

You may respond to the allegations above by filing a notarized statement providing any information regarding the facts and circumstances surrounding the allegations. Your response will be included as an attachment to the investigator's report.

When we conclude the investigation, a copy of the Report of Investigation will be mailed to you at the above address. You may file a response to the report <u>within 14 days from the date the report is mailed to you</u>. Based on the results of the investigation, legal staff will make a written recommendation to the Commission on whether there is probable cause to believe you have violated Chapter 104 or 106, Florida Statutes. A copy of the Staff Recommendation will be mailed to you and you may file a response <u>within 14 days from the date the recommendation is mailed to you</u>. Your timely filed response(s) will be considered by the Commission when determining probable cause.





The Commission will then hold a hearing to determine whether there is probable cause to believe you have violated Chapters 104 or 106, Florida Statutes. You and the complainant will receive a notice of hearing at least 14 days before the hearing. The notice of hearing will indicate the location, date, and time of your hearing. You will have the opportunity to make a brief oral statement to the Commission, but you will not be permitted to testify or call others to testify, or introduce any documentary or other evidence.

At any time before a probable cause finding, you may notify us in writing that you want to enter into negotiations directed towards reaching a settlement via consent agreement.

The Report of Investigation, Staff Recommendation, and Notice of Hearing will be mailed to the above address as this letter. Therefore, if your address changes, you must notify this office of your new address. Otherwise, you may not receive these important documents. Failure to receive the documents will not delay the probable cause hearing.

Under section 106.25, Florida Statutes, complaints, Commission investigations, investigative reports, and other documents relating to an alleged violation of Chapters 104 and 106, Florida Statutes, are <u>confidential</u> until the Commission finds probable cause or no probable cause. The confidentiality provision does not apply to the person filing the complaint. However, it does apply to you unless you waive confidentiality in writing. The confidentiality provision does not preclude you from seeking legal counsel. However, if you retain counsel, your attorney must file a notice of appearance with the Commission before any member of the Commission staff can discuss this case with him or her.

Each candidate is required to provide the Division of Elections with confidential personal information that may be used to allow access in the event that password is forgotten or lost. When you enter the campaign account screen, there will be a drop down box where you pick a question (such as *What is your mother's maiden name?*) and supply an answer. All passwords and answers to questions are stored as encrypted data and cannot be viewed by Division staff and given out over the phone. Please notify the Division if your credentials have been compromised.

Timely Filing

All reports filed must be completed and filed through the EFS no later than midnight, Eastern Standard Time, of the due date. Reports not filed by midnight of the due date are late filed and subject to the penalties in Section 106.07(8), Florida Statutes. In the event that the EFS is inoperable on the due date, the report will be accepted as timely filed if filed no later than midnight of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any candidate failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first 3 days late and, thereafter, \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for reports immediately preceding each primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the candidate and campaign treasurer and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.

Our records indicate that you have not filed either your termination report or notification that no reportable activity occurred, whichever is applicable. The filing date was September 22, 2016.

The law (s. 106.07(8)(b), Fla. Stat.) requires the filing officer to immediately notify you about the missed filing date and the automatic fines that will be assessed for late filing of a report, if a report was due.

- If reportable activity occurred and you have not filed a report, statutory fines are automatically assessed as \$50 per day until you file your report. The total fine for the untimely report cannot exceed 25% of the total receipts or expenditures, whichever is greater, for the cover period.
