### FINAL ORDER

THIS CAUSE came before the FLORIDA ELECTIONS COMMISSION

(Commission) pursuant to Sections 120.569 and 120.57(1), Florida

Statutes, on August 18, 2006, in Tallahassee, Florida, for the

purpose of considering the Administrative Law Judge's Recommended

Order, Respondent's Exceptions to the Recommended Order, and

Petitioner's Response to Respondent's Exceptions to the

Recommended Order. Petitioner was represented by Eric M. Lipman,

Assistant General Counsel and Respondent was represented by Mark

Herron, Esquire and Benedict Kuehne, Esquire.

Upon review of all the pleadings, the argument of the parties, and after a review of the complete record in this matter, the Commission makes the following findings and conclusions.

#### RULINGS ON RESPONDENT'S EXCEPTIONS

The Commission reviewed and considered Respondent's Exceptions and ruled as follows:

1. The Commission was unable to rule on Respondent's exceptions because no transcript of the final hearing before the Division of Administrative Hearings (DOAH) was provided.

Therefore, the Commission was unable to review the entire record as required Section 120.57(1)(1), Florida Statutes (2006).

## FINDINGS OF FACT

- 2. The findings of fact set forth in the Recommended Order are approved, adopted, and incorporated herein by reference.
- 3. There is competent substantial evidence to support the findings of fact.

#### CONCLUSIONS OF LAW

- 4. The Commission has jurisdiction of this matter pursuant to Section 120.57(1), Florida Statutes, and Chapter 106, Florida Statutes.
- 5. The conclusions of law set forth in the Recommended Order are approved, adopted, and incorporated herein by reference.

#### DISPOSITION

Upon a complete review of the record in this matter, the Commission accepts the disposition recommended by the Administrative Law Judge.

WHEREFORE, IT IS HEREBY ORDERED AND ADJUDGED that in the matter of Florida Elections Commission v. Sen. Alex Diaz De La Portilla, Agency Case No. FEC 00-006, the Respondent is hereby fined \$1,000 for each of the two (2) violations of Section

106.07(5), Florida Statutes, \$1,000 for each of four violations of Section 106.19(1)(b), Florida Statutes; \$250 for each of the five violations of Section 106.143(1), Florida Statutes, \$250 for each of the five violations of Section 106.143(2), Florida Statutes, and \$250 for the one violation of Section 106.143(4)(a), Florida Statutes.

This Final Order shall take effect upon being filed with the Clerk for the Florida Election Commission. The total fine of \$8,750.00 shall be due and owing within 30 days of entry of this order.

¹ In Diaz de la Portilla v. Florida Elections Commission, 857 So.2d 913 (Fla. 3rd DCA 2003), the court affirmed the Commission's finding that Respondent violated the section of Chapter 106 that prohibits "advertisements without indications of party affiliation." However, the court incorrectly identified the section as 106.132(2). The ALJ also cited to Section 106.132(2). The correct citation is Section 106.143(2), Florida Statutes (1999).
