Questions or complaints about violations of sign ordinances should be directed to the local city or county code enforcement. The elections office does not have the authority to investigate or punish violations of sign ordinances.
   See F.S. 337.406 and the Candidate Handbook Tab 9.
- Be sure to use the proper disclaimer on all political advertisements. Important: Disclaimer language must be, variations are prohibited by law.
