If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing*. The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

ORDER OF PROBABLE CAUSE

THIS MATTER was heard by the Florida Elections Commission (Commission) at its regularly scheduled meeting on December 1, 2020, in Tallahassee, Florida.

On June 3, 2020, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff's Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation(s):

Count 1:

On or about April 1, 2019, Respondent violated Section 106.07(2)(b)1., Florida Statutes, when Respondent failed to file an addendum to his 2017 M9 Report within seven days of receiving notice from the filing officer that his 2017 M9 Report was incomplete.

Count 2:

On or about April 1, 2019, Respondent violated Section 106.07(2)(b)1., Florida Statutes, when Respondent failed to file an addendum to his 2017 M10 Report within seven days of receiving notice from the filing officer that his 2017 M10 Report was incomplete.

Count 3:

On or about April 1, 2019, Respondent violated Section 106.07(2)(b)1., Florida Statutes, when Respondent failed to file an addendum to his 2017 M11 Report within seven days of receiving notice from the filing officer that his 2017 M11 Report was incomplete.

Count 4:

On or about April 1, 2019, Respondent violated Section 106.07(2)(b)1., Florida Statutes, when Respondent failed to file an addendum to his 2017 M12 Report within seven days of receiving notice from the filing officer that his 2017 M12 Report was incomplete.

Count 5:

On or about April 1, 2019, Respondent violated Section 106.07(2)(b)1., Florida Statutes, when Respondent failed to file an addendum to his 2018 M1 Report within seven days of receiving notice from the filing officer that his 2018 M1 Report was incomplete.

Count 6:

On or about April 1, 2019, Respondent violated Section 106.07(2)(b)1., Florida Statutes, when Respondent failed to file an addendum to his 2018 Termination Report within seven days of receiving notice from the filing officer that his 2018 Termination Report was incomplete.

NOTICE OF RIGHT TO A HEARING

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by <u>consent order</u> where you and Commission staff agree to resolve the violation(s) and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an <u>informal hearing</u> held before the Commission, if you <u>do not</u> dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to make written or oral arguments to the Commission concerning the legal issues related to the violation(s) and the potential fine. At the request of Respondent, the Commission will consider and determine willfulness at an informal hearing. Otherwise, live witness testimony is unnecessary.

Third, you may request a <u>formal hearing</u> held before an administrative law judge in the Division of Administrative Hearings (DOAH), if you dispute any material fact in the Staff Recommendation. You have 30 days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper righthand corner of the first page of the order. At the hearing, you will have the right to present evidence relevant to the violation(s) listed in this order, to cross-examine opposing witnesses, to impeach any witness, and to rebut the evidence presented against you.

If you do not elect to resolve the case by consent order or request a formal hearing at the DOAH or an informal hearing before the Commission within 30 days of the date this Order of Probable Cause is filed with the Commission, the case will be sent to the Commission for a formal or informal hearing, depending on whether the facts are in dispute. STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the complaint in this case recommending that there is **probable cause** to charge Respondent with violating **Section 106.07(2)(b)1., Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on April 23, 2020, the following facts and law support this staff recommendation.

1. On April 12, 2019, the Florida Elections Commission ("Commission") received a referral from the Division of Elections ("Division") alleging that Al Jacquet ("Respondent") violated Chapter 106, Florida Statutes.

2. Respondent was a candidate for State Representative, District 88, in the 2018 election. Respondent's Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates form was filed with the Division on January 25, 2017. Respondent appointed himself as his own campaign treasurer. (ROI Exhibit 1)¹

3. By letter dated January 31, 2020, the Executive Director notified Respondent that Commission staff would investigate the following alleged violations:

Section 106.07(2)(b)1., Florida Statutes: Respondent, a 2018 candidate for the office of State Representative, acting as his own treasurer, failed to timely make necessary amendments to the following campaign treasurer reports, as alleged in the complaint:

- 2017 M2²
- 2017 M3
- 2017 M9
- 2017 M10
- 2017 M11
- 2017 M12
- 2018 M1
- 2018 TR

¹ The Report of Investigation shall be referred to herein as "ROI."

 $^{^2}$ The 2017 M2 and 2017 M3 Reports have already been considered by the Commission; and therefore, will not be addressed in this Staff Recommendation.

4. By letter dated January 26, 2017, Kristi Reid Bronson, Division of Elections, Chief, Bureau of Election Records, notified Respondent that his name had been placed on the 2018 active candidate list. The letter advised Respondent that all candidates who file reports with the Division are required to use the electronic filing system ("EFS") and provided Respondent with a user identification number and initial password to access the EFS. (ROI Exhibit 2, page 1)³

5. Ms. Bronson's January 26, 2017 letter further advised Respondent that all the Division's publications and reporting forms were available on the Division's website and directed Respondent to print a copy of Chapters 104 and 106, Florida Statutes, the *Candidate and Campaign Treasurer Handbook* ("Handbook"), and the *Calendar of Reporting Dates*. (ROI Exhibit 2, page 3)

Section 106.07(2)(b)1., Florida Statutes.

6. Respondent filed his 2017 M9, 2017 M10, 2017 M11, 2017 M12, 2018 M1, and 2018 Termination Reports with the Division. However, each of the reports was incomplete. (Attachment A)

7. On September 26, 2018, the Division sent notification to Respondent that his 2017 M9, 2017 M10, 2017 M11, 2017 M12, 2018 M1, and 2018 Termination Reports were incomplete and Respondent had seven days from receipt of the notice to correct the errors on the attached Error Report. The letter also stated that if the information was reported accurately, Respondent should provide a written explanation to the Division addressing the issues noted in the Error Report. (ROI Exhibit 3, pages 1-6; Attachment A, page 1)⁴

8. On October 25, 2018, the Division sent notification to Respondent that his 2017 M9, 2017 M10, 2017 M11, 2017 M12, 2018 M1, and 2018 Termination Reports were incomplete and Respondent had seven days from receipt of the notice to correct the errors on the attached Error Report. (ROI Exhibit 3, pages 7-11; Attachment A, page 1)

9. On November 7, 2018, the Division sent notification to Respondent that his 2017 M9, 2017 M10, 2017 M11, 2017 M12, 2018 M1, and 2018 Termination Reports were incomplete and Respondent had seven days from receipt of the notice to correct the errors on the attached Error Report. The letter also stated that if the information was reported accurately, Respondent should provide a written explanation to the Division addressing the issues noted in the Error Report. (ROI Exhibit 3, pages 12-16; Attachment A, page 1)⁵

10. On March 22, 2019, the Division sent a "Final Notice" to Respondent notifying Respondent that his 2017 M9, 2017 M10, 2017 M11, 2017 M12, 2018 M1, and 2018 Termination

Reports remained incomplete and Respondent had seven days from receipt of the notice to correct the errors identified on the attached Error Report. The letter also stated that if the information was reported accurately, Respondent should provide a written explanation to the Division addressing the issues noted in the Error Report. (ROI Exhibit 4, pages 1-4; Attachment A, page 2) The Division's March 22, 2019 letter was confirmed delivered on March 25, 2019. (ROI Exhibit 4, page 5)

11. As of May 18, 2020, Respondent has not made the corrections identified by the Division and filed an amended report for the 2017 M9, 2017 M10, 2017 M11, 2017 M12, 2018 M1, or 2018 Termination Report reporting periods. (Attachment B)

12. Investigator Mellow attempted to contact Respondent three times on August 20, 2020. Investigator Mellow first called Respondent at Respondent's office. Investigator Mellow was unable to speak with anyone or leave a message for Respondent. (ROI Exhibit 7, page 1, Phone Log Entry 1)

13. On April 20, 2020, Investigator Mellow attempted to call Respondent on Respondent's cell phone. Investigator Mellow reached a message stating the voicemail had not been set up. (ROI Exhibit 7, page 1, Phone Log Entry 2)

14. On April 20, 2020, Investigator Mellow sent Respondent an email stating he attempted to call Respondent at two different phone numbers without success. Investigator Mellow requested Respondent to contact him at Respondent's earliest convenience, which Respondent failed to do. (ROI Exhibit 7, page 2)

15. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So.2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So.2d 305, 309 (Fla. 1st DCA 1995).

16. The above facts show that Respondent was a candidate for State Representative, District 88, in the 2018 election. Respondent filed his 2017 M9, 2017 M10, 2017 M11, 2017 M12, 2018 M1, and 2018 Termination Reports with the Division. However, the reports were incomplete.

17. The above facts also show that the Division sent letters to Respondent on September 26, 2018, October 25, 2018, November 7, 2018, and March 22, 2019, notifying Respondent that his 2017 M9, 2017 M10, 2017 M11, 2017 M12, 2018 M1, and 2018 Termination Reports were incomplete and Respondent had seven days from receipt of the notice to correct the errors identified by the Division on the attached Error Report and file an amended report for each of the reporting periods. As of May 18, 2020, Respondent has failed to do so.

Based upon the above facts and circumstances, staff recommends that Commission find probable cause that Respondent committed the following violations:

Count 1:

On or about April 1, 2019, Respondent violated Section 106.07(2)(b)1., Florida Statutes, when Respondent failed to file an addendum to his 2017 M9 Report within seven days of receiving notice from the filing officer that his 2017 M9 Report was incomplete.

Count 2:

On or about April 1, 2019, Respondent violated Section 106.07(2)(b)1., Florida Statutes, when Respondent failed to file an addendum to his 2017 M10 Report within seven days of receiving notice from the filing officer that his 2017 M10 Report was incomplete.

Count 3:

On or about April 1, 2019, Respondent violated Section 106.07(2)(b)1., Florida Statutes, when Respondent failed to file an addendum to his 2017 M11 Report within seven days of receiving notice from the filing officer that his 2017 M11 Report was incomplete.

Count 4:

On or about April 1, 2019, Respondent violated Section 106.07(2)(b)1., Florida Statutes, when Respondent failed to file an addendum to his 2017 M12 Report within seven days of receiving notice from the filing officer that his 2017 M12 Report was incomplete.

Count 5:

On or about April 1, 2019, Respondent violated Section 106.07(2)(b)1., Florida Statutes, when Respondent failed to file an addendum to his 2018 M1 Report within seven days of receiving notice from the filing officer that his 2018 M1 Report was incomplete.

Count 6:

On or about April 1, 2019, Respondent violated Section 106.07(2)(b)1., Florida Statutes, when Respondent failed to file an

I. Preliminary Information:

1. I investigated whether Respondent violated this section of the election laws by failing to file amended reports for the following campaign treasurer's reports after receiving notice from the filing officer: 2017 M2, 2017 M3, 2017 M9, 2017 M10, 2017 M11, 2017 M12, 2018 M1 and 2018 TR.

2. An appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 9) was filed on January 25, 2017. Respondent was named as the treasurer for his own campaign during his 2018 candidacy for State Representative. To review the DS-DE 9, refer to Exhibit 1.

3. On January 26, 2017, the Division sent Respondent a letter acknowledging his appointment as the campaign treasurer for his campaign. The letter advised Respondent that all of the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the Candidate and Campaign Treasurer Handbook, and the Calendar of Reporting Dates. The letter further advised Respondent that it was his responsibility to read, understand, and follow the requirements of Florida's election laws. To review a copy of the acknowledgement letter, refer to Exhibit 2.

II. Alleged Violation of Section 106.07(2)(b)(1)., Florida Statutes:

4. On September 26, 2018, October 25, 2018, and November 7, 2018¹, the Division sent correspondence to Respondent informing him that one or more campaign reports were incomplete. The correspondence was sent to Respondent's address provided on the DS-DE 9 and included an error report referencing the following reports: 2017 M2, 2017 M3, 2017 M9, 2017 M10, 2017 M11, 2017 M12, 2018 M1 and 2018 TR. To review the correspondence and error report, refer to Exhibit 3.

5. On March 22, 2019, the Division sent Respondent a letter marked "Final Notice" with delivery confirmation informing him that one or more campaign reports were incomplete. The letter was sent to Respondent's address provided on the DS-DE 9 and included an error report referencing the following reports: 2017 M2, 2017 M3, 2017 M9, 2017 M10, 2017 M11, 2017 M12, 2018 M1 and 2018 TR. It was confirmed delivered on March 25, 2019. To review the Final Notice letter, error report and delivery confirmation, refer to Exhibit 4.

6. In an email dated March 13, 2020, Division staff confirmed that Respondent has not correctly amended any of the reports at issue. To review the email from Division staff, refer to Exhibit 5.

7. Respondent did not respond to the referral.

¹ The November 7, 2018, notice was labeled a "Final Notice," but there is no proof of delivery, refer to Exhibit 3. ROI Referral – Failure to Timely Amend (03/20)

8. Respondent did not respond to a questionnaire-affidavit. However, in a prior case, Respondent acknowledged that he had read Chapter 106, Florida Statutes, and the *Candidate and Campaign Treasurer Handbook*. To review Respondent's response to the previous questionnaire-affidavit, refer to Exhibit 6.

9. I attempted to contact Respondent on three occasions to give him an opportunity to discuss the allegations made in the referral. As of the date of this report, Respondent has not returned my telephone calls. To review a copy of the phone log and email, refer to Exhibit 7.

III. FEC History:

10. Respondent has a prior history with the Florida Elections Commission. FEC 18-196, violation of Section 106.07(2)(b)1., F.S., fined \$2,000.00, not paid; FEC 18-287, PC, Section 106.141(9), F.S.; FEC 18-487, PC, Section 106.141(9), F.S.

All passwords and answers to questions are stored as encrypted data and cannot be viewed by Division staff and given out over the phone. Timely Filing

All reports filed must be completed and filed through the EFS no later than midnight, Eastern Standard Time, of the due date. Reports not filed by midnight of the due date are late filed and subject to the penalties in Section 106.07(8), Florida Statutes. In the event that the EFS is inoperable on the due date, the report will be accepted as timely filed if filed no later than midnight of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any candidate failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first 3 days late and, thereafter, \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for reports immediately preceding each primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the candidate and campaign treasurer and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.

On April 12, 2019, the Florida Elections Commission received a complaint alleging that you violated Florida's election laws. I have reviewed the complaint and find that it contains one or more **legally sufficient allegations**. The Commission staff will investigate the following alleged violation:

Section 106.07(2)(b)1., Florida Statutes: Respondent, a 2018 candidate for the office of State Representative, acting as his own treasurer, failed to timely make necessary amendments to the following campaign treasurer reports, as alleged in the complaint:

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. Based on the results of the investigation, a staff attorney will prepare and present a written Staff Recommendation (SR) to the Commission as to whether there is probable cause to charge you, the Respondent, with violating Chapters 104 or 106, Florida Statutes. You will have an opportunity to respond to both the ROI and the SR. The Commission will then hold one or more hearings to determine whether the alleged violation occurred and, if so, the amount of the fine to be imposed upon you. Notice will be mailed to you and the Complainant at least 14 days before any hearing at which your case is to be considered.

Pursuant to Section 106.25(4)(i)3., Florida Statutes, the Commission may enter into a consent agreement with a Respondent to settle a complaint prior to a finding of probable cause. If you are interested in entering negotiations directed towards reaching a consent agreement to resolve this matter, please contact the Commission and request to speak with the attorney assigned to this case.
