A hearing will be held in this case before the Florida Elections Commission on February 23, 2021 at 8:30 am, EST, or as soon thereafter as the parties can be heard.

Please note that because of COVID-19, this will be a virtual meeting conducted by remote video or teleconference. Enclosed you will find additional details on joining the video conference via GoToWebinar, 9-Digit Webinar ID 627-359-707, or via teleconference by dialing (877) 309-2071 and entering the meeting access code 324-720-215, when prompted. If you wish to speak before the Commission, you will need to appear by webcam and will be sworn in remotely. Please be advised that the Commission will consider multiple cases, so you will need to wait until your case is considered. If you have any questions, please contact Commission staff at (850) 922-4539.

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

If you are the Respondent, you may attend the hearing, and you or your attorney will have 5 minutes to present your case to the Commission. However, some cases (including those in which motions to dismiss or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which motions to dismiss or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have 5 *minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Executive Director Florida Elections Commission February 2, 2021 Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing*. The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

According to Mr. Barbetta, he went to the post office and mailed it the same day. After receiving notice of the late report, he emailed the filing officer and explained the situation. He notes that he hand delivered another copy on July 28th. Mr. Barbetta also included copies of emails to the city clerk's office and a picture of the envelope containing the report.

- The 2020 25P Original Report covers the period from 07/01/20-07/15/20; it was due on 07/24/20.
- The 2020 25P Report shows that it was hand delivered on 07/28/20 and received by mail on 08/24/20.

- The City of Sarasota City Clerk's office sent notes that pertain to Joseph Barbetta's 2020 25P report.

In accordance with your letter of August 21st along with the additional information I received yesterday from the City of Sarasota Auditor and Clerk's Office I am providing this additional information to go with my Notice of Appeal I sent to Donna Ann Malphurs, the Agency Clerk, on August 18th, 2020.

SUPPLEMENTAL INFORMATION FOR <u>CASE NO: FEC 20-289</u> Campaign Treasurer's Report due 07/24/2020

Please be advised that yesterday, August 25, 2020 I received an email from Lori Rivers, the Deputy Auditor and Clerk of the City of Sarasota, informing me that they finally received the envelope with my Report which I personally mailed inside the City of Sarasota Post Office on Thursday, July 23rd, a day before its due date after attempting personal hand delivery to their offices at City Hall which I found locked. Again in my original Notice of Appeal sent to you on August 18th I spelled out the exact circumstances of my delivery attempts culminating in my personally mailing it a day before its due date in the City of Sarasota Main Post office just a few short blocks away for the Sarasota City Hall offices of the Clerk. I have now learned from Ms. Rivers email attached that for some unusual reason the Post Office apparently decided not to deliver it to the Address of the City Auditor and Clerk on the envelope, which is the address given to Candidates to file the Reports, but instead the Post Office chose to forward it to the City's Post Office Box located in the same Post Office where I personally mailed the Original Report on Thursday July 23rd as previously mentioned. I had no knowledge of the City's P.O. Box address especially since it does not appear anywhere on any correspondence I've received from the City Auditor and Clerk. I certainly am unable to explain those unusual circumstances and actions by the U.S. Post Office and I do not feel that it is fair that I be fined for this since I did everything that was asked of me on a timely basis, in fact I did it all a day earlier than required, and that is after attempted hand delivery to the Offices of the Auditor and Clerk which were in City Hall which I found to be locked at all entrances, again I was a day early in my delivery efforts. There is no circumstance where my Report would have been late in either of my efforts to make delivery.

Again I sincerely appreciate your consideration in reversing this fine which I clearly feel is unjustified under these unusual circumstances. I clearly complied with the law and did everything

that was asked of me. This whole incident is most unfortunate and I ask that you read this supplemental information in conjunction with my Original Notice of Appeal sent on August 18th, 2020, which is clearly detailed, and not uphold the fine assessed. Thank you for your consideration.

Thank you for the opportunity to present you with my Appeal of the fine for the alleged late filing of my Campaign Treasurer's Report which was due on July 24, 2020. I have attached a copy of the letter dated August 11, 2020 from Shayla Griggs, the City Auditor and Clerk notifying me of the assessed fine along with supporting documentation which I am providing to substantiate the fact that I complied with the filing deadline.

First of all in each instance of the filing of my Campaign Treasurer's Report during this Campaign I have made it a policy of mine to be sure to deliver my Report in person at least one

day prior to its actual due date if not sooner. All of my reports have been delivered and received on a timely basis but for some still unknown reason the Clerk's Office claims to not have received this report in question, namely the one due on July 24th, 2020. As to that report I personally placed it in the usual large brown envolope, a copy of which is enclosed, addressed properly, and went to City Hall on Thursday, July 23rd at approximately 1PM or so to make personal delivery to the City Auditor and Clerk's Office. I found that all the doors in City Hall, a Public Building, all the way around were locked and I was unable to gain access to execute the personal delivery, again a day earlier than the due date. I waited a few minutes, called the phone number listed, and got a recording, no one came to the door to allow access. When unable to gain access, enter and make delivery, after about 10 minutes I then went to the Sarasota Main Post Office, about 2 blocks away, attached the proper postage, and promptly mailed it in the Mail slot inside the building. Prior to placing it in the mail slot I took a picture of the envelope whch is attached. Again it was properly addressed, was mailed on Thursday, July 23rd by me personally, a full day earlier than the due date, and obviously would be timely postmarked a day earlier than necessary since that actual postmarked deadline according to the Auditor & Clerk's office letter was to be no later than Friday the 24th for a postmark. I followed it up with an email to Lori Rivers, the Deputy Clerk, which is also enclosed. Again the Sarasota Main Post Office is about 2 blocks from City Hall. I only mailed it since the City Hall, a Public Building, where I was to file it was locked and I was unable to gain access during regular business hours. I even confirmed with a Postal Employee as to what postmark would be on my envelope that I just mailed today. July 23rd and when would it likely be received and she responded, "Today's date, July 23rd would be the postmark and they should receive it either Friday, July 24th or Saturday, July 25th". I felt comfortable with that although I would have preferred the personal hand delivery by me as I attempted to do earlier that day.

Thank you for the opportunity to present you with my Appeal of the fine for the alleged late filing of my Campaign Treasurer's Report which was due on July 24, 2020. I have attached a copy of the letter dated August 11, 2020 from Shayla Griggs, the City Auditor and Clerk notifying me of the assessed fine along with supporting documentation which I am providing to substantiate the fact that I complied with the filing deadline.

First of all in each instance of the filing of my Campaign Treasurer's Report during this Campaign I have made it a policy of mine to be sure to deliver my Report in person at least one day prior to its actual due date if not sooner. All of my reports have been delivered and received on a timely basis but for some still unknown reason the Clerk's Office claims to not have received this report in question, namely the one due on July 24th, 2020. As to that report I personally placed it in the usual large brown envolope, a copy of which is enclosed, addressed properly, and went to City Hall on Thursday, July 23rd at approximately 1PM or so to make personal delivery to the City Auditor and Clerk's Office. I found that all the doors in City Hall, a Public Building, all the way around were locked and I was unable to gain access to execute the personal delivery, again a day earlier than the due date. I waited a few minutes, called the phone number listed, and got a recording, no one came to the door to allow access. When unable to gain access, enter and make delivery, after about 10 minutes I then went to the Sarasota Main Post Office, about 2 blocks away, attached the proper postage, and promptly mailed it in the Mail slot inside the building. Prior to placing it in the mail slot I took a picture of the envelope which is attached. Again it was properly addressed, was mailed on Thursday, July 23rd by me personally, a full day earlier than the due date, and obviously would be timely postmarked a day earlier than necessary since that actual postmarked deadline according to the Auditor & Clerk's office letter was to be no later than Friday the 24th for a postmark. I followed it up with an email to Lori Rivers, the Deputy Clerk, which is also enclosed. Again the Sarasota Main Post Office is about 2 blocks from Clty Hall. I only mailed it since the City Hall, a Public Building, where I was to file it was locked and I was unable to gain

Dear Mr. Barbetta:

Your Campaign Treasurer's Report for the period of July 1, 2020 through July 15, 2020, was not received by the due date of 5:00 p.m., July 24, 2020.

In accordance with Section 106.07(8)(b) of the Florida Statutes,

"Upon determining that a report is late, the filing officer shall immediately notify the candidate or chair of the political committee as to the failure to file a report by the designated due date and that a fine is being assessed for each late day. The fine shall be \$50 per day for the first 3 days late and, thereafter, \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding each special primary election, special election, primary election, and general election, the fine is \$500 per day for each late day, not to exceed 25 percent of the total receipts or expenditures, whichever is greater, for the period covered by the late report."

We notified you on Friday, July 24, 2020 that your report had not been received by the due date and a fine may be assessed if the report was not postmarked by the deadline. To date, we have not received a postmarked report for this period. Your report was received by my office on Wednesday, July 28, 2020 and is therefore considered four days late. A fine of \$650.00 has been assessed.

Please note that in accordance with the Statute: "Such fine shall be paid to the filing officer within 20 days after receipt of the notice of payment due, unless appeal is made to the Florida Elections Commission pursuant to paragraph (c). Notice is deemed complete upon proof of delivery of written notice to the mailing or street address on record with the filing officer. In the case of a candidate, such fine shall not be an allowable campaign expenditure and shall be paid only from personal funds of the candidate".



In accordance with Section 106.07(8)(b) of the Florida Statutes,
