#### NOTICE OF VIRTUAL HEARING (AUTOMATIC FINE)

A hearing will be held in this case before the Florida Elections Commission on, May 25, 2021, at 8:30 am EST, or as soon thereafter as the parties can be heard.

Please note that because of COVID-19, this will be a virtual meeting conducted by remote video or teleconference. Enclosed you will find additional details on joining the video conference via GoToWebinar, 9-Digit Webinar ID 640938187 or via teleconference by dialing (866) 901-6455 and entering the meeting access code 278040912, when prompted. If you wish to speak before the Commission, you will need to appear by webcam and will be sworn in remotely. Please be advised that the Commission will consider multiple cases, so you will need to wait until your case is considered. If you have any questions, please contact Commission staff at (850) 922-4539.

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

**If you are the Respondent**, you may attend the hearing, and you or your attorney will have 5 minutes to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have 5 minutes to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Executive Director Florida Elections Commission May 10, 2021 Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, he must provide the Commission with written proof of his financial resources at the hearing. A financial affidavit form is available from the Commission Clerk.

**SUMMARY:** Pasco County Democratic Executive Committee is a political party executive committee (PTY) registered with the State of Florida. The PTY's chair is John Ford and its treasurer is Michael Weinert.

The PTY is appealing the fine claiming that the treasurer had additional unplanned work hours on the due date. According to Mr. Ford, the committee treasurer is a volunteer that has full time work on third shift. He states that the report was filed in good faith the morning after it was due. He notes that they do not have a history of late filings and requests a waiver of the fine.

- The 2020 G7 Original Report covers the period from 08/14/20-10/29/20; it was due on 10/30/20.
- The 2020 G7 Report shows that it was filed on 10/31/20 at approximately 9:56am.
- Pasco County Democratic Executive Committee reported receiving 327 contributions while making 48 expenditures.
- The Pasco County Supervisor of Elections office provided one email regarding Pasco County Democratic Executive Committee's 2020 G7 report. On 10/31/20, SOE staff sent an email asking if the G7 report had been filed. According to the email, the treasurer responded that he was "bogged down with work" and stated that the report had been filed.

Honorable Commissioners,

We are writing to appeal an automatic fine related to a late political committee treasurer's report.

The Pasco County Democratic Executive Committee received notice of the fine on November 13, 2020. The 2020 G7 report for the period ending 10/29/2020 was due 10/30/2020, the Friday prior to the general election. The treasurer filed the report on 10/31/2020.

The fine is assessed per statutes 106.07(8) & 106.29(3) is \$500.

The Pasco County Democratic Executive Committee requests an appeal of the fine per the same statutes 106.07(8) & 106.29(3).

Please consider these mitigating circumstances:

The Committee does not have a history of late filings. The late filing was submitted in good faith 2 days after the end or the reporting period, the day after it was due.

The committee treasurer is a volunteer that has full time work on third shift including weekend nights, this included the nights on each side of the due date; the treasurer had additional work hours on the due date of 10/30/2020 which had been unplanned. The report was then filed in the morning of 10/31/2020.

Therefore, Pasco County Democratic Executive Committee requests consideration of a significant reduction of the penalty under statute 106.265.



Dear Mr. Ford:

Your campaign treasurer's report that was due no later than Friday, October 30, 2020 was received on Saturday, October 31, 2020. Therefore, the report is considered to be one (1) day late.

Pursuant to 106.07(8)(b), Florida Statutes, upon determining that a report is late, the filing officer shall immediately notify the candidate/committee as to failure to file a report by the designated due date and that a fine is being assessed for each late day.

The amount of the fine is \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. Since the report is considered to have been filed 1 day late with expenditures totaling \$36,634.22 the DEC is fined \$500.00 (the per day rate rather than the percentage rate for this reporting period which would have been a fine of \$9,158.55).

The fine must be paid to the Supervisor of Elections within 20 days of receipt of this notice unless appealed to the Florida Elections Commission. Please note that as a committee, the fine is <u>an allowable committee expenditure</u> and may be <u>paid from DEC funds</u>.

Section 106.07(8)(c), Florida Statutes, provides for appealing or disputing the assessed fine by submitting a notice of appeal in writing within 20 days of the date of receipt of the notice of late payment due stating any unusual circumstances surrounding the failure to file on the designated due date. A failure to timely file such notice will constitute a waiver of the right of appeal.

Moreover, the notice of appeal must be accompanied by any and all supporting evidence you wish the Commission to consider in making its determination. Examples of such evidence that the Florida Elections Commission will consider are: (1) an affidavit attesting, in specific detail, to timely filing; (2) and affidavit or letter detailing an issue with the electronic filing system used to submit your campaign finance reports to the supervisor;

(3) an affidavit or statement from an attending physician or a hospital bill, setting forth specific dates, if there is a health-related reason as to why your report was not timely filed.

If you fail to submit documentation or evidence demonstrating the unusual circumstances which prevented you from timely filing your report within the 20 days stated above, no documentation or evidence submitted thereafter will be considered by the Florida Elections Commission.

You also have the right to a hearing before the Commission. However, if you desire a hearing before the Commission, you must request such hearing in the notice of appeal within 20 days of receipt of this notice. If no timely request for a hearing is made in your notice of appeal, you will be deemed to have waived your right to a hearing and the Commission's determination shall be based upon written record.

The above-mentioned penalty is not at the discretion of the Supervisor of Elections.
