## **NOTICE OF HEARING (AUTOMATIC FINE)**

A hearing will be held in this case before the Florida Elections Commission on, August 14, 2018 at 9:00 am, or as soon thereafter as the parties can be heard, at the following location: First District Court of Appeal, 2000 Drayton Drive, Tallahassee, Florida 32399. Due to heightened security access requirements, please bring only essential items into the building and plan to arrive early to allow for delays coming through security.

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

**If you are the Respondent**, you may attend the hearing, and you or your attorney will have 5 minutes to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

**If you are the Complainant**, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

**If you are an Appellant**, and you have requested a hearing, you may attend the hearing, and you or your attorney will have 5 *minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, he must provide the Commission with written proof of his financial resources at the hearing. A financial affidavit form is available from the Commission Clerk.

**SUMMARY:** Narragansett (Narrie) Smith is a candidate for Columbia County School Board, District 1 in the 2018 elections. Phillip J. Mobley is her treasurer.

Narragansett (Narrie) Smith is appealing the fine claiming that due to extenuating circumstances, her treasurer filed the report one day late (Friday, May 11, 2018 at 8:33pm). According to Narragansett (Narrie) Smith, both the treasurer and candidate pins were assigned to the report as instructed, however, they did not receive any notification that the treasurer pin was rejected and that the report was not successfully submitted. Ms. Smith states that on Monday, May 14, the Columbia County Supervisor of Elections office called stating the report was not complete, therefore, a fine of \$650 is accessed because the report was 4 days late.

- The 2018 M4 Original Report covers the period from 04/01/18-04/30/18; it was due on 05/10/18.
- The 2018 M4 Queued Transaction Report shows that it was created on 05/11/18 and filed on 05/14/18.
- Narragansett (Narrie) Smith reported receiving 8 contributions, while making 4 expenditures.
- The Columbia County Supervisor of Elections has two notes that pertain to Narragansett (Narrie) Smith's 2018 M4 report. On 05/11/18 SOE staff contacted Ms. Smith to let her know her report was late. Ms. Smith stated that her brother, the treasurer, had to travel for a funeral and that she thought the report was due May 12<sup>,</sup> 2018. On Monday, May 14<sup>th</sup>, Melinda and Tomi (SOE staff) contacted Ms. Smith to let her know that both the Candidate and Treasurer pin numbers are required to file the report and gave her a tentative amount of the fine.

## STATEMENT OF CHARGES <u>LATE FEE</u>

Per Florida Statute 106.07, you were late filing your Campaign Treasurer's Report for the period shown below. Therefore, you are assessed a late fee as determined by Florida Statute 106.07. Such fee is to be paid the Columbia County Supervisor of Elections within 20 days after receipt of this notice of payment due, unless an appeal is made to the Florida Elections Commission. A candidate <a href="mailto:shall not">shall not</a> claim this fee as a campaign expenditure, but **shall pay the fee from the candidate's personal funds**. The candidate may appeal or dispute the fine per Florida Statute 106.07. If you choose to appeal or dispute the fine, the request must be made within 20 days after receipt of this notice of payment due.

Per Florida Statute 106.07 the late fee is determined as follows:

If the Campaign Treasurer's Report is filed late, a fine shall be assessed as follows - \$50 per day for the first 3 days that the report is late and then \$500 per day for each late day thereafter, not to exceed 25% of the total receipts or expenditures, whichever is greater for the period covered by the late report. For reports immediately preceding a primary or general election, the fee is \$500 for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater for the period covered by the late report. [Florida Statute 106.07(8)(b)].

Therefore, no printed report will be required to be delivered to the Columbia County Supervisor of Elections office by 5:00pm on the report due date. Campaign Treasurer's Reports that are filed electronically are considered to be timely filed up until midnight of the due date.

Upon submission of the Campaign Treasurer's Report the filing officer will review the report for completeness. A complete report includes all items per Florida Statute 106.07. If the report is incomplete, the filing officer will contact the treasurer by certified mail. An addendum must be filed within 7 days of receipt of notice providing all necessary information to complete the report.

IMPORTANT: If the Campaign Treasurer's Report is filed late, a fine shall be assessed as follows - \$50 per day for the first 3 days that the report is late and then \$500 per day for each late date thereafter, not to exceed 25% of the total receipts or expenditures, whichever is greater for the period covered by the late report. For reports immediately preceding a primary or general election, the fee is \$500 for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater for the period covered by the late report. NOTE: Candidates must pay this late fee from their personal funds, not from their campaign account. [Florida Statute 106.07(8)(b)].
