AMENDED DEFAULT FINAL ORDER

THIS MATTER was referred to the Florida Elections Commission (Commission) by the filing officer for failure of the Respondent to pay the assessed fine.

FINDINGS OF FACT

1 The Commission is charged with enforcing Chapter 106, Florida Statutes, the campaign financing laws.

2 Respondent was a state candidate for the office of State Representative during the 2014 elections. Respondent's 2014 P1 campaign treasurer's report was not filed with the filing officer on June 27, 2014, the designated due date.

3 On December 19, 2014, the filing officer sent a final notification to the Respondent advising him that the amount of the fine was \$551.25. The notice also advised Respondent, as required by Section 106.07(8)(b), Florida Statutes, that he must either pay the fine or appeal to the Florida Elections Commission within 20 days after receipt of the notice of payment due.

4 Respondent has failed to pay the assessed fine or to appeal to the Commission.

CONCLUSIONS OF LAW

5 The Commission has jurisdiction over the parties to and subject matter of this case, pursuant to Section 106.07, Florida Statutes.

6 Respondent's failure to timely file a notice appealing the assessed fine constitutes a waiver of entitlement to an appeal


**ORDER**
