**NOTICE OF HEARING (AUTOMATIC FINE)**

A hearing will be held in this case before the Florida Elections Commission on, **August 13, 2019 at 8:30 am**, or as soon thereafter as the parties can be heard, at the following location: **Senate Office Building, 404 South Monroe Street, Room 110-S, Tallahassee, Florida 32399**. Due to heightened security access requirements, please bring only essential items into the building and plan to arrive early to allow for delays coming through security.

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

**If you are the Respondent**, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

**If you are the Complainant**, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

**If you are an Appellant**, and you have requested a hearing, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

**SUMMARY:** NRA Political Victory Fund is a political committee (PC) registered with the State of Florida. The PC's chair is Chris W. Cox and its treasurer is Todd Adkins.

The PC is appealing the fine claiming that the report was originally submitted on March 11<sup>th</sup> and disclosed no activity by the committee. According to Chris Cox, at the time of filing, the bank fees deducted from their account for the applicable periods was not in their accounting system. He states that once the fees were in the system, they amended the report on April 8<sup>th</sup> to reflect that activity. They request that the fine be waived because the expenditures were bank fees of minimal amounts and were not connected to any election.

- The 2019 M2 Original Report covers the period from 02/01/19-02/28/19; it was due on 03/11/19.
- The 2019 M2 Queued Transaction Report shows that it was created and filed on 03/11/19.<sup>1</sup>
- NRA Political Victory Fund reported receiving zero contributions, while making 1 expenditure.
- FEC staff was advised, "The committee filed a notice of no activity (waiver) on 03/11/19. A waiver is not a report. On 04/08/19, the committee filed a report showing \$33.13 of activity. The fine is based on 25% of the activity.
- The Division of Elections does not have any notes that pertain to NRA Political Victory Fund's 2019 M2 report.

To Whom It May Concern:

This letter serves as a formal appeal for the NRA Political Victory Fund. I am in receipt of two letters dated April 10, 2019 which detail fines imposed for two reports filed on April 8, 2019. The reports were due on February 11, 2019 (M1) and March 11, 2019 (M2), and were originally filed on February 7, 2019 and March 11, 2019, respectively. Both reports disclosed no activity by the committee. At the time of filing, the bank fees deducted from our account for the applicable periods were not in our accounting system. Later, when they were entered in the accounting system, we amended the M1 and M2 reports to disclose the bank fees. These amendments were the reports filed on April 8, 2019.

We respectfully request that the fine be waived for the following reasons:

- The expenditures disclosed were not in connection to any election;
- The expenditures were bank fees of minimal amounts, as opposed to independent expenditures or candidate contributions; and
- Our committee has been diligent in meeting and exceeding filing requirements, most noticeably in the weeks before the November 6, 2018 election, during which we reported all our independent expenditures despite only being required to report contributions.

We apologize for this error and will continue to be diligent in reporting all financial activity, including bank fees, in the future.
