FINAL ORDER

THIS MATTER was heard at an informal hearing held before the Florida Elections Commission (Commission) on May 20, 2015.

STATEMENT OF THE ISSUE

Whether Respondent violated Section 106.07(2)(b)1, Florida Statutes, as alleged in the Order of Probable Cause.

PRELIMINARY STATEMENT

On September 30, 2014, the Commission received a referral from the Division of

Elections (Division) alleging violations of Florida's election laws. Staff of the Commission conducted an investigation to determine whether the facts alleged in the referral constituted probable cause to believe that Respondent violated the Florida Election Code.

On January 8, 2015, staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. On February 25, 2015, the Commission entered an Order of Probable Cause finding that there was probable cause to charge Respondent with the following violation:

Count 1:

On or about July 28, 2014, Travis W. Pitts violated Section 106 07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to his 2014 P1 Report within seven days after receiving notice from the Department of State, Division of Elections, that the report required amendment.

Respondent did not timely elect to have a formal administrative hearing before an administrative law judge from the Division of Administrative Hearings and, therefore, the matter was set for an informal hearing before the Commission. At the informal hearing, the Commission adopted the undisputed facts set forth in the Staff's Recommendation as its findings of fact.

Respondent testified on his own behalf. Respondent did not offer any exhibits into evidence.

FINDINGS OF FACT

1. Respondent was a 2014 candidate for State Representative, District 5. Respondent acted as his own treasurer.
2. On July 9, 2014, Respondent filed his 2014 P1 Report with the Division. The report was incomplete.
3. By letters dated July 16, 2014, August 15, 2014, and September 3, 2014, the

Division notified Respondent that his 2014 P1 Report was incomplete and that he was required to file an amended report within 7 days of receipt of the notification. The September 3, 2014 letter was confirmed delivered.

4. An Error Report showing why the report was incomplete was attached to each notification.

5. Respondent failed to timely file the required amendment to his report within 7 days of receiving notification from the Division that his report was incomplete and required amendment.

6. Despite having received 3 notifications, Respondent still has not filed the required amendment to his report.

CONCLUSIONS OF LAW

7. The Commission has jurisdiction over the parties to and subject matter of this cause, pursuant to Section 106.26, Florida Statutes.

8. Respondent's conduct was willful. Respondent committed the acts while knowing that, or showing reckless disregard for whether, the acts were prohibited, or failed to commit an act while knowing that, or showing reckless disregard for whether, the acts were required.

9. Respondent committed 1 count of violating Section 106.07(2)(b)1, Florida Statutes, when he failed to amend his 2014 P1 Report after receiving notices that the report was incomplete.

10. In determining the amount of the civil penalty, the Commission considered the mitigating and aggravating circumstances set forth in Section 106.265, Florida Statutes


ORDER

The Commission finds that Respondent has violated Section 106.07(2)(b)1., Florida Statutes, on 1 occasion, and imposes a \$100.00 fine.

Therefore it is

ORDERED that Respondent shall remit a civil penalty in the amount of \$100.00, inclusive of fees and costs. The civil penalty shall be paid to the Florida Elections Commission, Collins Building, Suite 224, 107 West Gaines Street, Tallahassee, Florida 32399, within 30 days of the date this Final Order is filed with the Commission and must be paid by money order, cashier's check or attorney trust account check.

NOTICE OF RIGHT TO APPEAL

This order is final agency action. Any party who is adversely affected by this order has the right to seek judicial review pursuant to Section 120.68, Florida Statutes, by filing a notice of administrative appeal pursuant to Rule 9.110, Florida Rules of Appellate Procedure, with the Clerk of the Florida Elections Commission at 107 West Gaines Street, Suite 224, Collins Building, Tallahassee, Florida 32399-1050 and by filing a copy of the notice of appeal with the appropriate district court of appeal. The party must attach to the notice of appeal a copy of this order and include with the notice of appeal filed with the district court of appeal the applicable filing fees. **The notice of administrative appeal must be filed within 30 days of the date this order is filed with the Commission.** The date this order was filed appears in the upper right-hand corner of the first page of the order.
