Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

If you are the Respondent, you may attend the hearing, and you or your attorney will have 5 minutes to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have 5 *minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, he must provide the Commission with written proof of his financial resources at the hearing. A financial affidavit form is available from the Commission Clerk.

SUMMARY: Nelson Mullins Riley & Scarborough Florida State/Local Political Committee is a political committee (PC) registered with the State of Florida. The PC's chair is Crystal C. McCall, and its treasurer is Douglas M. Webb. Brian G. Svoboda, Esquire is representing the PC in this matter.

The PC is appealing the fine. According to Mr. Svoboda, the PC timely filed a waiver for the report on September 16, 2022. He notes that, through their initiative, they identified an omitted deposit. To ensure the report was correct and the public record complete, the committee amended their submission on September 26, 2022. Mr. Svoboda states this was done "before the November 8 election, thus ensuring that voters had access to its contributor information." They request a waiver of the fine and have provided documents to support the appeal.

- The 2022 G2 Original Report covers the period from 09/03/22-09/09/22; it was due on 09/16/22.
- The 2022 G2 Queued Transaction Report shows that it was created and filed on 09/16/22.¹
- Nelson Mullins Riley & Scarborough Florida State/Local Political Committee reported receiving 227 contributions while making zero expenditures.
- FEC staff was advised, "The committee filed a notice of no activity (waiver) on 09/16/22. A waiver is not a report. On 09/26/22, the committee filed a report showing \$12,500.00 of activity. The fine is based on 25% of the activity."
- The Division of Elections does not have any notes that pertain to Nelson Mullins Riley & Scarborough Florida State/Local Political Committee's 2022 G2 Report.

PRIOR CASES: None.

Dear Ms. Malphurs:

We are counsel to Nelson Mullins Riley & Scarborough Florida State/Local Political Committee and James C. Gray, Jr., Chairperson (PAC 75180) ("the Committee"). Please accept this letter as a formal notice to appeal the fine imposed by the Florida Department of State Division of Elections by letter dated November 8, 2022, which the Committee received on November 17, 2022. A copy of the notice of imposition of fine accompanies this letter as Exhibit A.

The Committee has had no prior case before the Commission. The asserted fine arises from the G2 report due on September 16, 2022. Contrary to the notice of imposition of fine issued by the Division of Elections, the Committee did, in fact, timely file. As a confirmation email demonstrates, the Committee filed a waiver with respect to the G2 report on September 16, 2022, at 10:58 a.m. *See* Exhibit B.

After filing the waiver on the September 16 due date, the Committee, on its own initiative, identified a deposit made on September 7, 2022. To ensure that the report was correct and the public record complete, the Committee promptly filed an amended report on September 26, 2022. *See* Exhibit C. The Committee has since revised its practices to ensure that all deposits are timely identified and reported.

The Committee respectfully asks the Commission to impose no fine. First, the Committee, in fact, *filed*. Believing in good faith that it had no activity during the period, the Committee timely filed the waiver required by Fla. Stat. Ann. 106.07(7). Upon discovering the deposit, the

Committee then amended the report. The Committee has no enforcement history before the Commission. It discovered the omitted deposit and corrected the report on its own initiative. It did so well before the November 8 election, thus ensuring that voters had access to its contributor information. Finally, the Committee has revised its practices to ensure that similar mistakes do not recur.

For the foregoing reasons, the Committee respectfully requests the Commission to consider and grant its appeal of the fine. If you need further information, please do not hesitate to contact me directly at (202) 434-1654.

due date, the report will be accepted as timely filed if filed no later than midnight, Eastern Standard Time, of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any political committee failing to file a report on the designated due date is subject to a fine of \$50 per day for the first three days late and, thereafter, \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding each primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the chairperson and campaign treasurer, and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.
