**NOTICE OF HEARING (AUTOMATIC FINE)**

A hearing will be held in this case before the Florida Elections Commission on, **May 14, 2019 at 8:30 am**, *or as soon thereafter as the parties can be heard*, at the following location: **Senate Office Building, 404 South Monroe Street, Room 110-S, Tallahassee, Florida 32399**. Due to heightened security access requirements, please bring only essential items into the building and plan to arrive early to allow for delays coming through security.

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

**If you are the Respondent**, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

**If you are the Complainant**, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

**If you are an Appellant**, and you have requested a hearing, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

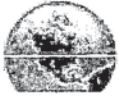

**SUMMARY:** Raymond Murphy is a candidate for Fort Myers Beach Town Council Member in the 2019 elections. Daniel Hughes is his treasurer.

Raymond Murphy is appealing the fine claiming that he was out of town until November 18<sup>th</sup> and that his treasurer was unable to file a complete report until his return to Ft. Myers Beach. According to Mr. Murphy, his campaign received contributions which were deposited into his account by the treasurer. He states that the treasurer did not have all available information to complete the report (addresses and occupations) until he returned. As such, he was unable to file the report until November 30<sup>th</sup>. Mr. Murphy states that they have no previous history of similar acts or omissions.

- The 2018 M10 Original Report covers the period from 10/01/18-10/31/18; it was due on 11/13/18.
- The 2018 M10 Original Report shows that it was hand delivered on 11/30/18 at 11:30am.
- Raymond Murphy reported receiving 21 contributions, while making zero expenditures.
- The Fort Myers Beach Town Clerk does not have any notes that pertain to Raymond Murphy's 2018 M10 report.

Pursuant to the provisions of F.S. 106.07 (8) (c), I hereby appeal the levy of a fine for the late filing of my Treasurer's Report M10 for the month of October, 2018. See the attached filing officer's letter dated November 30, 2018.

I was out of town on a lengthy trip in the Midwest, returning to Fort Myers Beach on November 18. In the meantime, contributions had been received and deposited in my campaign bank account in October by my Treasurer. He did not, however, have available all the information required to complete his report (addresses, occupations), until my return to town. Report M10 was then completed and filed on November 30 and Treasurer's Report M11 for the month of November was timely filed on December 10.

Please consider as mitigation in accordance with F.S. 106.265 (2), the aforesaid unusual circumstances and the following:

- (a) The delayed filing was not of a grave nature;
- (b) No previous history of similar acts or omissions;
- (c) The penalty is financially onerous in that the substantial portion of total receipts to date was received in October (\$3,225.00) versus November (\$495.00) and December (\$100.00 to date); and
- (d) The candidate has shown good faith in attempting to comply with the provisions of Chapter 106.

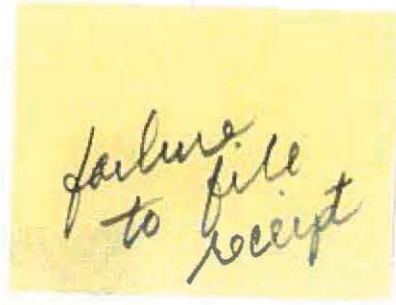

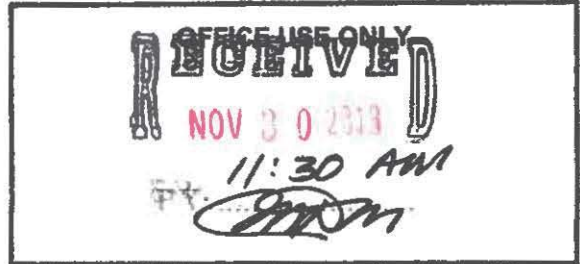
