**NOTICE OF HEARING (AUTOMATIC FINE)**

A hearing will be held in this case before the Florida Elections Commission on, **August 13, 2019 at 8:30 am**, *or as soon thereafter as the parties can be heard*, at the following location: **Senate Office Building, 404 South Monroe Street, Room 110-S, Tallahassee, Florida 32399**. Due to heightened security access requirements, please bring only essential items into the building and plan to arrive early to allow for delays coming through security.

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

**If you are the Respondent**, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

**If you are the Complainant**, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

**If you are an Appellant**, and you have requested a hearing, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

**SUMMARY:** Elizabeth Lambrides was a candidate for Poinciana CDD Supervisor Seat #3 in the 2018 elections. Ms. Lambrides was her own treasurer.

Elizabeth Lambrides is appealing the fine claiming that she turned in her report on the day it was due, however, she received an email stating that it contained errors. According to Ms. Lambrides, she tried finding the error for several hours but was unable to locate it until the next morning. She states that her campaign was in a senior community and that she received over 100 donations ranging from \$5 to \$10 which made it extremely difficult to find a keying error in all those numbers. She has also included email correspondence from the Supervisor of Elections office regarding the issue.

- The 2018 TR Original Report covers the period from 11/03/19-02/04/19; it was due on 02/04/19.
- The 2018 TR Report shows that it was filed on 02/07/19, however, the postmark date states that it was mailed on 02/05/19.
- Elizabeth Lambrides reported receiving zero contributions, while making 11 expenditures.
- The Polk County Supervisor of Elections office sent emails pertaining to Elizabeth Lambrides' 2018 TR report.

Hello,

I am appealing a fine imposed by the Polk County Supervisor of Elections.

I ran for Poinciana CDD Supervisor Seat #3 in Polk County. I didn't want to run as I don't like politics and truly don't have the time. But my small retirement community needed someone familiar with negotiating real estate deals so I was encouraged strongly to "volunteer". I had no idea what I was getting in to. Campaigning and dealing with campaign contributions is a nightmare. I will never do it again unless I can afford to hire a campaign treasurer that knows how to do accounting.

I didn't remember that I had to file the final report so many months later on February 4<sup>th</sup> until I got an email a few days before it was due. I'm not a politician, I'm a realtor so everything having to do with campaign finance was difficult for me.

I turned my report in on the day it was due February 4, 2019. At 11:12 am, I received an email saying that my report had an error. I tried to find the error for several hours that afternoon and into the evening but it took me until the next morning to find it.

Mine was a local campaign in a senior community so the majority of the donations were \$5 and \$10 and I'm sure there were well over 100 of them. Trying to find a keying error in all those numbers was extremely difficult.

Also, I live in a small town and the last mail pickup at our post office is at 3:00 pm. I didn't find the error in time so I mailed the report the next day so it was late.

I would truly appreciate your excusing this fine. It was not negligence or mal intent that led to my report being a few hours late. It was geography and my bad accounting skills.

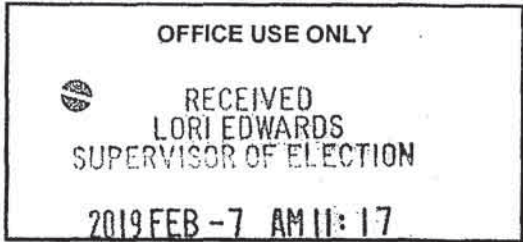

VIA EMAIL

To ensure easier and quicker processing to campaign finance data, candidates and committees are required to file their campaign treasurer's report using our procedures on our web site.

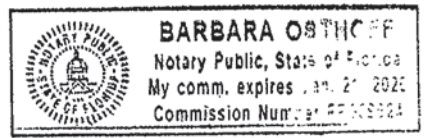

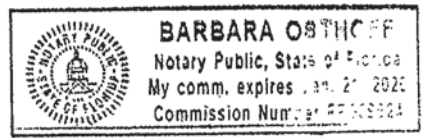


