STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to section 106 25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the complaint in this case recommending that there is **probable cause** to charge Respondent with violating Section 106.07(2)(b)(1), Florida Statutes Based upon a thorough review of the Report of Investigation submitted on February 21, 2013, the following facts and law support this staff recommendation:

1 On July 3, 2012, the Florida Elections Commission ("Commission") received a referral from Department of State, Division of Elections ("Division"), alleging that Our Fair Share for Florida ("Respondent") violated Chapter 106, Florida Statutes

2 Respondent was Ireasurer of Our Fair Share for Florida, ("OFSF PAC") in the 2012 election cycle

3 By letter dated July 30, 2012, the Executive Director notified Respondent that Commission staff would investigate the following statutory provision:

> Section 106.07(2)(b)1., Florida Statutes: Philip Nichols, as Treasurer of Our Fair Share of Florida (55215), failed to amend the 2012 Q1 campaign finance report after receiving notice that it was incomplete, as alleged in the referral from the Division of Elections

4 OFSF PAC's Appointment of Campaign Ireasurer and Designation of Campaign Depository for Political Committee's ("DS-DE 6") forms were filed on April 29, 2011, May 4, 2011, and May 9, 2011 All three DS-SE 6 forms designated Respondent as treasurer for the PAC (ROI Exhibit 2)¹

5 On May 12, 2011, Kristi Bronson, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that her office received the committee's DS-DE 6 form and that the PAC had been placed on the active committee list. The letter advised Respondent that all political committees filing reports with the Division are required to use the electronic filing system (EFS) and provided Respondent with a user identification number and initial password to grant access to the EFS (ROI Exhibit 5)

¹ The Report of Investigation is referred to herein as "ROI"

6 Ms Bronson's letter further advised Respondent that all of the Division's publications and reporting forms were on its website and directed Respondent to print out the 2011 Calendar of Reporting dates as well as other documents. *Id*

7. On April 12, 2012, Respondent filed the committee's 2012 Q1 Report with the Division However, the committee's 2012 Q1 Report was incomplete, and the Division mailed a letter to Respondent on April 30, 2012, instructing him to file an amended report supplying the missing information or provide an explanation for the entries (ROI Exhibit 6)

8 By letters dated May 22, 2012, and June 6, 2012, the Division further informed Respondent that the committee's 2012 Q1 Report was still incomplete, and that he needed to file an amended 2012 Q1 Report within seven days receipt of the notices The letters were sent to the address listed on Respondent's DS-DE 6 form (ROI Exhibits 8 & 9)

9 As of April 1, 2013, Respondent has not amended the committee's 2012 Q1 Report

10 "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. Schmitt v State, 590 So 2d 404, 409 (Fla 1991) Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed *Department of Highway Safety and Motor Vehicles v Favino*, 667 So 2d 305, 309 (Fla 1st DCA 1995).

11 The facts set forth above show that Respondent was the Chairman/Ireasurer of the "OFSF PAC" during the 2012 election cycle The Respondent filed an incomplete 2012 Q1 Report on behalf of the committee on April 12, 2012 Despite the Division mailing three separate notices to Respondent on April 30, 2012, May 22, 2012, and June 6, 2012, notifying him that the committee's 2012 Q1 Report was incomplete and that it needed to be amended, as of March 28, 2013, Respondent has failed to file an amended 2012 Q1 Report.

Based upon these facts and circumstances, I recommend that the Commission find probable cause to charge Respondent with violating the following statutory provision.

Count 1:

On or about May 22, 2012, violated Section 106 07(2)(b)1, Florida Statutes, when he failed to amend the committee's 2012 Q1 campaign finance report after receiving notice that it was incomplete



Pursuant to Section 106.25, Florida Statutes, on July 3, 2012, the Florida Elections Commission received information from the Division of Elections that Respondent violated Chapter 106, Florida Statutes The Division's referral was mandated pursuant to Section 106.07(8)(d), Florida Statutes Commission staff investigated whether Respondent violated the following statute:

Section 106.07(2)(b)1, Florida Statutes, failure of a campaign treasurer of a political committee to file an addendum to an incomplete report after receiving notice from the filing officer.

I. Preliminary Information:

1. Respondent is the treasurer and chairman of the political committee (PC), Our Fair Share for Florida. He accepted the appointment as treasurer on May 9, 2011. Mr. Kenneth Foote is the registered agent for the political committee. On May 10, 2011, the PC was registered and placed in an active status with the Division of Elections and has remained in active status since that date The purpose of the PC is to support economic growth, business development and gaming, and to oppose increased taxes.

2. Complainant is the Division of Elections (DOE)

3. Respondent's filing officer is Kristi Reid-Bronson, Chief, Bureau of Election Records.

II. Alleged Violation of Section 106.07(2)(b)1, Florida Statutes:

4 I investigated whether Respondent violated this section of the election laws by not filing an addendum to his 2012 Q1 Report, after receiving notice that it was incomplete

5 A DOE staff representative, Theresa Holdeen, submitted a sworn affidavit dated June 28, 2012 regarding Respondent's failure to file an addendum to his 2012 Q1 Report To review the sworn affidavit, refer to exhibit 1.

6 On April 28, 2011, Respondent initially accepted appointment as campaign treasurer for the political committee On April 29, 2011, the political committee filed the Appointment of Campaign Treasurer and Designation of Campaign Depository for Political Committees (DS-DE 6), the Statement of Organization of Political Committee (DS-DE 5), and the Registered Agent Statement of Appointment (DS-DE 41) with the DOE, and its name was

placed on the active committee list as a political committee that supports/opposes issues¹ To review copies of relevant documents, refer to exhibit 2

7. On May 4, 2011, Respondent filed a second DS-DE 6 with the DOE appointing himself campaign treasurer² A second DS-DE 5 was also filed at this time that specifically listed the "Area, Scope, and Jurisdiction of the Committee" To review a copy of Respondent's second DS-DE 6 and DS-DE 5 forms, refer to exhibit 3.

8. On May 10, 2011, Respondent filed his final DS-DE 6 with the DOE appointing himself campaign treasurer. To review a copy of Respondent's final DS-DE 6, refer to exhibit 4

9 In a May 12, 2011 letter, the filing officer advised Respondent that the political committee's first report was due on July 11, 2011, and all reports must be filed electronically using the Divisions' Electronic Filing System (EFS). The letter also declared that the chairperson and campaign treasurer are subject to the provisions of Section 106.07(5), Florida Statutes To view a copy of the acknowledgement letter, refer to Exhibit 5.

10. In addition, the letter informed Respondent that all of the Division's publications were available online at the DOE's website "It is your responsibility to read, understand, and follow the requirements of Florida's election laws. Therefore, please print a copy of the following documents: Chapter 106, Florida Statutes, 2010 Political Committee Handbook, 2011 Calendar of Reporting Dates, and Rule IS-2.017, Florida Administrative Code." To review a copy of the acknowledgement letter, refer to exhibit 5.

11. On April 30, 2012, the DOE mailed Respondent a notice that his 2012 Q1 Report was incomplete and needed to be amended. The notice included an attached "Error Report" that declared the following: "The Transaction Date Is Either Before Or After the Report Coverage Period"; "Cash Contributions May Not Exceed \$50"; Contribution Amounts Are Limited to \$500 For This Contributor Type"; and "Invalid Expenditure Type" (Note: the coverage period for this report covers January 1, 2012 through March 31, 2012). To review a copy of this April 30, 2012 letter, refer to exhibit 6. To review a copy of the error Report, refer to exhibit 7.

12. On May 22, 2012, the DOE mailed Respondent a second notice and attached the error report. To review a copy of the second notice, refer to exhibit 8 To review a copy of the error report, refer to exhibit 7.

13 On June 6, 2012, the DOE mailed the final notice to Registered Agent Kenneth Foote with delivery confirmation Included with the final notice were the earlier notices and error report. The USPS track and confirm website indicates that the final notice was delivered on June 9, 2012 at 9:15 am. To review a copy of the final notice with delivery confirmation, refer to exhibit 9. To review the Registered Agent Statement of Appointment, refer to exhibit 2.

14 In a February 20, 2013 telephone interview with DOE representative Lenard Randolph, I was advised that Respondent filed an amended 2012 Q1 Report with the DOE on May 29, 2012 Mr. Randolph states that the report was still considered incomplete due to

reporting errors. Mr Randolph advised me that Respondent has filed several campaign reports completely and timely since filing his 2012 Q1 Report, so he is not sure as to why this report remains incomplete. To review a copy of Respondent's amended 2012 Q1 Report, refer to exhibit 10.

15. I have attempted to make contact with Respondent; however, he has not responded to any of my attempts

16. There is no record that Respondent previously violated this section of the election laws.

III. FEC History

17 In FEC 12-048, the commission found probable cause for a possible violation of 106.07(1)/Informal Hearing scheduled for May 2013 Commission meeting.

Conclusion:

18. Respondent was offered several opportunities to make comments regarding the findings of this investigation. Respondent did not respond to any of the messages left for his behalf

19 In the May 11, 2011 acknowledgment letter, Respondent was informed that all of the Division's publications were available online at DOE's website. "It is your responsibility to read, understand, and follow the requirements of Florida's election laws. Therefore, please print a copy of the following documents: Chapter 106, Florida Statutes, 2010 Political Committee Handbook, 2011 Calendar of Reporting Dates, and Rule IS-2.017, Florida Administrative Code." To review a copy of the acknowledgement letter, refer to exhibit 5.

20. The 2010 Political Committee Handbook states, "If a campaign treasurer files a report that is deemed incomplete, he or she will be notified by the filing officer as to why the report is incomplete. The campaign treasurer must file an addendum to the incomplete report within three days of notification. The addendum must include all necessary information to complete the report." To review relevant pages from the 2010 Political Committee Handbook, refer to exhibit 11³.

³ By the time Respondent filed his amended 2012 Q1 Report, the period of time in which a candidate had to file an amended report had been extended from "within three days of notification" to "within seven days of notification" of an incomplete report. The 2012 Political Committee Handbook, as well as, in each of the letters sent to Respondent on April 30, 2012, May 22, 2012, and June 6, 2012 reflect this change



Each political committee chairperson is required to provide the Division of Elections with confidential personal information that may be used to allow access in the event that the password is forgotten or lost. When you enter the campaign account screen, there will be a drop down box where you pick a question (such as *What is your mother 's maiden name?*) and supply an answer. All passwords and answers to questions are stored as encrypted data and cannot be viewed by Division staff and given out over the phone. Please notify the Division if your credentials have been compromised.

Timely Filing

All reports must be completed and filed through the EFS not later than midnight, Eastern Standard Time, of the due date. Reports not filed by midnight, Eastern Standard Time, of the due date are late filed and subject to the penalties in Section 106 07(8), Florida Statutes. In the event that the EFS is inoperable on the due date, the report will be accepted as timely filed if filed no later than midnight, Eastern Standard Time, of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any political committee failing to file a report on the designated due date is subject to a fine of \$50 per day for the first 3 days and, thereafter, \$500 per day for each day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report However, for the reports immediately preceding each primary and general election, the fine shall be \$500 per day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the chairperson and campaign treasurer and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.





Incomplete Reports

If a campaign treasurer files a report that is deemed incomplete, he or she will be notified by the filing officer as to why the report is incomplete The campaign treasurer must file an addendum to the incomplete report within three days of notification. The addendum must include all necessary information to complete the report.

In lieu of a notice by registered mail, the filing officer may notify the campaign treasurer by telephone that the report is incomplete and request the information necessary to complete the report. If such information is not received by the filing officer within three days after the telephone request, notice shall be sent by registered mail.

(Section 106 07(2), F S)

Reporting Total Sums

Each campaign treasurer's report required by Chapter 106, F S., shall contain the total sums of all loans, in-kind contributions, and other receipts, and total sums of all expenditures made during the reporting period. The reporting forms shall be designed to elicit separate totals for in-kind contributions, loans, and other receipts

(Section 106.07, F.S.)

Reporting Contributions

Each report must contain:

- 1 Full name, address, specific occupation, amount, and date of each person making a contribution Reports must provide as clear a description as practicable of the principal type of business conducted for corporations contributing. Occupations or principal type of business are not required if the contribution is \$100 or less.
- 2 Name, address, amount, and date of each political committee or organization making any transfer of funds.
- 3 Full name, address, **specific** occupation, principal place of business of the lender and endorser, date and amount of each loan
- 4 Statement of each contribution, rebate, refund or other receipts not listed in 1 through 3. above.

(Section 106 07(4), F S.)

Contributions to a political committee may be received by an affiliated organization and transferred to the bank account of the political committee via check written from the affiliated organization if such contributions are specifically identified as intended to be contributed to the political committee. All contributions received in this manner shall be reported pursuant to Section 106 07, F S, by the political committee as having been made by the original contributor

(Section 106 08(10), F S.)

Complainant: Division of Elections

Pursuant to Section 106.25, Florida Statutes, on March 26, 2012, the Florida Elections Commission received information from the Division of Elections that Respondent violated Chapter 106, Florida Statutes. The Division's referral was mandated pursuant to Section 106.07(8)(d), Florida Statutes. Commission staff investigated whether Respondent violated the following statute:

> Section 106 07(1), Florida Statutes, failure of a campaign treasurer of a political committee to file timely regular reports of all contributions received, and all expenditures made, by or on behalf of the political committee

I. Preliminary Information:

1 Respondent is the treasurer and chairman of the political committee (PC), Our Fair Share for Florida He accepted the appointment as treasurer on May 9, 2011 Mr Kenneth Foote is the registered agent for the political committee On May 10, 2011, the PC was registered and placed in an active status with the Division of Elections and has remained in active status since that date. The PC supports/opposes both candidates and issues. The purpose of the PC is to support economic growth, business development and gaming, and to oppose increased taxes

2 Complainant is the Division of Elections

3. Respondent's filing officer is Kristi Reid-Bronson, Chief, Bureau of Election Records

II. Alleged Violation of Section 106.07(1),¹ Florida Statutes:

4 I investigated whether Respondent violated this section of Florida's election laws by not filing his 2011 Q4 Report which was due on January 10, 2012, after receiving notice that the report was due.

5 On May 10, 2011, the committee filed an Appointment of Campaign Treasurer and Designation of Campaign Depository for Political Committees (DS-DE 6) form, appointing Respondent treasurer of the committee. To view a copy of Form DS-DE 6 and additional relevant documents for the political committee, refer to Exhibit 1

6. Complainant submitted a sworn affidavit dated March 22, 2012 To review the sworn affidavit, refer to Exhibit 2.

7. By letter dated May 11, 2011, the filing officer advised Respondent that the political committee's first report was due on July 11, 2011, and all reports must be filed

electronically using the Divisions' Electronic Filing System (EFS) To view a copy of the letter, refer to Exhibit 3.

8. Respondent was informed that it is his responsibility to read, understand and follow the requirements of Florida's election laws; therefore, he was directed to print the following relevant documents: Chapter 106, *Florida Statues*; the 2010 Political Committee Handbook; the 2011 Calendar of Reporting Dates; and Rule 1S-2.017, *Florida Administrative Code*. (Note that this information appears in bold font in the final paragraph.) To view a copy of the letter, refer to Exhibit 3. To review the 2011 Calendar of Reporting Dates, refer to Exhibit 4.

9 On January 12, 2012, the Division mailed Respondent notification that his 2011 Q4 Report had not been filed On January 26, 2012, the Division mailed a second failure-to-file notice to Respondent Both letters were mailed to Respondent's address listed on his Appointment of Campaign Treasurer and Designation of Campaign Depository form (DS-DE 6) and not returned to the Division. To review the notice dated January 12, 2012, refer to Exhibit 2, page 3 To review the second notice, refer to Exhibit 2, page 4

10 Based upon the History Notes—the Division's electronic communications log on February 10, 2012, Division staff, Theresa Holdeen, attempted contact with Respondent by telephone; however, the telephone number on file with the Division appeared to no longer be in service Ms Holdeen phoned the registered agent's office and left a message with his staff regarding the committee's 2011 Q4 Report To review the Divisions' History Notes, refer to Exhibit 2, page 2

11 On February 20, 2012, the Division mailed a final notice with delivery confirmation to Kenneth Foote, the committee's Registered Agent To review the final notice, refer to Exhibit 2, page 5 To review the USPS track and confirm history, refer to Exhibit 2, page 6

12. Upon further investigation, it was determined that Respondent filed his 2011 Q4 Report 73 days late on March 23, 2011—one day after Complainant swore out the complaint. His 2011 Q4 Report listed one contribution totaling \$500 and no expenditures. Respondent was fined \$125.00 by the filing officer for the *untimely* filing of his 2011 Q4 Report covering the reporting period of October 1, 2011 through December 31, 2011 To view Respondent's filing history, refer to Exhibit 5. To review Respondent's 2011 Q4 Report, refer to Exhibit 6. To view a copy of Respondent's campaign finance activity, refer to Exhibit 7.

13 In addition, it appears that Respondent filed *untimely* all additional reports at the time my report was submitted. He filed his 2011 Q2 Report—Waiver of Report—four days late; no fine was assessed by the filing officer. He filed his 2011 Q3 Report—Waiver of Report—two days late; no fine was assessed by the filing officer. And Respondent filed his 2012 Q1 Report two days late; the filing officer assessed a fine totaling \$100 00. (Note that Respondent has not paid or appealed to the Commission any fines imposed by the filing officer by the date of this report.) To view a copy of Respondent's campaign finance activity, refer to Exhibit 7. To review Respondent's 2011 Q4 Report, refer to Exhibit 6.

14. Respondent did not respond to my affidavit-questionnaire regarding the untimely filing of his 2011 Q4 Report. On May 30, 2012, I phoned Respondent and informed him that I was sending by email an affidavit-questionnaire to query Respondent about the untimely filing of his 2011 Q4 Report. I admonished Respondent to phone me if he did not receive my email and

the attached affidavit-questionnaire; Respondent did not contact me by telephone or email to inform me he did not receive my affidavit-questionnaire and my email was not returned as undeliverable.

III. FEC History:

15. Respondent has no history of additional complaints filed against him with the Commission at the time of our receipt of this complaint

Respondent was assessed a fine in the amount of \$125.00 by the filing officer. As of the date of this report the fine has not been paid. In a letter dated July 5, 2012, the Florida Elections Commission sent you a complaint in the above referenced matter. I have reviewed the complaint and find that it contains one or more legally sufficient allegations. Along with all allegations in the complaint, the Commission staff will investigate the following alleged violation:

Section 106.07(2)(b)1.,Florida Statutes: Philip Nichols as Treasurer of Our Fair Share of Florida (55215), failed to amend the 2012 Q1 campaign finance report after receiving notice that it was incomplete, as alleged in the referral from the Division of Elections

You may respond to the allegation above by filing a notarized statement providing any information regarding the facts and circumstances surrounding the allegation. If you choose to file a response to the alleged violation, you should do so within 20 days of the date you receive this letter. Your response will be included as an attachment to the investigator's report.

When we conclude the investigation, you will receive a copy of the Report of Investigation You may file a response to the report within 14 days from the date the report is mailed to you. Based on the results of the investigation, legal staff will make a written recommendation to the Commission on whether there is probable cause to believe you have violated Chapter 104 or 106, Florida Statutes You will receive a copy of the Staff Recommendation and may file a response within 14 days from the date the recommendation is mailed to you. Your timely filed response(s) will be considered by the Commission when determining probable cause

The Commission will then hold a hearing to determine whether there is probable cause to believe you have violated Chapter 104 or 106, Florida Statutes You and the complainant will receive a notice of hearing at least 14 days before the hearing. The notice of hearing will indicate the location, date, and time of your hearing. You will have the opportunity to make a brief oral statement to the Commission, but you will not be permitted to testify or call others to testify, or introduce any documentary or other evidence. The Commission also may allow the complainant to make a brief oral statement.

At any time before a probable cause finding, you may notify us in writing that you want to enter into negotiations directed towards reaching a settlement via consent agreement

The Report of Investigation, Staff Recommendation, and Notice of Hearing will be mailed to the same address as this letter. Therefore, if your address changes, you must notify the investigator assigned to this case of your new address. Otherwise, you may not receive the correspondence from the staff. Failure to receive the documents will not delay the probable cause hearing.

Under section 10625, Florida Statutes, complaints, Commission investigations, investigative reports, and other documents relating to an alleged violation of Chapters 104 and 106, Florida Statutes, are <u>confidential</u> until the Commission finds probable cause or no probable cause. The confidentiality provision does not apply to the person filing the complaint However, it does apply to you, the Respondent, unless you waive confidentiality in writing. The confidentiality provision does not preclude you from seeking legal counsel. However, if you retain counsel, your attorney must file a notice of appearance with the Commission before any member of the Commission staff can discuss this case with him or her.


