A hearing will be held in this case before the Florida Elections Commission on, November 16, 2016 at 8:30 am, or as soon thereafter as the parties can be heard, at the following location: Senate Office Building, 404 South Monroe Street, Room 110-S, Tallahassee, Florida 32399

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

If you are the Respondent, you may attend the hearing, and you or your attorney will have 5 minutes to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have 5 *minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

SUMMARY: Jerry Lawrence Bullard is a candidate for State Representative, District 10 in the 2016 elections. Athena Smith is his treasurer.

Jerry Lawrence Bullard is appealing the fine claiming that his treasurer, Athena Smith, had a series of unfortunate events that caused her to not be able to access her home and office computer. According to Mr. Bullard, all campaign financial information necessary for filing reports were held in her office and maintained on her personal computer. Mr. Bullard notes that her home had major framing issues which caused Mrs. Smith and her family to vacate their home for over three weeks. By the time she able to access her computer the report was late.

- The 2016 P1Original Report covers the period from 06/01/16-06/24/16; it was due on 07/01/16.
- The 2016 P1 Queued Transaction Report shows that it was filed on 07/08/16.
- Jerry Lawrence Bullard reported receiving 23 contributions, while making 21 expenditures.
- The History Notes from the Division do not show entries that pertain to the 2016 P1 Report.
- Mr. Bullard has included a letter and bill from the contractor who provided service on the treasurers' home.

We received a letter from the Division of Elections regarding automatic fines for late filing of the report period ending June 24, 2016. Copy enclosed.

We are respectfully requesting abatement of the penalties under Florida Administrative Code Section 2B-1.005. I would like the opportunity to plead this case in front of the committee.

Mrs. Athena Smith, the campaign treasurer had a series of unfortunate events that caused her to not be able to access her home office and computer. All campaign financial information necessary for filing timely reports were held in her office and maintained on her personal computer.

A project that began on Mrs. Smith's home as a cosmetic improvement ended up being a major repair. The home had interior framing issues that had to be addressed and forced Mrs. Smith and her family to vacate their home for over 3 weeks. Extreme heat kept the contractors from working full days and by the time she was able to access her office and computer, the report was late.

Mrs. Smith filed the reports as soon as she was able to get back into her home office where all the financial information is maintained.

We have attached a copy of the estimate from the contractor and a letter from him stating that Mrs. Smith and her family were indeed not able to get into their home while some of these major repairs were being made. The work began on June  $22^{nd}$  and was completed on July  $22^{nd}$ .
