**SUMMARY:** Miami Firefighters PAC II is a political committee (PC) registered with the State of Florida. The PC's chair is Alexander Cardenas and its treasurer is Raul Cernuda.

The PC is appealing the fine claiming the late report was an honest mistake made by the new treasurer. According to the treasurer, Raul Cernuda, he was unaware that PAC reports during the primary election were due more frequently than the previous monthly reports. He also notes that he is an active-duty Fire Captain and serves as treasurer for the PAC on a part-time basis. Mr. Cernuda states that he has printed the 2022 Calendar of Reporting dates to ensure this never happens again. He respectfully requests leniency regarding the late filing and assessed fine.

- The 2022 P1A Original Report covers the period from 06/18/22-06/24/22; it was due on 07/01/22.
- The 2022 P1A Queued Transaction Report shows that it was created and filed on 07/11/22.
- Miami Firefighters PAC II reported receiving 572 contributions, while making zero expenditures.
- The Division of Elections does not have any notes that pertain to Miami Firefighters PAC II's 2022 P1A report.

This letter is in regards to a letter I just received about PAC 37384. As the treasurer for this PAC, I failed to submit in a timely manner the campaign treasurer's report due on July 1, 2022. I incorrectly filed this report on July 11, 2022. As a result of this late filing, we've been assessed a late fine of \$697.00.

Please note that this late filing is a result of the fact that I am new in the position of treasurer for the Miami Firefighters PAC II. The filing process is new to me and I was unaware of the fact that PAC reports during the primary election season were due with a high level of regularity. I was under the impression that these reports were due on a monthly basis similar to the previous PAC reports.

As an active-duty Fire Captain, my primary employment is not that of our PAC's treasurer. These duties are conducted on a part time basis as a member of the Miami Association of Firefighters. In this capacity, I am unaffiliated to my regular, fulltime fire department responsibilities. As I'm sure you may understand, the position of treasurer is much different than that of a Fire Captain. I've come to know that the learning curve in the position of treasurer is steep and dynamic in a manner I was not expecting.

I am respectfully requesting leniency and flexibility with this late filing and assessed late fine. Please forgive this mistake as it was unintentional and based on an honest mistake on my part. In an effort to ensure this never happens again, I've printed the 2022 Calendar of Reporting Dates and it currently sits in my direct line of sight at my desk. Again, I humbly request leniency in regards to my honest mistake.



**Your first campaign treasurer's report will be due April 10, 2003.** Any political committee failing to file a report on the designated due date shall be subject to a fine of \$50 per day for the first 3 days late and, thereafter, \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding each primary and general election, the fine shall be \$500 per day for each late day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. A report which is postmarked by midnight of the due date is considered timely filed.




