NOTICE OF HEARING (AUTOMATIC FINE)

A hearing will be held in this case before the Florida Elections Commission on, May 17, 2017 at 8:30 am, or as soon thereafter as the parties can be heard, at the following location: Augustus B. Turnbull Conference Center, 555 West Pensacola Street, Room 214, Tallahassee, Florida 32301

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

If you are the Respondent, you may attend the hearing, and you or your attorney will have 5 minutes to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have 5 *minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Executive Director Florida Elections Commission May 1, 2017 Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, he must provide the Commission with written proof of his financial resources at the hearing. A financial affidavit form is available from the Commission Clerk.



Dear Mr. Nichols,

The Campaign Treasurer's Report Summary 2016-G3, covering the period from September 17th, 2016, to September 30th, 2016, was due on Friday, October 7th, 2016. The report was received in the City Clerk's Office on Monday, October 10th, 2016 – one day late.

On October 5, 2016, the City declared a state of emergency in advance of the arrival of Hurricane Matthew. An evacuation was ordered for Duval County's beaches and anyone who lived in evacuation zones A, B, and C on October 6. The City of Jacksonville Beach's City Hall was closed on Friday, October 7th, 2016.

On Wednesday, October 5th, 2016, I reached out to the Office of the Supervisors of Election (SOE) to determine what effect City Hall being closed would have on the candidates' Campaign Treasurer's Reports not being able to be submitted by the required deadline of Friday, October 7th, 2016.

The response from Jean Atkins, Director of Voter Administration, SOE was there were no provisions allowing reports to be submitted after their due date "for circumstances beyond our control" and recommended that the candidates be encouraged to file their reports before City Hall's closing on Friday, October 7, 2016.

An email, along with the Office of Supervisor of Elections response, was sent to all candidates on Wednesday, October 5, 2016, (excluding P. Vogelsang and K. Loftus who had already turned in their reports).

On Monday, October 10th, 2016, two candidates submitted either their Campaign Treasurer's Report Summary or Waiver of Report [late] to the



City Clerk's Office. I contacted Ms. Atkins, to further discuss the Penalty Late Fee for submitting the reports late. Ms. Adkins suggested requesting an opinion from the Florida Elections Commission (FEC) to determine if there was a stipulation to waive late fees under such circumstances. Ms. Atkins contacted Florida Elections Commission and received an opinion from Kristin R. Bronson, Chief, Division of Elections. Ms. Bronson opinioned there were no provisions [to waive late fees], and the fees are mandatory. The process is for the candidate to appeal the Penalty Late Fee to the FEC.

Your report was submitted upon the opening of City Hall on Monday, October 10th, 2016. As the filing officer, I am required to assess a one-day late fee of \$500 as described in Florida State Statute 106.07. Please submit a check, payable to the City of Jacksonville Beach, for the amount of \$500 within 20 days after receipt of this notice of payment due, unless an appeal is made to the Florida Elections Commission. If you choose to appeal, you are required to notify the filing officer in writing of your intent to bring the matter before the commission. Please refer to Florida State Statute 106.07 for further detailed instructions.


