FINAL ORDER

THIS CAUSE came on to be heard by the Florida Elections Commission at its regularly scheduled meeting held on February 8 & 9, 2011.

FINDINGS OF FACT

- 1. The Commission is charged with enforcing Chapter 106, Florida Statutes, the campaign financing law.
- 2. The Respondent's campaign treasurer's report was not filed with the filing officer on January 11, 2010, the designated due date.
- 3. The treasurer or deputy treasurer is responsible for filing campaign reports. The filing officer fined the Respondent \$650.00 for the late filing of the report. The Respondent timely appealed claiming that the Political Committee's administrator was placed on maternity leave earlier than expected.

CONCLUSIONS OF LAW

- 4. The Commission has jurisdiction over the parties to and subject matter of this case, pursuant to Section 106.04, 106.07, or 106.29, Florida Statutes.
- 5. The treasurer or deputy treasurer is responsible for filing campaign reports. The Respondent's claim that the Political Committee's administrator was placed on maternity leave earlier than expected does not justify the Respondent's failure to timely file the report.

ORDER

Based on the foregoing facts and conclusions of law, the Commission finds that the

Respondent failed to file the report on the designated due date. Therefore, it is

ORDERED that the assessed fine of \$650.00 is affirmed. The fine shall be paid to the Division of Elections within 30 days of the date this Final Order is received by the Respondent.

NOTICE OF RIGHT TO APPEAL

This order is final agency action. Any party who is adversely affected by this order has the right to seek judicial review pursuant to Section 120.68, Florida Statutes, by filing a notice of administrative appeal pursuant to Rule 9.110, Florida Rules of Appellate Procedure, with the Clerk of the Florida Elections Commission at 107 West Gaines Street, Suite 224, Collins Building, Tallahassee, Florida 32399-1050, and by filing a copy of the notice of appeal with the appropriate district court of appeal. The party must attach to the notice of appeal a copy of this order and include with the notice of appeal filed with the district court of appeal the applicable filing fees. The notice of administrative appeal must be filed within 30 days of the date of this order is filed with the Commission. The date this order was filed appears in the upper right-hand corner of the first page of the order.
