**ORDER OF PROBABLE CAUSE**

**THIS MATTER** was heard by the Florida Elections Commission (“Commission”) at its regularly scheduled meeting on February 8, 2022, in Tallahassee, Florida.

On October 12, 2021, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff’s Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff’s Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violation:

**Count 1:**

On or around June 19, 2020, Elijah Manley violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign’s 2020 P1 Report.

The Commission finds that there is **no probable cause** to charge Respondent with violating Section 106.07(7), Florida Statutes.

#### **NOTICE OF RIGHT TO A HEARING**

As the Respondent, you may elect to resolve this case in several ways. First, you may elect to resolve this case by consent order where you and Commission staff agree to resolve the violation(s) and agree to the amount of the fine. The consent order is then presented to the Commission for its approval. To discuss a consent order, contact the FEC attorney identified in the Order of Probable Cause.

Second, you may request an informal hearing held before the Commission, if you do not dispute any material fact in the Staff Recommendation. You have thirty (30) days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to make written or oral arguments to the Commission concerning the legal issues related to the violation(s) and the potential fine. At the request of Respondent, the Commission will consider and determine willfulness at an informal hearing. Otherwise, live witness testimony is unnecessary.

Third, you may request a formal hearing held before an administrative law judge in the Division of Administrative Hearings ("DOAH"), if you dispute any material fact in the Staff Recommendation. You have thirty (30) days from the date the Order of Probable Cause is filed with the Commission to request such a hearing. The date this order was filed appears in the upper right-hand corner of the first page of the order. At the hearing, you will have the right to present evidence relevant to the violation(s) listed in this order, to cross-examine opposing witnesses, to impeach any witness, and to rebut the evidence presented against you.

If you do not elect to resolve the case by consent order or request a formal hearing at the DOAH or an informal hearing before the Commission within thirty (30) days of the date this Order of Probable Cause is filed with the Commission, the case will be sent to the Commission for a formal or informal hearing, depending on whether the facts are in dispute. The date this order was filed appears in the upper right-hand corner of the first page of the order.

STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is **probable cause** to charge Respondent with violating **Section 106.19(1)(c), Florida Statutes**, and **no probable cause** to charge Respondent with violating **Section 106.07(7), Florida Statutes**. Based upon a thorough review of the Report of Investigation submitted on August 25, 2021, the following facts and law support this staff recommendation:

1. On September 16, 2020, the Florida Elections Commission (“Commission”) received a referral from the Department of State, Division of Elections (“Division”), alleging that Elijah Manley (“Respondent”) violated Chapter 106, Florida Statutes.

2. Respondent was a 2020 candidate for State Representative, District 94. Respondent’s Statement of Candidate form (“DS-DE 84”) was filed on December 13, 2019. (ROI Exhibit 2, page 1)<sup>1</sup>

3. By letter dated January 11, 2021, the Executive Director notified Respondent that Commission staff would investigate the following statutory provisions:

**Section 106.07(7), Florida Statutes:** As alleged in the complaint, Respondent, a 2020 candidate for State Representative, District 94, may have failed to notify the filing officer on the prescribed reporting date that no report would be filed on that date because he had not received funds, made contributions, or expended reportable funds during the 2020 P1 reporting period.

**Section 106.19(1)(c), Florida Statutes:** As alleged in the complaint, Respondent, a 2020 candidate for State Representative, District 94, may have falsely reported or deliberately failed to include information required by Chapter 106, Florida Statutes, during the 2020 P1 reporting period.

4. By letter dated December 16, 2019, Kristi Reid Willis, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that the Division had received his Appointment of Campaign Treasurer and Designation of Campaign Depository for Candidates form and that his name was placed on the 2020 active candidate list. (ROI Exhibit 3, page 1)

5. The acknowledgment letter advised Respondent that all candidates filing reports with the Division are required to use the electronic filing system (“EFS”), and provided Respondent with a user identification number and initial password to grant access to the EFS. (ROI Exhibit 3, page 1) The letter further advised Respondent that all of the Division’s publications and reporting forms were available on its website and directed Respondent to print out the *Calendar of Reporting Dates* as well as other relevant documents. (ROI Exhibit 3, page 2)

6. Respondent’s 2020 P1 Report was due on June 19, 2020; however, Respondent failed to timely file the report or notify the filing officer that no report would be filed. *See Compl.* By letters dated June 22, 2020, July 14, 2020, and August 20, 2020, the Division notified Respondent that his 2020 P1 Report had not been received. The letters also notified Respondent that he was still required to notify the Division if he had no reportable financial activity. (ROI Exhibits 4 & 5) The final notification was confirmed delivered on August 24, 2020. (ROI Exhibit 5, page 2)

7. A subpoena was issued to Respondent’s designated campaign depository to ascertain whether any financial activity occurred during the relevant reporting period, i.e., June 1, 2020 – June 12, 2020. (ROI Exhibit 5, page 1) Respondent’s bank records show 10 contributions totaling \$4,583.54, 78 expenditures totaling \$2,369.24, and one bank fee totaling \$1.05 during the relevant reporting period. (ROI Exhibit 7)

8. Respondent stated that he forgot to file his report. Respondent was uncertain as to whether he possessed or read Chapter 106, Florida Statutes; however, Respondent stated that he possessed and read the *Candidate and Campaign Treasurer Handbook*. Respondent was not a first-time candidate. (ROI Exhibit 8, page 2)

9. On January 22, 2021, Respondent’s 2020 P1 Report was filed. The report was 217 days late. Respondent reported 132 contributions totaling \$4,183.79 and 74 expenditures totaling \$2,161.26. The Division assessed an automatic fine of \$1,045.95 for the late filing of the report. (ROI Exhibit 6, page 1)

10. As it appears that Respondent had financial activity during the relevant reporting period, Respondent failed to include information in his 2020 P1 Report in violation of Section 106.19(1)(c), Florida Statutes. Thus, Respondent was not required to notify the filing officer that he would not be filing his report because Respondent had reportable financial activity.

11. “Probable Cause” is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).

12. The facts set forth above show that Respondent was a 2020 candidate for State Representative, District 94. Respondent failed to timely file his 2020 P1 Report or notify the filing

officer that no report would be filed. As it appears that Respondent had financial activity during the relevant reporting period, Respondent failed to include information in his 2020 P1 Report in violation of Section 106.19(1)(c), Florida Statutes. Thus, Respondent was not required to notify the filing officer that he would not be filing his report because Respondent had reportable financial activity.

Based upon these facts and circumstances, I recommend that the Commission find **no probable cause** to charge Respondent with violating **Section 106.07(7), Florida Statutes**, and find **probable cause** to charge Respondent with violating the following:

**Count 1:**


On or around June 19, 2020, Elijah Manley violated Section 106.19(1)(c), Florida Statutes, when he deliberately failed to include information required by Chapter 106, Florida Statutes, on the campaign's 2020 P1 Report.

**Staff further recommends** that, upon a finding of probable cause, the Commission dismiss the referral pursuant to Section 106.25(4)(j), Florida Statutes, as the public interest would not be served by proceeding further. Respondent failed to include information in his 2020 P1 Report in violation of Section 106.19(1)(c), Florida Statutes. However, the report was ultimately filed, and Respondent was assessed an automatic fine for the late filing of the report. Therefore, Commission staff recommends that, under these specific facts and circumstances, the Commission forgo pursuing this matter further.

1. Respondent was a 2020 candidate for State Representative, District 94; he was defeated in the primary election held on August 18, 2020. Respondent was not a first-time candidate.
2. An Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 9) was filed on December 13, 2019. Respondent was appointed as campaign treasurer. To review the DS-DE 9, refer to Exhibit 1.

The Division sent correspondence to Respondent to the address provided on the DS-DE 9 notifying Respondent that the following campaign report, or the required notification that no reportable activity occurred, had not been filed: 2020 P1. The letters included reference to the filing date for the report. To review the failure to file correspondence, refer to Exhibit 4.
7. On August 20, 2020, the Division sent Respondent a letter marked "Final Notice" with delivery confirmation to the address provided on the DS-DE 9 notifying Respondent that the following campaign report, or the required notification that no reportable activity occurred, had not been filed: 2020 P1. 



On September 16, 2020, the Florida Elections Commission received a complaint alleging that you violated Florida's election laws. I have reviewed the complaint and find that it contains one or more **legally sufficient allegations**. The Commission staff will investigate the following alleged violations:

**Section 106.07(7), Florida Statutes:** As alleged in the complaint, Respondent, a 2020 candidate for State Representative, District 94, may have failed to notify the filing officer on the prescribed reporting date that no report would be filed on that date because he had not received funds, made contributions, or expended reportable funds during the 2020 P1 reporting period.

**Section 106.19(1)(c), Florida Statutes:** As alleged in the complaint, Respondent, a 2020 candidate for State Representative, District 94, may have falsely reported or deliberately failed to include information in his 2020 P1 report, as required by Chapter 106.

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. Based on the results of the investigation, a staff attorney will prepare and present a written Staff Recommendation (SR) to the Commission as to whether there is probable cause to charge you, the Respondent, with violating Chapters 104 or 106, Florida Statutes. You will have an opportunity to respond to both the ROI and the SR. The Commission will then hold one or more hearings to determine whether the alleged violations occurred and, if so, the amount of the fine to be imposed upon you. Notice will be mailed to you and the Complainant at least 14 days before any hearing at which your case is to be considered.

Pursuant to Section 106.25(4)(i)3., Florida Statutes, the Commission may enter into a consent agreement with a Respondent to settle a complaint prior to a finding of probable cause. If you are interested in entering negotiations directed towards reaching a consent agreement to resolve this matter, please contact the Commission and request to speak with the attorney assigned to this case.
