NOTICE OF HEARING (AUTOMATIC FINES (AF))

A hearing will be held in this case before the Florida Elections Commission on, **August 19, 2025 at 9:00 a.m., or as soon thereafter as the parties can be heard**, at the following location: **Virtual Meeting via Webinar link: <https://register.gotowebinar.com/register/3863768971242962781> and Webinar ID 748-293-987.**

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

If you are the Respondent, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have *5 minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

Please refer to the information below for further instructions related to your particular hearing:

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

STAFF MEMORANDUM

This matter is scheduled as an appeal of an automatic fine imposed by the Division of Elections (“Division” or “Filing Officer”) against Golden Triangle Democratic Club Political Committee (“Appellant”) following the late filing of the 2024 Q2 Report.

Appellant is a political committee currently registered with the Division. Appellant’s 2024 Q2 Report was due on June 10, 2024. Appellant submitted a waiver of the 2024 Q2 Report pursuant to Section 106.07(7), Fla. Stat., on the due date. Two (2) months later, on August 21, 2024, Appellant filed the 2024 Q2 Report under Section 106.07(1), Fla. Stat. The report reflected one (1) expenditure to a candidate totaling \$1,000.00. Pursuant to Section 106.07(8), Fla. Stat., the Division assessed a fine of \$250.00 based on twenty-five (25) percent of the committee’s expenditures pursuant to Section 106.07(8)(b), Fla. Stat.


The Commission’s objective for automatic fine appeals is to determine whether the aggrieved party’s report was timely filed and, if not, whether the party demonstrated unusual circumstances—or other circumstances beyond the party’s control—that directly caused the report to be late. Florida Administrative Code Rule 2B-1.005(3); § 106.07(8)(c), Fla. Stat.; *Candidate and Campaign Treasurer Handbook* (2022), page 74. Unusual circumstances are rare or sudden events that directly prevented the party from timely filing. Fla. Admin. Code R. 2B-1.0055(1). Examples of unusual circumstances include natural disasters and emergencies; death, illness, disability, or necessary surgery of the candidate, treasurer, or immediate family thereof; and unanticipated technological failures. Most of the subsections enumerate corroborative evidence that the aggrieved party needs to provide for the claim, such as a newspaper article, death certificate, or a physician’s certification on professional letterhead. Fla. Admin. Code R. 2B-1.0055(1)(a)-(d). The Division’s Advisory Opinion, DE 91-02 (1991), specifies that, “before the

FEC may label these occurrences as ‘unusual circumstances,’ the FEC must determine that the persons involved took all steps necessary to ensure that a timely report was filed.”

The submission at issue before the Commission is the 2024 Q2 Report filed on August 21, 2024, which discloses one (1) expenditure, rather than the notice of no report filed on June 10, 2024. Campaign reports contain all contributions received and all expenditures made during a reporting period. § 106.07(1) and (4), Fla. Stat. A committee with no activity may waive the required report for a specified period under Section 106.07(7), Fla. Stat., but must notify the filing officer in writing that “no report is being filed.” *Handbook*, page 54. Committees registered with the Division do so by selecting the “waiver” option in the Division’s Electronic Filing System (“EFS”). § 106.0705(2)(a); *Candidate EFS User’s Guide*, page 13; *Handbook*, page 54. A waiver filed pursuant to Section 106.07(7), Fla. Stat., is not a report but a notice stating that no report has been filed due to no reportable activity; however, the Commission may choose to consider a party’s reasons for filing a waiver under mitigating and aggravating circumstances as outlined in Section 106.265(3), Fla. Stat.

Rule 2B-1.005(2), Fla. Admin. Code, specifies that the appealing party has twenty (20) days from acceptance of the appeal to submit any documents supporting the appeal. Appellant timely submitted an initial statement. While the Commission may consider subsequent supplemental documents no later than five (5) business days before the hearing, i.e., August 12, 2025, the record currently reflects that the 2024 Q2 Report was not timely filed.

SUMMARY: Golden Triangle Democratic Club Political Committee is a political committee (PC) registered with the State of Florida. The PC's chair is Nancy Hurlbert, and its treasurer is Jason Emilio Rodriguez.

The PC is appealing the fine claiming that they submitted a waiver on the due date and updated the submission on August 21, 2024. According to Ms. Hurlbert, the board made a \$1,000 contribution to a candidate to assist with outreach for the November general election. As such, the treasurer believed it needed to be reported during the 2024 G1 reporting period. The treasurer, upon realizing the error, subsequently added the expenditure to the 2024 Q2 Report.

- The 2024 G1 Original Report, which was cited by the committee, covers the period from 08/17/24-08/23/24.
- The 2024 Q2 Original Report covers the period from 04/01/24-05/31/24; it was due on 06/10/24.
- The 2024 Q2 Queued Transaction Report shows that it was created and filed on 06/10/24.¹
- Golden Triangle Democratic Club Political Committee reported receiving zero contributions while making 1 expenditure on 05/20/24.
- FEC staff was advised, "The committee filed a notice of no activity (waiver) on 06/10/24. A waiver is not a report. On 08/21/24, the committee filed a report showing \$1,000.00 of activity. The fine is based on 25% of the activity."
- The Division of Elections provided one note that pertains to Golden Triangle Democratic Club Political Committee's 2024 Q2 Report. On 11/19/24, a Division staff member noted, "[Mr. Rodriguez] stated that he filed the report on time and asked why they received a fine. . . . I explained that if you add activity to a waiver after the report due date, a fine will be imposed based upon the new filing date in accordance with Section 106.07(8)(b), Florida Statutes (see page 54 in PC Handbook). I then told Mr. Rodriguez that they have the option to appeal the fine[.]"

Dear Members of the Florida Election Commission:

The Division of Elections Bureau of Election Records has assessed a late fine of \$250.00 to the Golden Triangle Democratic Club Political Committee (GTDCPC) relating to an amendment to a Waiver Report originally filed on June 10, 2024, for the Q2 reporting period, and amended on August 21, 2024 to include an expenditure.

On May 20, 2024, the GTDCPC Board made a \$1,000 financial contribution to the campaign of Florida House of Representatives District 26 candidate Jacqueline Arndt. The contribution was for expenses relating to voter outreach for the November *general election* since she did not have a primary.

At the time that our treasurer filed the Q2 report on June 10th, Mr. Rodriguez honestly thought that the \$1,000 contribution needed to be reported as part of the *general election* reporting cycle (G1). Therefore, he did not include the contribution in the Q2 report. However, once reporting for the general election began in August, the G1 report only covered dates from August 17th – 23rd. Realizing the limited time frame covered in the G1 report, Mr. Rodriguez *immediately* amended the Q2 report to include the \$1,000 contribution dated May 20, 2024. The amended report was filed on August 21, 2024. There were no indications at the time of filing the amendment, or thereafter, that such amendment was not allowed to a Waiver Report. Mr. Rodriguez did not receive notifications stating that such filing was in error.

I am writing to appeal the \$250 fine. This is the first general election cycle for which Mr. Rodriguez serves as treasurer of our club's political committee. He genuinely thought that since the contribution was toward a *general election* campaign activity the reporting needed to take place during the *general election* reporting cycle. And, since the amended waiver report appeared to be accepted, there was no reason to believe this would be an issue.

I effusively ask for your kind consideration in removing the \$250 fine assessed to our club by the Division of Elections and look forward to your favorable response.

Pin Numbers

Pin numbers are confidential secure credentials that allow you to submit reports and update information. The enclosed sealed envelope provides a confidential pin number for the chairperson. By copy of this letter, a confidential PIN number to access the Division of Election's electronic filing system (EFS) was sent to the treasurer.

Each political committee chairperson is required to provide the Division of Elections with confidential personal information that may be used to allow access in the event that the password is forgotten or lost. When you enter the campaign account screen, there will be a drop down box where you pick a question (such as *What is your mother's maiden name?*) and supply an answer. All passwords and answers to questions are stored as encrypted data and cannot be viewed by Division staff and given out over the phone. Please notify the Division if your credentials have been compromised.

Timely Filing

All reports must be completed and filed through the EFS not later than midnight, Eastern Standard Time, of the due date. Reports not filed by midnight, Eastern Standard Time, of the due date are late filed and subject to the penalties in Section 106.07(8), Florida Statutes. In the event that the EFS is inoperable on the due date, the report will be accepted as timely filed if filed no later than midnight, Eastern Standard Time, of the first business day the EFS becomes operable. No fine will be levied during the period the EFS was inoperable.

Any political committee failing to file a report on the designated due date is subject to a fine of \$50 per day for the first 3 days and, thereafter, \$500 per day for each day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report. However, for the reports immediately preceding each primary and general election, the fine shall be \$500 per day, not to exceed 25% of the total receipts or expenditures, whichever is greater, for the period covered by the late report.

Electronic Receipts

The person submitting the report on the EFS will be issued an electronic receipt indicating and verifying the report was filed. Each campaign treasurer's report filed by means of the EFS is considered to be under oath by the chairperson and campaign treasurer and such persons are subject to the provisions of Section 106.07(5), Florida Statutes.


