ORDER OF PROBABLE CAUSE

THIS MATTER was heard by the Florida Elections Commission ("Commission") at its regularly scheduled meeting held on August 20, 2025, at 1:00 p.m. via Zoom teleconferencing.

On January 10, 2025, Staff recommended to the Commission that there was probable cause to believe that the Florida Election Code was violated. The facts articulated in Staff's Recommendation are adopted by reference and incorporated herein. Based on the Complaint, Report of Investigation, Staff's Recommendation, and oral statements (if any) made at the probable cause hearing, the Commission finds that there is **probable cause** to charge Respondent with the following violations:

Count 1:

On February 19, 2024, Leslie Gibbs violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2023 M2 Report within seven days after receiving notice from the Division that the report required amendment.

Count 2:

On February 19, 2024, Leslie Gibbs violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2023 M3 Report within seven days after receiving notice from the Division that the report required amendment.

Count 3:

On February 19, 2024, Leslie Gibbs violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2023 M6 Report within seven days after receiving notice from the Division that the report required amendment.

STAFF RECOMMENDATION FOLLOWING INVESTIGATION

Pursuant to Section 106.25(4)(c), Florida Statutes, undersigned staff counsel files this written recommendation for disposition of the referral in this case recommending that there is probable cause to charge Respondent with violating Section 106.07(2)(b)1., Florida Statutes. Based upon a thorough review of the Report of Investigation submitted on November 4, 2024, the following facts and law support this staff recommendation:

- On March 12, 2024, the Florida Elections Commission ("Commission") received a referral from the Florida Division of Elections ("Complainant" or "Division") alleging that Leslie Gibbs ("Respondent") violated Chapter 106, Florida Statutes.
- Respondent was the treasurer for Katherine Waldron, a 2024 candidate for State 2. Representative, District 93. (ROI Exhibit 1, page 1)¹
- The Appointment of Campaign Treasurer and Designation of Campaign Depository 3. form ("DS-DE 9") was filed on February 15, 2023, appointing Respondent to serve as the campaign's treasurer. (ROI Exhibit 1, page 1)
- By letter dated July 17, 2024, the Executive Director notified Respondent that Commission staff would investigate the following statutory provision:

Section 106.07(2)(b)1., Florida Statutes: Respondent, treasurer for Katherine M. Waldron, a 2024 candidate for State Representative, District 93, failed to timely make necessary amendments to the following campaign treasurer's reports, as alleged in the complaint:

- 2023 M2
- 2023 M3
- 2023 M6
- By letter dated February 17, 2023, Donna S. Brown, Chief, Bureau of Election Records, sent Respondent a letter acknowledging that the Division had received Respondent's DS-DE 9. (ROI Exhibit 2, page 1)
- The acknowledgment letter provided Respondent with a user identification number and initial password to grant access to the electronic filing system ("EFS"). The letter further

advised Respondent that all the Division's publications and reporting forms were available on its website and directed Respondent to print out Chapter 106, Florida Statutes, and the *Calendar of Reporting Dates*, as well as other relevant documents. (ROI Exhibit 2, page 1)

Alleged Violation: Section 106.07(2)(b)1., Florida Statutes

- 7. The campaign's 2023 M2 Report was filed on March 10, 2023. (ROI Exhibit 5, page 6) The report was incomplete when filed as it reflected two expenditures to the candidate for expenses made by the candidate on behalf of the campaign. (ROI Exhibit 3, page 2; ROI Exhibit 4, page 2; ROI Exhibit 5, page 3)
- 8. The campaign's 2023 M3 Report was filed on April 8, 2023. (ROI Exhibit 5, page 12) The report was incomplete when filed as it reflected one expenditure to the candidate for expenses made by the candidate on behalf of the campaign. (ROI Exhibit 3, page 2; ROI Exhibit 4, page 2; ROI Exhibit 5, page 9)
- 9. The campaign's 2023 M6 Report was filed on July 10, 2023. (ROI Exhibit 5, page 18) The report was incomplete when filed as it reflected two expenditures to the candidate for expenses made by the candidate on behalf of the campaign. (ROI Exhibit 3, page 2; ROI Exhibit 4, page 2; ROI Exhibit 5, page 15)
- 10. The Division sent letters on January 16, 2024, and February 6, 2024, notifying Respondent that the campaign's reports were incomplete and that Respondent was required to amend the reports within seven days of receipt of the notifications. (ROI Exhibit 3, page 1; ROI Exhibit 4, page 1) A Compliance Report showing why each report was incomplete was attached to every notification. (ROI Exhibit 3, page 2; ROI Exhibit 4, page 2) The final notification was confirmed delivered on February 12, 2024. (ROI Exhibit 4, page 3)
- 11. Respondent stated that he did not receive any assistance, advice, or materials from the Division. Respondent stated that he called the Division, but staff could not explain what corrections were needed. Respondent stated that he did not make any corrections. Respondent stated that he was a first-time treasurer. (ROI Exhibit 7, page 1)
- 12. As of January 7, 2025, Respondent has not filed the required amendments to the campaign's reports. (Attachment A, pages 1-4)
- 13. The omitted information triggers issues of transparency, which the Florida Election Code was designed to address. The manner in which the expenditures were reported concealed the true expenditure recipients required under section 106.07(4)(a)6., Florida Statutes. Consequently, the public could not determine the actual venues, events, sponsors, stores, or printing services the candidate used. This omitted information points to potential violations under section 106.07(5), Florida Statutes.
- 14. Additionally, the transactions, without further explanation, appear to be unlawful as the candidate's finances reflect no prior loans to the campaign under sections 106.11(6) and

106.141(2), Florida Statutes. (Attachment B, pages 1-5) The transfer of funds from the campaign account to the candidate raises concerns under section 106.19(1)(c), Florida Statutes.

- 15. Finally, if Respondent knew of but failed to report contributions made by the candidate, to which reimbursement was proper, then there are concerns about potential violations under section 106.19(1)(b), Florida Statutes.
- 16. Commission staff often gives weight to respondents' efforts to mitigate harm caused by their conduct. In this case, Respondent had approximately one year from the time the complaint was filed to seek guidance and correct the reports; however, no corrections have been made. Respondent asserted that the Division offered no help or resources, but this claim appears to be without merit. It seems that Respondent received the acknowledgment letter directing him to review the necessary elections materials on the Division's website. Further, the notice letters expressly stated that the identified expenditures looked like reimbursements and provided the specific page number in the *Candidate EFS User's Guide* to guide Respondent in making the appropriate changes. Based on how detailed and specific the Division's notices were, it is highly unlikely that the Division did not or could not discern what the relevant issues were or how to assist Respondent in remedying the errors.
- 17. Respondent failed to amend the campaign's 2023 M2, 2023 M3, 2023 M6 Reports within seven days of receiving notification from the Division that the reports were in error and required correction.
- 18. "Probable Cause" is defined as reasonable grounds of suspicion supported by circumstances sufficiently strong to warrant a cautious person in the belief that the person has committed the offense charged. *Schmitt v. State*, 590 So. 2d 404, 409 (Fla. 1991). Probable cause exists where the facts and circumstances, of which an [investigator] has reasonably trustworthy information, are sufficient in themselves for a reasonable man to reach the conclusion that an offense has been committed. *Department of Highway Safety and Motor Vehicles v. Favino*, 667 So. 2d 305, 309 (Fla. 1st DCA 1995).
- 19. The facts set forth above show that Respondent was the treasurer for Katherine Waldron, a 2024 candidate for State Representative, District 93. Respondent failed to timely file the required amendments to the campaign's 2023 M2, 2023 M3, 2023 M6 Reports within seven days of receiving notification from the Division that the reports were incomplete and required amendment.

Based upon these facts and circumstances, I recommend that the Commission find probable cause to charge Respondent with violating the following:

Count 1:

On February 19, 2024, Leslie Gibbs violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2023 M2 Report within seven days after receiving notice from the Division that the report required amendment.

Count 2:

On February 19, 2024, Leslie Gibbs violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2023 M3 Report within seven days after receiving notice from the Division that the report required amendment.

Count 3:

On February 19, 2024, Leslie Gibbs violated Section 106.07(2)(b)1., Florida Statutes, when he failed to timely file an addendum to the campaign's 2023 M6 Report within seven days after receiving notice from the Division that the report required amendment.

- 2. An Appointment of Campaign Treasurer and Designation of Campaign Depository (DS-DE 9) was filed on February 15, 2023. Respondent was appointed as campaign treasurer for Katherine Waldron, a 2024 candidate for State Representative, District 93. To review the DS-DE 9, refer to Exhibit 1.
- 3. On February 17, 2023, the Division sent Respondent a letter acknowledging Respondent's appointment as the campaign treasurer for Katherine Waldron's campaign. The letter advised Respondent that all of the Division's publications and reporting forms are available on their website, including Chapter 106, Florida Statutes, the *Candidate and Campaign Treasurer Handbook*, and the *Calendar of Reporting Dates*. The letter further advised that it was Respondent's responsibility to read, understand, and follow the requirements of Florida's election laws. To review the acknowledgement letter, refer to Exhibit 2.

II. Alleged Violation of Section 106.07(2)(b)(1)., Florida Statutes:

- 4. The Division sent correspondence to the address provided on the DS-DE 9 notifying Respondent that one or more campaign treasurer report(s) were incomplete. The correspondence included error report(s) referencing the following report(s): 2023 M2; 2023 M3; and 2023 M6. To review the correspondence and error report(s), refer to Exhibit 3.
- 5. On February 6, 2024, the Division sent a letter marked "Final Notice" with delivery confirmation to the address provided on the DS-DE 9 notifying Respondent that one or more campaign treasurer report(s) were incomplete. The letter included an error report referencing the following report(s): 2023 M2; 2023 M3; and 2023 M6. It was confirmed delivered on February 12, 2024. To review the "Final Notice," error report and delivery confirmation, refer to Exhibit 4.
- 6. As noted above, the "Final Notice" was confirmed delivered on February 12, 2024. The Division filed the referral on March 12, 2024. By filing the referral, the Division affirmed that as of that date, the report(s) at issue had not been amended to correct all errors identified by the Division. To review the report(s) at issue, refer to Exhibit 5.
 - 7. Respondent did not respond to the referral.

8. I called Respondent for the purpose of providing an opportunity to discuss the allegations made in the referral. Respondent stated that he was a first-time treasurer. He stated that he did not receive any election materials, advice, or assistance from the Division. On March 12, 2024, the Florida Elections Commission received a complaint alleging that you violated Florida's election laws. I have reviewed the complaint and find that it contains one or more **legally sufficient allegations**. The Commission staff will investigate the following alleged violation:

Section 106.07(2)(b)1., Florida Statutes: Respondent, treasurer for Katherine M. Waldron, a 2024 candidate for State Representative, District 93, failed to timely make necessary amendments to the to the following campaign treasurer's reports, as alleged in the complaint:

- 2023 M2
- 2023 M3
- 2023 M6

When we conclude the investigation, a copy of the Report of Investigation (ROI) will be mailed to you at the above address. Based on the results of the investigation, a staff attorney will prepare and present a written Staff Recommendation (SR) to the Commission as to whether there is probable cause to charge you, the Respondent, with violating Chapters 104 or 106, Florida Statutes. You will have an opportunity to respond to both the ROI and the SR. The Commission will then hold one or more hearings to determine whether the alleged violation occurred and, if so, the amount of the fine to be imposed upon you. Notice will be mailed to you and the Complainant at least 14 days before any hearing at which your case is to be considered.

Pursuant to Section 106.25(4)(i)3., Florida Statutes, the Commission may enter into a consent agreement with a Respondent to settle a complaint prior to a finding of probable cause. If you are interested in entering negotiations directed towards reaching a consent agreement to resolve this matter, please contact the Commission and request to speak with the attorney assigned to this case.
